The public hearing of M/s. Boudh Distillery Pvt. Ltd. for establishment of 2X60 KLD Grain Based Distillery Plant along with 2X2.5 MW Co-Generation Power Plant at Titirikata Village, P.O: Rambhikata under Harabhanga Tahasil, Dist: Boudh held at Titirikata U.P. School, Titirikata, Dist: Boudh on dt. 11.3.2016, 10.00 A.M. Shri Madhusudan Mishra, IAS, Collector and District Magistrate, Boudh presided over the meeting along with Shri Hemendra Nath Nayak, Regional Officer, State Pollution Control Board, Odisha, Sambalpur. He welcomed the public who were present at the venue for participating in the meeting. The attendance sheet of the members present in the public hearing and the public attended the meeting are annexed as Annexure I and II respectively. About 150 persons had attended the public hearing meeting where as only 20 persons had intended to deliver their views whose list is annexed as Annexure-III and 16 persons took part in the deliberations. The statement of the public participated in the deliberation is annexed as Annexure-IV. The video recording of the entire proceeding of the public hearing was done and the CD is enclosed herewith along with the proceeding of the meeting. The video recording of the entire proceeding of the public hearing will be forwarded to the Ministry of Environment, Forest & Climate Change, Govt. of India, New Delhi as such proceeding of the meeting.

The venue, date and timing of the Public hearing meeting of the said establishment of M/s. Boudh Distillery Pvt. Ltd. was extensively propagated in all affected and nearby villages. The executive summary of the project both in Oriya & English were displayed in public at the meeting venue and also distributed among the persons during the meeting.

At the outset Shri H. N. Nayak, Regional Officer of State Pollution Control Board, Sambalpur welcomed all the public present in the meeting. He briefly described the objective of conducting the public hearing as per the EIA Notification No.S.O. 1533(E) of Dt.14th September 2006 of the Ministry of Environment and Forests (MOEF), Govt. of India and the importance of the actual views of the

villagers regarding the project and detail about the environmental impact of M/s. Boudh Distillery Pvt. Ltd. for establishment of 2X60 KLD Grain Based Distillery Plant along with 2X2.5 MW Co-Generation Power Plant at Titirkata Village,P.O: Rambhikata under Harabhanga Tahasil, Dist: Boudh. He also stated that video recording was done & the views of the public were very important for taking decision for grant of clearance for the said expansion of project of the company. He requested the Collector and District Magistrate, Boudh to preside over the meeting.

The Collector and District Magistrate, Boudh welcomed the public present at the meeting and invited the public to participate in the public hearing giving their views about the establishment of M/s. Boudh Distillery Pvt. Ltd. for establishment of 2X60 KLD Grain Based Distillery Plant along with 2X2.5 MW Co-Generation Power Plant at Titirikata Village, P.O: Rambhikata under Harabhanga Tahasil, Dist: Boudh.

Sri H. N. Nayak, Regional Officer of State Pollution Control Board, Sambalpur called the project proponent to deliver the detail of the project ,its impact & mitigation measures to be taken by the company to protect environment.

Miss Punam Srivastav, Public Relation officer, M/s. Boudh Distillery Pvt. Ltd. started her deliberations with the objective & detail of establishment of 2X60 KLD Grain Based Distillery Plant along with 2X2.5 MW Co-Generation Power Plant at Titirkata Village, P.O: Rambhikata under Harabhanga Tahasil, Dist: Boudh. Then she deliberated following points regarding the establishment of unit.

- The grains such as broken rice, maize, bajra, jowar and other starch containing left over material will be procured from various sources and will be used as raw material for the distillery plant to produce extra neutral alcohol which is used in perfume making, Pharamacetual company, united spirits.
- 2. The impacts on environment due to the establishment of proposed project are air pollution, water pollution & solid waste management.

- 3. The industry will install Electro Static Precipitator for abatement of air pollution from 25 TPH Boiler and provide stack as per the regulation of State govt. The industry will comply with all the rules, regulations, norms and conditions of Ministry of Environment, Forest & Climate Change, Govt. of India.
- 4. The industry will not use ground water and will draw surface water from Mahanadi River. The industry will comply with all the rules, regulations, norms and conditions of State Govt. as well as Ministry of Environment, Forest & Climate Change, Govt. of India regarding abatement of water pollution.
- 5. Solid waste generated from the Decanter of Distillery will be used as cattle feed /fish feed. Boiler ash generated from the co-generation power plant will be given to brick manufactures /cement manufactures.

She also outlines that the industry will give local employment & provide various facilities for improving the quality of life of the people living in this area like construction of roads, drinking water facility, education, free books and scholarships to the students on merit basis etc. Again she stated that the plant will not use the forest of that area but the unit will do plantation in 12 acres of the land, thereby achieving greenery of 33% of the total acquired land. Lastly She requested the public to help & assist for the establishment of the industry.

Sri H. N. Nayak, Regional Officer of State Pollution Control Board, Sambalpur requested the public to give their deliberation one by one regarding the expansion of the project.

Then the public deliberated on various issues of the industry one by one.

After the deliberations were made by the public, Regional Officer, State Pollution Control Board, Odisha, Samalpur again called the Representative of the industry to offer their views on issues raised by the public.

Miss Punam Srivastav, Public Relation officer of the unit placed his views on the issues raised by the Public. The summary of the views and concerns of the public and the commitments made by the Project Proponent are annexed in Oriya language & English language as **Annexure-V** & **VI** respectively.

Finally the meeting was ended with a vote of thanks to the chair and other participants.
