	He welcomed the gathering of the public hearing and also welcomed the proposed project of M/s JSW Cement. He expressed that the proposed project would lead to more development in the area and generation of more employment opportunity for the nearby villagers. He told that villagers are still unemployed today. He expressed that there are so many integrated steel plants have been operating in an around the Kalinga Nagar Industrial area. So he finally expressed that he supports the proposed project subject to (i) there should be the provision for local employment, (ii) provision of drinking water to the nearby village, (iii) provision of electricity to the nearby villages and (iv) Peripheral development.
2	Sri Srinivas Dash, Solei village
	He appreciated about the detailed proposed project expressed by previous speaker. He expressed that after establishment of the proposed project the unit shall adopt adequate pollution control measures in all respect and there should not be any type of pollution in the surrounding area. Expecting better employment opportunity and development activities in the periphery, he made a strong opinion in favour of the proposed project.
3	Smt. Minarani Behera, Sarpanch, Dhuligarh Gram Panchayat
	She expressed that the proposed expansion would lead to development in the area. She demanded that the company should deploy more local people for employment. Without elaborating in detail she supported the proposed project.

He welcomed the gathering of the public hearing and also welcomed the proposed cement industry of M/s JSW Cement Ltd. He expressed that the proposed project would lead to more development in the area and generation of more employment opportunity for the nearby villagers. He told that villagers are still unemployed today. He expressed that there are so many integrated steel plants operating in an around the Kalinga Nagar Industrial area. Each and every industry during establishment time told that they will give local employment opportunity and give attention towards local peripheral development, but after establishment of their industry, they forget the development works and as well as local employment opportunity. Most of the time it is seen the major numbers of employees including officer level are from outside State. He stressed that there are so many large scale industries operating in the Kalinga Nagar Industrial Complex, but CSR activities of all the industries in the surrounding area are not adequate except Tata Steels Ltd. So he finally expressed that he supports the proposed project subject to (i) there should be the provision of local employment opportunity (nearby village) (ii) Health check up facility, (iii) Drinking water facility and (iv) Peripheral development.

10 | Sri Sanjay Kumar Nayak, Jakhapura village

He welcomed the public hearing. He gave more stress to the local employment, adequate pollution control measures and provision of safe drinking water. Without elaborating much detail he expressed his views in support of the proposed expansion project.

11 | Sri Jalandhar Khillar, Kimirgadia Gram Panchayat

He welcomed the gathering of the public hearing. Simultaneously he stressed that there are many other industries which are operating in Kalinga nagar area not given adequate local employment opportunity. He expressed that the company should be positive and demanded that the company should deploy more local people for employment. He also mentioned that due to extreme summer conditions local villagers are facing acute shortage of drinking water. He demanded that the nearby village shall be provided adequate drinking water. Expecting better employment opportunity and further development activities in the periphery, he made a strong opinion in favour of the proposed project.

12 | Sri Deepak Kumar Samal, Jakhapuyra village

He welcomed the proposed project. He demanded that regarding employment issue, priority shall be given to local villagers who gave land for establishment of industry. He demanded that better health care facility, drinking water supply, adequate pollution control measures and peripheral development facility shall be provided by the industry.

14	Sri Bijay Kumar Dhal, Dhuligarh Gram Panchayat
	He welcomed the proposed project. His demands were a) Local employment opportunity, b) Adequate pollution control measures.
15	Sri Jibana Kumar Sahu, Jakhapura village
	He welcomed the gathering of the public hearing of M/s JSW cement Ltd. He expressed that most of the public are aware about the Cement industry which is proposed to be established in the Kalinga Nagar Industrial Complex but they are not aware about the type of cement which will be manufacture. The villagers could not able to know the meaning of Portland Slag Cement, Portland Pozzolana Cement and Ground Granulated Blast Furnace Slag Cement. The public should have knowledge about the requirement of water, type of raw material to be used for this type of industry. He expressed that this proposed cement industry will require lime stone as a raw material but this ore is not available in this area except Sundargarh District. He mentioned that in this industrial complex there is huge generation of fly ash. So the cement industry will be fly ash based not lime stone based. He told that the public hearing should be conducted at the proposed project site. He told that the proponent shall brief to the public about the pollution potential and what types of pollution control measures to be adopted in the cement plant. Finally he concluded that he has no objection if the proposed industry shall fulfill all Government norms.

At the same time people submitted their written statements (16 nos.) before the panel members are enclosed separately.

Observation:

Generation of local employment opportunity, drinking water facility, adequate air pollution control and peripheral developments etc. were the most important issues emerged during the discussion.


