PROCEEDINGS OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL (1) IMPACT ASSESSMENT OF M/S. GRASIM INDUSTRIES LIMITED FOR EXPANSION OF PRODUCTION CAPACITY OF CAUSTIC SODA FROM 72,000 TPA TO 1, 05,000 TPA, ITS 51-PRODUCTS AND VALUE ADDED DERIVATIVES AT JAYSHREE, DISTRICT-GANJAM

VENUE: AT THE OPEN SPACE INFRONT OF BSNL TELEPHONE EXCHANGE NEAR GANJAM TAHASIL OFFICE, GANJAM ON 23.05.2017, AT 11.00 AM.

At the outset, Sri Mitrasen Majhi, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA notification, 2006 and the objectives of the public hearing. He stated that M/s Grasim Industries Limited have proposed to have environmental assessment for expansion of production capacity of caustic soda from 72,000 TPA to 1,05,000 TPA, its bi-products and value added derivatives at Jayshree, District- Ganjam and has applied to obtain environmental clearance from the Ministry of Environment, Forest and Climate Change, Government of India and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manners -

- Advertisements through an Oriya daily "Samaj" dated 22.04.2017 and an English daily "The Times of India" dated 22.04.2017 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report, Executive Summaries (Oriya & English) and soft copy in the office of Collectorate Ganjam, Chatrapur, District Industries Centre (DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment, Govt of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the NAC, Ganjam, Ganjam Block, Ganjam, Kainchapur Gram Panchayat, Agastinuagaon Gram Panchayat, Pallibandha Gram Panchayat, Karapada Gram Panchayat and Humma Gram Panchayat of Ganjam district.
- Further announcements were also made through loud speaker regarding Public Hearing for information of the public in the surrounding villages.

He requested the audience to state their opinions orally or in written, based on the environmental aspects. Then he requested the Additional District Magistrate (Revenue), Ganjam, Sri Bijaya Kumar Dash, O.A.S. (S) to kindly preside and supervise the public hearing.

The Additional District Magistrate (Revenue) Ganjam, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Pollution related aspects. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking environmental clearance from the Govt. of India. Then he asked the representatives of M/s Grasim Industries Limited to give the detail description on the project.

Sri Shashank Shekhar Pareek, Unit Head, M/s Grasim Industries Limited, Jayshree, Ganjam, welcomed the gathering and requested Sri Pramod Kumar Panda, Senior Manager (Liaison). Sri Panda presented the salient features of the project, the present status of the environmental conditions, possible impact on the environment due to execution and operational activities and the remedial measures to be undertaken by the project proponent to reduce the impact while executing the project.

He concluded that a suitable Environmental Management Plan has been formulated and would be continuously upgraded to mitigate the impact on the different components of the environment such as water, air, noise & soil.

The Additional District Magistrate (Revenue) Ganjam, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project; specifically relating to environmental issues. About 500 persons were present in the public hearing meeting, but only 06 persons signed in the attendance sheet, 64 persons registered in the deliberation sheet and 47 persons participated in the oral deliberation. 05nos. of written representations was received in the hearing. The attendance sheets of audience and deliberators along with the written representations are enclosed as Annexure-II, Annexure-II and Annexure-III respectively.

The statements recorded are as follows.

#### 01. Professor, Dr. Nilamadhab Behera, REETC.

He addressed the gathering and briefed about the Membrance Cell Technology and appraised the industry for this Eco Friendly Technology adopted by them. He said that due to expansion of the production capacity and its bi-products and value added derivatives, no trees will be cut, no land acquisition or displacement is required and there will be no affect to the Atmosphere, Biosphere and Biotic elements. Further he said that as the unit is complying the Rules and Regulation of the Environmental Acts, this project should come up. Lastly he welcomed the project.



#### 02. Sri Kameswar Sahu, Barapalli, Ganjam.

He addressed the gathering and welcomed the project and said that the plant should given permission so that they will be benefited and they will get employment. Further he said that the project proponent should take care of the environmental pollution.

#### 03. Sri Kanga Pallai, Puintala, Ganjam.

He welcomed the project and demanded that the local temples should be repaired and employment opportunity should be given to the local people.

#### 04. Sri Prabhat Kumar Mahapatra, Samantara Sahi, Word No. 02, Ganjam.

He addressed the gathering and said that the issues relating to employment and environment should be duly addressed. Further he added that during the tenure of earlier management there was environmental problem but now due to change in technology the problem is controlled. He supported the deliberation of Professor Dr. Behera and requested the gathering to co-operate the expansion project. Further he hoped that the pollution problem should be properly handled and the project proponent and the State Pollution Control Board should be vigilant on it.

# 05. Sri Patitapaban Mahapatra, Ganjam Pouranchal Baristha Nagarika, Parishada, Ganjam

He addressed the gathering and showed his apprehension that the Environmental Impact Assessment Plan is not properly prepared. The 3<sup>rd</sup> party like National Environmental Engineering Research Institute (NEERI) should be engaged for the study. Further he said that as people want this expansion project the company should take all precautionary measure for control of the environmental issues. He submitted one written presentation during the hearing which is enclosed as **Annexure-III**.

#### 06. Sri Ramesh Chandra Dash, Ganjam.

He addressed the gathering and welcomed the expansion project and requested the local people to co-operate the expansion project.

#### 07. Sri Braja Sundar Panda, Raulasahi, Ganjam.

He addressed the gathering and welcomed the expansion project and said that due to the project the ground water level will be get affected. He demanded that the industry should take steps for ground water recharge, employment to the local un employed, training facility to the local people, proper implementation of the CSR activities, compensation to affected people and the pollution control measure should be taken on priority basis. He further added that as everybody wants the industry should grow up and develop, he also hope for the same.

#### 08. Smt. Minati Pradhan, Humma.

She addressed the gathering and requested to accorded permission for the expansion project with a demand that the proponent should take care of the environmental issues and should provide employment to the local people. Lastly she welcomed the project.

#### 09. Sri Kitan Das, Ex- Zillaparishad Member, Ganjam.

He addressed the gathering and welcomed the expansion project. He want to know about the employment position and the non procurement of local salt. Further he requested to the project proponent to provide technical assistant to the salt cultivators to improve the salt quality and demanded for local employment.

#### 10. N. Bhimaraj Reddy, Ex- Chairman, Ganjam Block.

He addressed the gathering and welcomed the technology adopted by the industry. He demanded for procurement of salt in the local area, employment to the local people based on their qualification, provisions for drinking water facility to the local and development of the surrounding areas through peripheral development. Lastly he said that they are not opposing the expansion project.

# 11. Sri Laxmi Padhy, Representative of Hon'ble M.P, Ganjam and Reporter of Sambad.

He addressed the gathering and said that for the socio economical development of an area industry is required. Hence, he welcomed the expansion project and hoped that due to the expansion direct and indirect employment will be created and local people will get benefitted due to the project. Further he hoped that due to expansion of M/s Grasim Industries Limited other ancillary industries will come up. He appreciated the activities of the Birla Groups and demanded that the proponent should procure the local salt and should provide technical assistant to the salt farmers. Further he demanded for employment to the local people.

#### 12. Sri Krushna Chandra Pradhan, Suryanarayanpur, Ganjam

He addressed the gathering and welcomed the expansion project. He showed his happiness and said that approval should given the expansion project.

#### 13. Sri Ranjit Kumar Pradhan, Ganjam NAC.

He addressed the gathering and hoped that due to the expansion of the unit, there will be opportunity for direct and indirect employment to the local people and said that they should co-operate the expansion of the project so that the area will be developed.

#### 14. Sri Kailash Chandra Pallai, Puintala, Ganjam.

He addressed the gathering and said that if there is industry there will be impact on water and air, however he welcomed the project and demanded that the project proponent should followed the CSR activity within a radius of 10 K.M. and should provide drinking water facility to the local people, Medical facility, Educational facility up to +2 level with good teaching staffs and employment to the local people. #### 16. Sri A. Kaleya, Ex-Sarapanch, Agastinuagaon G.P.

He welcomed the project and said that the project proponent should carried out the CSR activities properly and one paediatric hospital should be established for the local people.

#### 17. Sri Dillip Chhotaray, Sarapanch, Pallibandha G.P.

He addressed the gathering and welcomed the expansion project. He said that the industry should procure the local salt and M/s Grasim Industries Limited should provide technical assistance to the salt farmers for production of quality salt and should provide employment to the local people. Further he said that environmental issues should be handled properly and employment should be given on qualification basis to the local people.

#### 18. Sri Brundaban Pallai, Ganjam

He addressed the gathering and welcomed the expansion project. He hoped that the industry should come up so that the peripheral development of the areas will occur. He added that the industry should take all precautionary measures to address the pollution problems and should provide employment to the local people.

#### 19. Sri R. Bhagirathi Reddy, Ex-Vice Chairman, Kainchapur, Ganjam Block.

He welcomed the expansion project and demanded that the proponent should provide employment to the local people and also provide health facility to them. Further he said that the industry should take steps for peripheral development and educational development. If the unit will fulfill their above demand then they will support the project.

#### 22. Sri Ranjit Kumar Palai, Young Mass General Secretary, BJD.

He addressed the gathering and want to know the status of present employee position and after expansion. Further he demanded for procurement of local salt and employment to the local people.

#### 23. Sri Shyam Sundar Pallai, Barapalli, Ganjam.

He addressed the gathering and showed his dissatisfaction and said that no drinking water facility provided to them and said that due to chlorine gas effect his crops getting damaged which should be addressed properly. Further he demanded for local employment.

#### 24. Sri Surath Pradhan, Ex-Chairman, Ganjam.

He addressed the gathering and emphasized on utilization of local salt in the industry so that people will get direct and indirect employment and demanded for the development of fishermen and cultivators. Lastly he welcomed the expansion project.

#### 25. Sri G. Santosh Reddy, Sarapanch, Kainchapur, G.P.

He addressed the gathering and on behalf of the people of his Gram Panchayat, welcomed the expansion project. Further he demanded for making provisions for recharge of Ground Water at Kalyanpur, development of educational facility, health facility and employment to the educated local people.

#### 26. Sri Kanhu Nayak, Bada Bazar, Ganjam.

He addressed the gathering and demanded for own employment.

#### 27. Sri Santosh Mohapatra, Durgadevi Street, Ganjam

He addressed the gathering and showed his happiness and expressed that the pollution load has been reduced remarkably due to adoption of new technology. Further he demanded for free education, free medical facilities to the local people, procurement of salt from the local cultivator and should create opportunity for direct and indirect employment. Lastly he hoped that the industry should improved a lot and the environmental issues should be addressed properly.

#### 28. Sri Guru Charan Raula, Puintala, Ganjam.

He addressed the gathering and shows his dis-satisfaction and said that M/s Grasim Industries has not taken initiation for the improvement of local salt cultivation. Further he said that the chlorine gas of the industry is affecting the surrounding which should be controlled. Lastly he welcomed the expansion project and demanded for local employment and requested for carryout of environmental study of the surrounding area.

#### 29. Dr. Priyansu Pradhan, Hon'ble MLA, Chatrapur.

He addressed the gathering and said that everybody supporting the expansion project. But there should be employment opportunity to the local unemployed. Further he expressed his view that priority should be given for utilization of local salt and the allegation with respect to chlorine gas leakage should be addressed properly. Also he said that the educational standard of Jayshree English Medium School should be improve.

#### 30. J. Santoshi Reddy. Zillaparisada

She addressed the gathering and desired the social and educational development of the area.

#### 31. Sri Sanatana Behera, Kainchapur, Ganjam.

He addressed the gathering and welcomed the expansion project and said that water demand is increasing day by day and the ground water level is depleting, therefore, the ground water recharge is required. He requested the project proponent and the District Administration for local employment and training to the local unemployed Engineering and Diploma students for skill development. Lastly he supported the expansion of the project. Further he requested for repairing of the river bank.

#### 32. Sri J. Rajesh Reddy, Santoshpur, Ganjam

He addressed the gathering and welcomed the expansion project. He showed his dissatisfaction on present local employment and suggested for more employment to the local people on qualification basis. Further he emphasized on the reddressel of the pollution problem of the surrounding areas.

#### 33. Sri Rama Krushna Pradhan, JCL, Workers Union.

He addressed the gathering and said that as the ground water getting depleted, the industry should take steps for ground water recharge. Further he said that the salt cultivation of the local area should be restarted and the industry should use the local salt as its raw material and the industry should provide employment to the local people.

#### 34. Urmila Pallai, Chairperson, Ganjam NAC.

She addressed the gathering and said that the company should come up. She demanded that the local salt should be utilized as raw material in the plant. Further she said that there should not be any environmental problem due to the industry, the drinking water problem should be taken in to account by the unit, there should be employment to the local people, mass plantation should be developed in the surrounding and proper implementation of the CSR activity by the proponent.

#### 35. Sri Trilochan Sahu, Purunabandha, Ganjam.

He addressed the gathering and welcomed the expansion project. He demanded for development of the approach roads of the industry with plantation in both sides, the environment and ecology should be balance so that there should not be any affect to the nesting of Sea Turtles, the local salt cultivation should be facilitated, the industry should provide employment to the local people and CSR activity should be carried out as per the provision.

#### 36. Sri Daniel Das, President, JCL, Workers Union.

He addressed the gathering and said that the industry should promote the local salt by improving in the quality under CSR activity and it should operate the ETP with adequate capacity, should provide educational facilities, employment opportunity to the local people, development of a park and suggested for installation of desalination plant.

#### 37. Sri A. Sanjib Reddy, Kalyanpur, Ganjam.

He addressed the gathering and showed his dissatisfaction on drawal of ground water at Kalyanpur Region which affecting the ground water level, salt production and agricultural activity. He suggested that the proponent should take steps for ground water recharge, mass plantation, provisions for drinking water facility, employment to the local people, improvement of quality of the education, irrigation facility to the local and there shall not be affect to soil, air, water of the area.





#### 38. Sri Tuna Moharana, Kalyanpur, Ganjam.

He addressed the gathering and showed his dis-satisfaction and said that the proponent has not fulfilled the assurance made in the last public hearing. Further he questioned on the Environmental Impact Assessment and environment protection made by the unit and also on the social impact analysis of the area. He said that he is not opposing the expansion of the unit but the company should provide the local employment, need based CSR activity, training and awareness programme for the local people and should take steps for proper protection of the environment.

#### 39. Sri Dambaru Brahma, Ganjam.

He addressed the gathering and showed his dissatisfaction and said that the unit has not taken any steps towards employment, health, education, environment, communication, ground water contamination and plantation activity. He opposed the expansion project.

#### 40. Smt. Sushama Biswal, Counsellor, Ward no.- 9, Ganjam.

She welcomed the project and demanded for local employment, drinking water facility, health and education facilities to the surrounding area.

#### 41. Sri Umakanta Behera, Damodarapur, Ganjam.

He welcomed the project and demanded for local employment and the CSR activity should be taken. Further he requested not to discharge the waste water out side of the company.

#### 42. Sri Prasant Kumar Naik, Chairman, Ganjam Block.

He addressed the gathering and welcomed the expansion project and said that the issues raised by the deliberators in this public hearing should be fulfilled. He suggested that one committee should be constituted for peripheral development. Also he requested the State Pollution Control Board for close monitoring of the environmental pollution of the unit. He further demanded for local employment and procurement of local salt.

#### 43. Sri Arakhita Mahakuda, O.D. Street, Ganjam, Ward No.- 6.

He addressed the gathering and said that everybody supporting the project, therefore they are also supporting the project with the conditions that the company should take steps towards local employment, educational development, provision of health facility, agricultural development, compensation to crop damage and better environment.
