

**PROCEEDINGS OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT OF M/S. SARAF AGENCIES PRIVATE LIMITED FOR EXPANSION OF 15 MW CAPTIVE POWER PLANT, 5000 TPA FERRO TITANIUM, 3000 TPA FERRO MANGANESE, 12TPD ALUMINIUM POWDER AND 2.4 TPA SCANDIUM OXIDE RECOVERY PLANT AT KANAMANA, TIKIRI-BERHAMPUR & SRIRAMCHANDRAPUR, CHATRAPUR, DISTRICT- GANJAM**

**VENUE: AT THE VACANT SPACE INFRONT OF KANAMANA GRAM PANCHAYAT OFFICE, UNDER CHATRAPUR TAHASIL OF GANJAM DISTRICT ON 16.08.2017, AT 11.00 AM.**

At the outset, Sri Mitrasen Majhi, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA notification, 2006 and the objectives of the public hearing. He stated that M/s Saraf Agencies Private Limited has proposed to have environmental assessment for expansion of 15 MW Captive Power Plant, 5000 TPA Ferro Titanium, 3000 TPA Ferro Manganese, 12 TPD Aluminium Powder and 2.4 TPA Scandium Oxide recovery plant at Kanamana, Tikiri-Berhampur & Sriramchandrapur, Chatrapur, District- Ganjam and has applied to obtain Environmental Clearance from the Ministry of Environment, Forest and Climate Change, Government of India and carried out Environmental Impact Assessment (EIA) Study.

**Publicity regarding public hearing was made in the following manners –**

- *Advertisements made through Oriya daily “The Dharitri” dated 15.07.2017 and an English daily “The New Indian Express” dated 15.07.2017 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report, Executive Summaries (Oriya & English) and soft copy in the office of Collectorate Ganjam, Chatrapur, District Industries Centre (DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment, Govt of Odisha and also in the website of State Pollution Control Board, Bhubaneswar ([www.ospcboard.org](http://www.ospcboard.org)).*

- *Executive summaries along with paper clippings regarding date, time and venue of public hearing were made available to the Kanamana Gram Panchayat, Sriramchandrapur Gram Panchayat, Arjipalli Gram Panchayat, Kalipalli Gram Panchayat and Chamakhandi Gram Panchayat of Ganjam district.*
- *Further, announcements were also made through loud speaker regarding Public Hearing for information of the public in the surrounding villages.*

He requested the audience to express their opinion orally or in writing on the environmental aspects. Then he requested the Additional District Magistrate (Revenue), Ganjam, Sri Bijaya Kumar Dash, O.A.S. (S) to kindly preside and supervise the public hearing.

The Additional District Magistrate (Revenue) Ganjam, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment & Pollution related aspects. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking environmental clearance from the Govt. of India. Then he asked the representatives of M/s Saraf Agencies Private Limited to give the detail description on the project.

On behalf of M/s Saraf Agencies Private Limited, Kanamana Chatrapur, Ganjam, Sri Bipin Bihari Panda, from M/s Centre for Envotech & Management Consultancy Pvt. Ltd., presented the salient features of the project, the present status of the environmental conditions, possible impact on the environment due to execution and operational activities and the remedial measures to be undertaken by the project proponent to reduce the impact while executing the project.

He concluded that a suitable Environmental Management Plan has been formulated and would be continuously upgraded to mitigate the impact on the different components of the environment such as Water, Air, Noise & Soil.

The Additional District Magistrate (Revenue) Ganjam, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project; specifically relating to environmental issues. About 600 persons were present in the public hearing meeting, but only 87 persons signed in the attendance sheet. 127 persons registered in the deliberation sheet and 102 persons participated in the oral deliberation. 02nos. of written

representations were received in the hearing. The attendance sheets of audience and deliberators along with the written representations are enclosed as **Annexure-I, Annexure-II** and **Annexure-III** respectively.




