At the outset Sri Hemendra Nath Nayak, Regional officer, Rourkela, State Pollution Control Board, Odisha welcomed the public present in the meeting. He briefly described the objective of the public hearing as per the EIA Notification S.O. 1533(E), dated 14th September 2006 of the Ministry of Environment and Forests & CC, Govt. of India. He informed that the date, time and venue for conducting the public hearing of M/s Suraj Products Limited for expansion of existing steel plant at- Village Barpalli, Kesramal, Dist-Sundargarh, was advertised in Odiya daily "Sambad" on 19.08.2017 and English Daily "The New Indian Express" on 18.08.2017. The production capacities as per revised TOR are less than the production capacities as mentioned in original TOR. The EIA/EMP report has been prepared as per revised TOR and was circulated and displayed prior to the date of above public notices. Corrigendum with regard to production capacities as per revised TOR was also advertised in Odiya daily "Sambad" on 22.09.2017 and English Daily "The New Indian Express" on 22.09.2017. (Paper cuttings of news papers are enclosed).

On behalf of the project proponent, Sri Mahendra Kumar Hati, Chief Finance Officer of M/s. Suraj Products Limited welcomed the dignitaries on the dais and gathering. He gave a brief description about the existing plant facilities and proposed expansion project. He has stated that the EIA/EMP report has been prepared as per revised Terms of Reference by the authorized consultant. He has expressed that the company is following the norms and guidelines of the MoEF & CC, Govt. of India and SPCB, Odisha in their existing plant. They will also control the pollution as per the norms and guidelines issued by the MoEF & CC, Govt. of India and SPCB, Odisha in their expansion project. Green belt has already been developed by the company and plantation activity will continue to comply the norms of 33% area of green belt out of total area. He has stated that at present about 348 persons were employed in the existing plant, among them about 90 % are from the local public. This proposed expansion project will generate about 300 employments during the construction period and about 300 employments during the operational period. This project is also expected to

create opportunities for indirect employment to about 500 persons. He has assured that preference will be given to local people as per their eligibility during employment. The project proponent has earmarked 2.5 % of the project cost for the peripheral development through Corporate Social Responsibility. At the end he has also highlighted that this project will be beneficial to the society.

Addl. District Magistrate, Sundargarh invited the public to offer their views on environmental related issues of the proposed expansion project. Most of the participants have welcomed the new project for employment opportunity & peripheral development. However they have raised issues related to employment to local peoples, Environment protection and Pollution Control, land acquisition, health care facility and drinking water facility. The views offered by the participants are enclosed as Annexure-IV. Summary of the points raised by the participants in the public hearing in English and Odiya (vernacular language) is enclosed as Annexure-V(A & B).

After the completion of the deliberation process ADM, Sundargarh invited the representative of M/s. Suraj Products Limited to give a brief note on the issues related to the demand and grievances of the local people raised in the public Hearing meeting. Summary of the views of the project proponent on issues raised by the public during public hearing in English and Odiya (vernacular language) is enclosed as Annexure-VI (A & B). During public hearing the proponent has also submitted their commitments in writing, which is enclosed as Annexure-VII.

Er. Deepak Kumar Sahoo, Asst. Env. Engineer, State Pollution Control Board, Rourkela gave vote of thanks at the end of public hearing after deliberation of the above and concluding statement by ADM, Sundargarh.

The Attendance sheet of the members present in the public hearing is annexed as Annexure-I. About 650 participants have attended the public hearing meeting but only 115 persons put their signature in the attendance




