Proceedings of the Public Hearing meeting of M/s. Deepak Fertilizers and Petrochemicals Corporation Ltd., At: Village: Bagadia, Chaukiarnata, Rangiagarh, Tehsil: Paradeep of Jagatsinghpur district for establishment of an Ammonium Nitrate Manufacturing Complex for Manufacturing of Technical Ammonium Nitrate-1000 MTPD and Ammonia-380 MTPD held on 13<sup>th</sup> October,2017 At 11.00 am, At: Gram Panchayat Office, Kothi under Kujang Block, Paradeep of Jagatsinghpur district.

Sri Biswajit Biswal, Addl. District Magistrate, Paradip presided over the meeting along with Dr. M. Mahaling, Regional officer, State Pollution Control Board, Odisha, Paradip. ADM, Paradip welcomed the public who were present at the venue for participating in the public hearing and informed about the objectives of the Public Hearing meeting.

At the outset Regional officer, State Pollution Control Board, Odisha, Paradip welcomed the public present in the meeting. He briefly described the objective of the public hearing as per the EIA Notification S.O. 1533(E), dated 14<sup>th</sup> September 2006 of the Ministry of Environment and Forests & CC, Govt. of India. He informed that the date, time venue for conducting the public hearing of M/s. Deepak Fertilizers and Petrochemicals Corporation Ltd., At: Village: Bagadia, Chaukiamata, Rangiagarh, Tehsil: Paradeep of Jagatsinghpur district was advertised in Odiya daily "The Samaj" on 09.09.2017 and English daily" Times of India" on 10.09.2017. (Paper cuttings are enclosed as Annexure-I).

On behalf of the project proponent, Mr. Chitaranjan Panigrahi, Senior Manager (Project) of M/s. Deepak Fertilizers and Petrochemicals Corporation Ltd., At: Village: Bagadia, Chaukiamata, Rangiagarh, Tehsil: Paradeep of Jagatsinghpur district, gave a brief presentation about the proposed project. He also briefed about the environmental management, pollution control measures and safety aspects to be undertaken in the proposed project.

ADM, Paradip invited the public to offer their views on environmental related issues of the proposed project.

About 550-600 participants have attended the public hearing meeting and out of them about but 337 participants have put their signature in the attendance sheet whose list is annexed as **Annexure-II**. About 33 persons have registered their name to deliver their views and out of them only 30 persons have delivered their views during public hearing and list is annexed as **Annexure-III**.

Statements of the public participated in the deliberation during public hearing meeting is as follow;

1.	Sri. Priya Ranjan Samantray:
	He expressed his dissatisfaction towards different industries operating in and around Paradeep area and stated that local people have not get employment in the industries and also the industries have not taken any local development activities in spite of local people have sacrificed their land for the sake of industrial purpose. He also added that local people of the Paradeep are not against the industrialization since 1962.

and road facilities to the local villagers.

At the end he has conditionally supported the proposed project with a demand before the company to provide employment & other peripheral development in the local villages under CSR activities.

# 2. Sri. Sachitra Mohanty of Village Jhimani:

- He demanded before the company authority that the employment should be given to the land looser of the local villagers as per their qualification in the proposed project.
- He also demanded before company authority to provide better education and healthcare facilities to the local people.

At the end he supported the proposed project.

# 3. Sri. Jogendra Sarkar, Village: Kothi

- He stated that the company authority should fulfill the commitment made in the public hearing meeting.
- He also demanded before company authority to provide employment to the local people in the proposed project and to provide better education and health care facilities to the local people.

At the end he supported the proposed project.

### 4. Mr. Pabitra Sahoo, Kothi

He expressed his dissatisfaction towards different industries operating in and around Paradeep area and stated that local people have not get employment in the industries.

- He raised the issues related to CSR activities and said about the industries that they are not undertaken the CSR activities in Paradeep areas.
- Further he added that 5% of the annual incom shall be spent under CSR activities in the localities by the company authority.
- He stated that environmental pollution is taking place due to operation of the Paradeep Port Trust.
- He expressed his serious concerned on dust pollution issues on the road due to plying of heavy vehicles particularly in gate no.1,2,3 & 4 of the Paradeep Port Trust. He also concerned about traffic related issues of the Roads connecting from Paradeepgarh to gate no-4 of PPT, and added that roads is unsafe for two wheeler riders. He informed that heavy vehicles and tankers are parking along the oil terminal road due to non-availability of parking facilities.
- He also suggested that the massive plantation should be undertaken by the various company authorities on both side of the roads in Paradeep areas.
- Also he apprehended that there is every possibility of fire and explosion hazards due to storage of chemicals by different industries of the Paradeep area.
- He also concerned about unemployment and unavailability of better medical facility at Paradeep area.
- He also expressed his concerned on the issues of ground water, local river & creek pollution and temperature rise in Paradeep area due to industrialization.

At the end he conditionally supported the proposed project with a demand before the company authority to provide employment, education & economic development in the local villages.

#### 5. Mr. Arakhita Das, Member, Panchayatsamiti, Kothi

 He expressed his dissatisfaction that various existing industries operating in the Paradeep areas for not providing the employment to the local youths & land losers in spite of they have given land for industries.

At the end he conditionally supported the proposed project with a demand before the company authority to provide employment to the local people in the proposed project.

# 6. Sri. Manoj Kumar Tarai:

He expressed his dissatisfaction and raised the following issues;

- Environmental pollution in Paradeep area has been increased manifold due to industrialization and caused the seasonal variation in this region.
- No local employment in the nearby industries.
- No CSR activities are undertaken by the industries in the local village.
- He also stated that if all the CSR amount of the companies would have spent then a
  good hospital would have established in Paradeep area. He also emphasized on
  employment, economic development of local people, massive plantation in & around
  Paradeep area.

At the end he conditionally supported the proposed project with a demand before the company authority to provide employment to the local people in the proposed project.

# 7. Sri. Rashmi Ranjan Choudhury, Zilla Parishad

He expressed his views and demanded before the proposed company authority to fulfill their following basic need before construction of the proposed project.

- Employment to the local people in the proposed project.
- Safe drinking water supply to the local villages prior to commissioning of the proposed project.

At the end he conditionally supported the proposed project with a demand before the company authority to fulfill their basic needs.

#### 8. | Sri. Dukhi Charan Swain

He expressed his views and demanded before the company authority to provide employment to the local people in the proposed project and safe drinking water supply to the local villages.

At the end he supported the proposed project.

# 9. Mr. Chinmaya Das, President, Paradeep Port Affected Land Loser Farmers Society:

- He expressed his views that IOCL, PPI, IFFCO and PPT have established over agricultural land of the local farmers. Local people have sold their land with lower prices with a hope to get employment in these companies, but the companies have failed to provide the employment. Also he stated that daily laborers working in these companies are being paid with minimum wages and company authorities heeds their plea.
- He informed that about 83.26 acres of land has been acquired for the proposed project of having capital investment of Rs.1750 Crore including cost of air pollution control equipments.
- He demanded before the company authority to recruit a person from each land loser family in the proposed project.
- Also he stated that local environment is getting polluted due to PPL & IFFCO and ground water is getting polluted due to gypsum pond.
- He demanded that the water of the Taldanda Cannal should not be provided for the industrial purposes.
- He suggested for establishment of Super Speciality Hospital in Paradeep area under CSR activities of various plant.
- He also suggested to construct a sluice gate or barrage in Mahanadi river to utilize the

- He demanded before the company authority to undertaken CSR activities and employment to the local farmers.
- He suggested to celebrates farmer's day & labors days by all the industries to encourage them

At the end he conditionally welcomed the proposed project.

### 10. Sri. Bada Kishor Jena, Village: Rangiagarh

He expressed his dissatisfaction and raised the following issues;

- No employment to the local people in the nearby industries.
- He also said that many company authorities have misled the local farmers in the name of employment and not yet provided the employment.
- He demand before the company authority to provide employment to the local people in the proposed project and said that local people will demonstrate if the company authority will not provide recruitment to the local people in the proposed project.
- He expressed his concern about the deteriorated road condition leading from Kujang to IOCL and demanded for repairing & maintenance.

At the end he supported the proposed project.

### 11. Bipin Kumar Tripathy, Sarpanch Pratinidhi, Mangrajpur

He expressed his views and demanded before the company authority to fulfill their following basic needs;

- Employment to the local people in the proposed project.
- Safe drinking water supply to the local villages.
- Better health care facilities to the local villagers
- Provisions of street lights in village roads
- Provisions of toilets in the local villages
- CSR activities in the local villages.

At the end he supported the proposed project.

#### 12. Dr. M.S. Panda, SwachSamaj, Bagadia

He expressed his dissatisfaction and raised the following issues;

- There is no employment to the local people in the nearby industries in Paradeep areas.
- No health care facilities are being provided to the local villages by the industries.
- He read out the written presentation submitted during public hearing which states that M/s. EQMS India Pvt.Ltd. the Environmental consultant of M/s. Deepak Fertilizers has not collected and presented any meteorological data and ambient air data of the 10 km radius area of the recent one/two years period. The data presented in the EIA report was collected for one season (3 month) by M/s. ERS (I)Pvt. Ltd., Bhubaneswar from 15/09/2009 to 15/12/2009., therefore he said that the data are of seven & half years old and based on those data some inference have been made.
- He also stated that concentration of  $PM_{10}$  &  $PM_{2.5}$  level in AAQ has increased in and around paradeep area in last seven & half years at that time when EIA & EMP had prepared, hence the study of EIA & EMP is treated as null & void.
- He also stated that proposed project would produce 5 products viz. technical
  ammonium nitrate prills, nitric acid, ammonium nitrate solution and ammonia. The
  units manufacturing these products will release plenty of nitrates, nitrates laden
  effluent; emit nitrogen based particulate matter to the environment and solid waste

to the environment. These pollutants on reaching the water bodies, become highly toxic to fish and flesh food organisms, paddy filed and plants/tress even with less concentration. Many company authorities have misled the local farmers in the name of employment and not yet provided in their company.

- He also suggested that reverse osmosis system (RO) should be introduced with the ETP for the treatment of waste water generated from the industry.
- The industry should not be allowed to withdrawal of water from Taladanda canal because canal is over stressed.

At the end he strongly opposed the proposed project.

### 13. Sri. Mihir Ranjan Sahu, Sarpanch, Paradeepgarh

- He expressed his dissatisfaction and stated that local farmers have scarified their agricultural land for the sake of industries in the Paradeep areas like IFFCO,ESSAR, IOCL, but these companies have not provided employment to the locals.
- He concerned about employment to local unemployed youth, drinking water supply to nearby villages, improve in educational facilities, development under CSR activities.
- Also he stated that no local development is being made by the companies operating in Paradeep areas.

At the end he conditionally supported the proposed project with a demand before the company authority to provide employment to the local people in the proposed project.

# 14. Sri. Basanta Kumar Sethi, Village: Kothi

He welcomed the proposed project with a demand before the company authority to provide employment to the land looser in the proposed project.

# 15. Sri. Galak Chandra Nayak, Village: Pardeepgarh

- He expressed his dissatisfaction and stated that land of about Ac.18,000 to Ac.20,000 have been given for the sake of industrial activities in Paradeep areas, but these companies have not yet provided any employment to the local people.
- Also he stated that no local development is being made by the companies operating in Paradeep areas.

At the end he conditionally supported the proposed project with a demand before the company authority to provide employment to the local people of four Gram Panchayats namely kothi, Paradeepgarh, Bagdia and Mangarajpur in the proposed project.

# 16. Sri. HarekrishnaNayak, Village-Kothi

He expressed his dissatisfaction and said that local farmers have scarified their agricultural land for the sake of industries in the Paradeep areas like PPL and Paradeep Port Trust, but these companies have not provided employment to the locals.

At the end he conditionally supported the proposed project with a demand before the company authority to provide employment to the local people in the proposed project.

# 17. Sri. Birendra Nath Acharya, Village-Kothi

He expressed his dissatisfaction towards different industries operating in and around Paradeep area and stated that no local area development is being made by the industries.

- He has demanded before the company authority to give attention towards health and environmental protection in the localities.
- He also demanded before the company authority to provide technical training to the local youths and provide employment in the proposed project.

At the end has supported the proposed project.

# 22. Sri. Satya Praksh Mohanty, Village-BhutaMundai

He expressed his dissatisfaction and stated that pollution level has increased manifold in the Paradeep area.

- He also stated that the local farmers have scarified their land for the sake of industries in Paradeep areas and the farmers have left nothing in their hand for livelihood and they are deprived from basic fundamental rights.
- He has demanded before the company authority to provide safe drinking water supply in the local village.
- He has stated that ground water of the Paradeep area has been polluted with saline water which contains high TDS.
- He demanded before the company authority to provide employment to the local people in the proposed project.

At the end he conditionally supported the proposed project.

#### 23. Sri. Rashmi Ranjan Samantray

He has demanded before the company authority to make pollution free environment as well as provide employment to the local people in the proposed project.

- He narrated the example of Bhopal Gas Tragedy and said that similar disaster may takes place in Paradeep area in near future as the Companies are importing huge quantity of LPG and storing it in their plant premises.




