PROCEEDINGS OF THE PUBLIC HEARING OF M/S PRADHAN INDUSTRIES FOR **BAINIBASA** GRAPHITE MINING AND BENEFICIATION PROJECT FOR GRAPHITE ROM MINING OF 13272TPA AND ITS BENEFICIATION TO PRODUCE 841TPA CONCENTRATE OVER AN AREA OF 58.704HA HELD ON 28.11.2017 AT 11.00 AM AT VILLAGE -BAINIBASA, BHAIRABAGADA GRAMPANCHAYAT TAHASIL- MUNIGUDA, DIST RAYAGADA

The public hearing in respect of the above project was held on 28.11.2017 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in nearby villages of proposed project site and also published in Local Dailies. The process followed for public hearing was adequate.

At the outset, Er. P Kar, Regional Officer, State Pollution Control Board, Rayagada welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Shri Birendra Korkora OAS(S) ADM, Rayagada presided over and supervised the public hearing. He briefed about the importance and objectives of such hearing and invited the project proponent to highlight on proposed project.

Er. Ashok Mishra, Consultant (Mining Advisor) of M/s Pradhan Industries, Bainibasa, Muniguda, Rayagada has explained about the proposed project and briefed about the Pollution Control measures to be adopted in the Project.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Rayagada.

1. Sri Radhamohan Dalapati, Bhairabagada

Sri Dalapati expressed his pleasure for this Public Hearing. He informed that they have experience of Graphite Plant since earlier another plant was operating in their locality. Further he informed that there are about 500 nos. of houses existing in Bhairabagada GP and they all depend on River Sakata for their day to day life. He apprehended that River Sakata water may be polluted due to the Project & expressed his concern regarding the use of Sakata River water for agriculture purpose. He emphasised on prevention of river water pollution by the project. He hoped that the local experienced skilled & unskilled people will be employed on priority basis in the project. He requested the project proponent for development of local schools, roads within 10 km radius and support for local cultural programmes. He supported the formation of committee as proposed by the project for local development and stressed on the protection of river water from contamination and adequate plantation.

2. Sri Anil Kumar Kuanra, Bhairabagada

Sri Kuanra expressed that the project will help to reduce the unemployment problem in the locality and urged that the water environment should be protected. He welcomed the project.

3. Sri Ramachandra Gauda, Sarapancha, Kumudabali ,Bhairabagada

Sri Gauda told that they have the experience about such project and expressed his concerned over the water scarcity in the locality during dry season. He urged for provision of alternative water sources for the Rabi crops. He suggested for filling of the mined out area followed by plantation for a better environment. He demanded for construction of roads in their Panchayat and suggested for pumping the water from River Vanshadahara to River Sakata to meet their water requirement during dry season. 78/11/17

4. Sri Sikaka Ramchadra, Ex Sarapancha Bhairabagarh GP, Bainibasa

Sr! Sikkaka expressed his concerned over the road problem in the locality and informed that Muniguda is 1km away from Bainibasa through river Sakata but no road connection is there. He hoped that the project will provide employment and make improvement of the locality. Also he urged that no effluent should be discharged to the river by the project for protection of river water.

5. Sri Dhanurjaya Jakesika, Nuagaon

He hoped that they will get employment in the project and it will help to avoid migration of local people to Kerala & Bombay for the job.

6. Sri Bhakta Charan Sahu, Bhairabagada

Sri Sahu expressed that earlier they got jobs in similar project at Padmapur but after close down of the project they became unemployed, so this project will provide employment opportunities. Further, he expressed that proper care should be taken to prevent the river water pollution and this project will be beneficial for them.

7. Sri Ramachandra Behera, Muniguda Zilla Parishada Member, Muniguda

Sri Behera hoped that this project will bring new opportunity for them and emphasised on plantation and protection of river water from pollution. He highlighted on the problem of drinking water and poor road connectivity in their locality. He drew attention of project proponent and District Administration regarding water scarcity problem for the farmers. He expected that the company will cooperate to solve their drinking water problem and water requirement for agriculture purposes and overall improvement in there locality. Further, he hoped that the project will provide enough employment opportunities for the locals and to avoid migrations for the job. He requested the project proponent to come up with a healthy and good environment.

8. Sri Paramnanda Gantayat, Bhairabagada

Sri Gantayat urged that the river water will not be affected by the project and hope that project will provide employment and all will be benefited. He suggested for formation of a committee for the developmental work of the locality and seek support for local cultural activities.

9. Smt. Jamuna Sikaka, Bainibasa

Smt. Sikaka described about the poverty of the locality and lack of proper education facilities. She hoped that the local people will jointly work in the project to meet their needs.

10. Sri Sanyashi Naik, Ex Samiti Sabhya, Bhairabagada

He congratulated the project proponent and welcomed the proposal to establish the mines in Bhairabaguda Grampanchayat which has a historical importance. He expressed his satisfaction for the coming up of mining project as it will provide employment to the locals and stop migrations to Kerala and Tamilnadu. Finally, he urged for proper labour payment and to extend support for agriculture by the project proponent.

11. Smt. Jamuna Majhi, Samiti Sabhya, Bhairabagada

Smt. Majhi emphasized on mutual cooperation for setting up of the project.

12. Sri Bhubani Pusika, Bhairabagada

He expressed his happiness for the mining project and hope that they will get employment and it will reduce the migration of the local people to Kerala & Bombay for the job. He demanded for the development of local roads by the project proponent.

13. Sri Jalandhara Sikaka, President Jangala Surakshya Committe, Bainibasa

Sri Sikaka described the local problems like poor road communication, lack of education facilities, and school building, lack of proper health facilities for pregnant ladies. He informed that most of them are daily labours and migrating to Kerala and Bombay for job. He strongly supported the project as it will provide jobs to the villagers and their children can get better education and other facilities.

14. Sri Digamber Sikaka, Sarapancha, Bhairabagada

Sri Sikaka stressed upon the clean environment for betterment of the locality. He informed that most of the peoples of Bhairabagada Panchayat are labours and they will be benefited by getting job in the project.

The Regional Officer, SPCB, Rayagada read over the issues raised by the public in the hearing and Er. Ashok Mishra, Consultant (Mining Advisor) of M/s Pradhan Industries, Bainibasa, Muniguda responded to the issues raised.

The issues raised by the public and corresponding comments of the applicant were prepared in Odia and English and it is annexed with the proceedings as Annexure-I & II respectively, list of the participants and oral deliberators in the hearing is annexed as Annexure-III& IV respectively. One written representation received during public hearing—is annexed as Annexure-V. The videography of proceedings are recorded and submitted as DVD (I).

Moreover, since Banshadhara is in downstream and about 8 Km from the mines site, it may not be feasible to bring water from Vanshadhara river for irrigation in the Bhairabgarh Panchayat. We also understand that, in order to provide water from local agricultural consumption, Govt. of Odisha has constructed one MI project and LI points in the neighboring villages situated at the upstream of Sakata Nala and providing water for irrigation to villages i.e. Vairabgarh, Nuagaon, & Bainibasa. In view of the above, we are of the opinion that, pumping of water from Banshadhara to River Sakata to support Ravi Crop during dry season in Bhairabgarh Panchayat, is not feasible. Moreover, ours being a SME project it will not be economically feasible on our part to undertake such a huge project.

The representatives of the project proponent informed that, they will spend Rs. 10,00,000.00 (Ten Lakhs) Approx. under EAC and equal amount under CSR Activity within 5 years from the starting of the mine and the expenses will be towards improvement in education sanitation, health of villagers. In addition, villagers will be trained in mobile repairing Pisciculture and Mushroom Cultivation for economic sustenance of villagers and the beneficiaries shall attend self sufficiency. The CSR expenses will be done as determined by a committee comprising representatives from Government, from villagers and Project Proponent.
