Proceedings of the Public Consultation conducted on 08.12.2017 at 11.00 AM for Construction of Additional Spillway of Hirakud Dam by Water Resources Department, Government of Odisha at Hirakud in Sambalpur District.

A public consultation for construction of an additional spillway of Hirakud Dam by Water Resources Department, Government of Odisha was held on 08.12.2017 at 11AM in front of Jawahar Udyan, Hirakud of Sambalpur district. Sri Trilochan Majhi, OAS(S), Additional District Magistrate, Sambalpur presided over the meeting along with Sri Dillip Kumar Dash, Regional Officer, State Pollution Control Board, Odisha, Sambalpur. He welcomed the public who were present at the venue for participating in the meeting. The attendance sheet of the members present in the public hearing and the public attended the meeting are annexed as **Annexure I and II** respectively. Around 300 (three hundred) persons had attended the public consultation meeting where as only 14 persons had signed the attendance sheet. 18 persons had intended to deliver their views whose list is annexed as **Annexure-III** and Inpot them took part in the deliberations. The statement of the public participated in the deliberation is annexed as **Annexure-IV**. The video recording of the entire proceeding of the public hearing will be forwarded to the Ministry of Environment & Forest, Govt. of India, New Delhi as such along with the proceeding of the meeting.

At the outset Sri Dillip Kumar Dash, Regional Officer of State Pollution Control Board, Sambalpur welcomed all the public present in the meeting. He briefly described the objective of conducting the public consultation as per the EIA Notification No.S.O. 1533(E) of Dt.14th September 2006 of the Ministry of Environment and Forests & Climate Change (MOEF & CC), Government of India, importance of the actual views of the villagers regarding the project.

Both Addl. District Magistrate, Sambalpur and Regional Officer explained to public that those who want to participate in the public hearing, may discuss about the impact on the environment due to the proposed construction project and the statements should be related to environment & pollution to be created due to the project. The Addl. District Magistrate then called the project proponent to describe the details of the project and its impact on surrounding environment before the public.

Additional District Magistrate Sambalpar Sri Harmohan Pradnan, Chief Engineer, Hirakud Dam stated that construction of additional spillway of the Hirakud dam is required to provide additional safety to the dam during increased entry of rain water into the Hirakud reservoir so that excess rain water can be discharged during such exigencies Such extreme conditions cannot be ruled out due to unexpected climate change scenarios. The additional spillway with 5 gates, each of 15m×15m will be provided at the left dyke of the existing demand excess flood water if any will be discharged to river Mahanadi through a 2.14 km long and 250 m wide RCC spill channel. The original dam will not be disturbed by construction of the project. He expressed that environmental problems of air, water and noise pollution caused during the construction period will be taken care of by following due procedures as recommended by MoEF & CC and State Pollution Control Board. Wide life in the project area is scarce and there will be no impact. There is 9.44 acres of forest land involved in the project for which forest clearance is sought from the Government.

Then the public deliberated on various issues of the project one by one.

After the deliberations were made by the public, Regional officer, SPCB, Sambalpur summarized various issues raised by the public and invited the project proponent to offer their views on those issues. Sri Harmohan Pradhan, Chief Engineer, Hirakud Dam placed his views on the issues raised by the Public. Sri Surjeet Singh Deepak, Consultant and Representative of the World Bank emphasized the procedure monitoring of the project and the environmental issues. The summary of the views and concerns of the public and the commitments made by the Project Proponent are annexed in Oriya language & English language as Annexure-V & VI respectively.

Finally the meeting was ended with a vote of thanks to the chair and other participants.

Statement of the Public participated in the deliberation during Public Consultation Conducted on 08.12.2017 at 11.00 AM for Construction of Additional Spillway of Hirakud Dam by Water Resources Department, Government of Odisha at Hirakud in

Sri Debendra Panigrahi, Gandhinagar, Hirakud 1.

He expressed his concern about the compliance to the points raised during earlier public hearing meeting conducted to deliberate socio-economic issues. He demanded to stop waste disposal by nearby industries in Hirakud area. Non-provision of public urinal at the meeting place was highlighted as a shortcoming in the arrangement.

2. Sri Manbodh Pradhan, Gandhinagar, Hirakud

He expressed that the rehabilitation and resettlement issues should be settled first before proceeding further. He emphasized about providing water, electricity and road to the resettlement areas and provision of schools and hospitals in approachable areas.

3. Sri Bhikari Pradhan, Gandhinagar, Hirakud

He also emphasized about rehabilitation and resettlement issues and opined that no deliberation on environment is required without solving the same.

4. Sri Malay Mahakud, Gandhinagar, Hirakud

He expressed his concerned that older commitments made by Government especially on plantation has not been fulfilled. He apprehended about safety of the Hirakud dam after a portion of the adjacent hill is cut due to the proposed project. He also expressed about settlement of the rehabilitation

5. Sri Braja Meher, Gandinagar, Hirakud

> He asked the project proponent the basis of selection about the present site for construction of additional spillway when other thinly populated areas are available. He requested for consideration of rehabilitation of the affected people inside Hirakud area and he demanded about minimum size of the houses where rehabilitation is made.

 He also expressed about rehabilitation and resettlement issues.

7. Sri Surendra Kumar Biswal, Gandinagar, Hirakud

He also expressed about rehabilitation and resettlement issues and demanded for minimum 4 decimal land with higher financial compensations.

8. Sri Pradeep Panda, Hirakud

He expressed that people have not been made aware about the environmental problems of the project and asked the project proponent to describe about environmental effects, forest clearance and the rehabilitation package. He demanded commitment from the authorities on the same. Chief Engineer Hirakud dam described about the monitoring of the project by World Bank authorities and committed that all the environmental issues and forest clearance will be taken up following due procedure. He also intimated about the rehabilitation dues approved by the Government.

9. Sri Subash Pattnaik, Hirakud

He emphasized about the pollution caused by nearby industries and how Hirakud is affected. He opined that the rehabilitation package proposed by Government is too less. He also expressed his concerned about their rehabilitation and demanded commitments to solve the issues. He demanded about looking into the prevailing environment of the proposed rehabilitation sites. He demanded that minimum 5 decimal land should be allotted with 10 lakh rupees compensation.

10. Sri Chandrasekhar Jena, Gujatal, Hirakud

He did not participate though signed in the attendance sheet.

11. Sri Rashmi Ranjan Swain, Hirakud

He also raised the rehabilitation issues. He demanded that Hirakud should be provided with ring road like Sambalpur and Burla. He demanded for construction of English medium School or Kendriya Vidyalay in the area. He also spoke about development of eco tourism in Hirakud.

12. Sri Baishnab Satpathy, Hirakud

He described about the problems of people in Re rolling mlll and Hira Cable areas after the factories were closed and demanded engagement of those people in the additional spillway project. He demanded for minimum compensation of 5 Lakh Rupees.

13. Sri Tarun Kanti Das, Gandhinagar, Hirakud

He raised various unrelated issues.

14. Sri Prakash Biswal, Gandhinagar, Hirakud

He expressed his concerned about flow of water in the additional spillway. He stated that Hirakud is flooded even the existing gates are opened and apprehended about more flooding due to the proposed additional spillway.

15. Sri Nisikant Das, Gandhinagar, Hirakud

He expressed from his memory that earlier 3 surveys made for location of this project and mentioned that this is the 4th survey and questioned why this location has been selected for the project. He emphasized about storage of water rather than discharging.

16. Sri Satyanarayan Behera, Gujatal, Hirakud

He emphasized about maintaining environmental standards during the project and to address the problems of affected people. He stated that there should be matching of commitment and practice during working.

17. Sri Arun Bahadur, Gujatal, Hirakud

He described about flooding in Hirakud and Sambalpur with the existing dam and questioned about the requirement for additional spillway.

18. Sri Kailash Chandra Mishra, Gujatal, Hirakud

He intimated that some affected people have not been included in the list and requested to include them.

The public raised the following issues and apprehensions for redressal by the project proponent.

- 1. Proper rehabilitation and resettlement of the affected families and adequate compensation.
- 2. Development of the resettlement area.
- 3. Safety of the existing dam after cutting of the nearby hill for construction of the spill channel.
- 4. Possible flooding in Hirakud and Sambalpur due to extra discharge of flood water through the additional spillway.
- 5. Deforestation in the project area and afforestation thereafter.

Views of Project Proponent on the issues raised by the public during the Public Consultation

- Rehabilitation and resettlement will be done as per the procedure approved by Government of Odisha. Core committees formed with representatives of the affected area will discuss the issue with the district administration and the Hirakud dam authorities and settle the issue.
- 2. The resettlement area will be developed with supply of road, water and electricity.
- Safety of the existing dam has been ensured by proper engineering and geotechnical studies.
- Additional spillway will be used only during exigencies to have better flood control and for safety of the Hirakud reservoir.
- 5. Compensatory afforestation will be carried out by Forest department, Government of Odisha as per the Rules.
