PROCEEDINGS OF THE PUBLIC HEARING MEETING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT OF M/S ODISHA CEMENT PLANT (A UNIT OF SHREE CEMENT LIMITED) FOR ESTABLISHING A CLINKER GRINDING UNIT OF 5.5 MILLION TONNES PER ANNUM CAPACITY (PHASE-I OF 3.0 MILLION TONNES PER ANNUM CEMENT AND PHASE-II OF 2.5 MILLION TONNES PER ANNUM CEMENT ALONG WITH 20 MW CAPTIVE POWER PLANT AND RESIDENTIAL COLONY NEAR VILLAGE CHANDRABALISHYAMPUR UNDER ATHAGARH BLOCK IN THE DISTRICT OF CUTTACK

The Public Hearing meeting in respect of environmental impact assessment of M/s.Odisha Cement Plant (a unit of Shree Cement Limited) for establishing a clinker grinding unit of 5.5 million tonnes per annum capacity (phase-I of 3.0 million tonnes per annum cement and phase-II of 2.5 million tonnes per annum cement along with 20 MW captive power plant and residential colony near village Chandrabalishyampur under Athagarh block in the district of Cuttack was held at the scheduled venue & time i.e. on 20.3.2018 (11.00 am) at the play ground of Ghantikhal Panchayat High School at/po: Ghantikhal in Athagarh Tahasii,PS: Khuntuni in Cuttack district, Odisha with reference to:

- 1. EIA Notification S. O. 1533(E) dated 14.09.2006.
- 2. Interim Operational Guidelines.

At the outset, welcoming the members participating in the meeting presided over by the Additional District Magistrate, Cuttack, the Representatives of State Pollution Control Board, Odisha, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by M/s Odisha Cement Plant(a unit of Shree Cement Limited).

Welcoming the public, Dr. Giri, the Regional Officer, State Pollution Control Board, Odisha, Cuttack, explained the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public.

Sri Rakesh Bhargava, Vice President (Environment), M/s Shree Cement Limited addressed the committee members and the assembled public in Hindi language and told that their environmental consultant will present the details of the project in local regional language Odia. Sri Mitu Behera, Consultant made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, afforestation programme and various other CSR activities envisaged in the proposed project.

Then Dr. Giri, Regional Officer, State Pollution Control Board, Cuttack requested the public to give their views, comments, objections and opinions on the proposed project.

The following speakers gave their views on the above said project, which is given as follows:

1. Sri Santosh Kumar Behera, Social Activist

Sri Behera introduced himself as a social activist in this area and welcomed the dias, political representatives, media and the people present in the meeting. He informed that earlier in Athagarh region there were no industry and with the interest of Sri Ranendra Pratap Swain, Honble Athagarh MLA some industries have come up which have helped in eradication of unemployment, and there has been economic growth and upliftment of social livelihood of the people. He mentioned that if this project comes up then there will be economic development in their area, people will get employment and there will be further development and the livelihood of the people will increase. Finally he welcomed the project.

2. Smt. Janakilata Nayak, Zilla Parishad Member, Zone No. 3

At first she informed the people regarding the public hearing meeting and thanked all the peoples of their area, government people, police, media and their local political representatives of Athagarh area. She welcomed the industry and informed that after the industry is established, the Company will provide all necessary facilities of the local people in their area and the Company Management have already given their assurance and commitment. She also warned the Company that, they should not deviate from their commitment made to them. She told that, they have faith on the Company and they should fulfill all the assurance and commitment given to them. There will be development in their area, the youth will get employment and informed that since they are rendering all types of help like they have given their lands, water air environment to the Company and similarly the Company should also equally reciprocate. She assured that that the Company will do all types of development work and there will be economic growth in the region.

3. Sri Laxmidhar Mohanty, Sarpanch, Ghantikhal

Sri Mohanty at first welcomed all the people gathered in the meeting and showed his respect for them. He informed that due to industrialization in Athagarh area and Ghantikhal panchayat and establishment of three numbers of industries with the help of the Chief Minister Sri Naveen Patnaik and their Athagarh MLA Sri Ranendra Pratap Swain, unemployment and economic problem of that area has been solved and there has been economic growth in their area. He welcomed the upcoming project of Shree Cement for which the public hearing meeting is held.

4. Sri Pranabananda Pradhan, Samiti Member, Ghantikhal

Sri Pradhan told that, the Late Shree BijuPattnaik had an aim to make Odisha No. 1 as well as also No. 1 in industry. He informed that with the help of the Chief Minister Sri Naveen Patnaik and their Athagarh MLA Sri Ranendra Pratap Swain, three industry have come up in their Ghantikhal Panchayat area and development has occurred. He informed that due to establishment of M/s Shree Cement plant, their area will be further developed and employment and economic problem of that area will be solved. He requested the Project Proponent to create employment opportunity for ITI, Diploma, Degree and other students of that locality and to give employment as per their educational and other capabilities. He also asked the company to develop their area, provide health facilities and educational facilities to the area.

5. Sri Ranjan Kumar Beura, Sarapanch, Dalabhaga

Sri Beura welcomed all the people present in the public hearing meeting and informed that Shree Cement is conducting their public hearing meeting in their area and demanded that the Project Proponent shall give employment to the people of their panchayat and also provide health facilities and resolve and take care of other problems of their area. Finally he submitted a written representation to the Chair.

6. Sri Basanta Kumar Beuria, Dalabhaga

Sri Beuria expressed his willingness for conducting the public hearing for establishment of M/s Odisha Cement Plant. He informed that for establishment of that industry in 42 Acres of land some people of that area have to sell their land and the company should give employment to those people as per their capability and other unemployed persons of that area on the basis of their qualification. He welcomed all the officials of M/s. Odisha Cement Plant and told that they should not forget in future to keep the commitments which have been made in the public hearing meeting for the development of that area, since earlier other companies have cheated them. This company i.e. M/s. Odisha Cement Plant have come to them and Sri Beuria asked them to render all necessary helps to the people of their area.

Sri Harish Nayak, Sub-Collector Athagarh asked the Project Proponent to present their commitments to the people with respect to the demands raised by the public at the public hearing meeting. Sri Rakesh Bhargava, Vice President (Environment), M/s Shree Cement Limited on behalf of M/s Odisha Cement Plant committed that all development works of Ghantikal Panchayat and surrounding regions will be taken care of. He informed that, due to their affection and earlier commitment, they have planned to set up the industry. He lastly requested the villagers to cooperate in the venture undertaken by them.

Then the President of Public Hearing meeting, Sri Raghuram R. Iyer, Additional District Magistrate, Cuttack spoke on public hearing meeting held and thanked the people for rendering their co-operation for smooth operation of the public hearing and finally ratified the minutes of meetings with the views and demands of the public. He informed the public that the proceedings will be sent to the Member Secretary, State Pollution Control Board, Odisha, Bhubaneswar who will again send all the documents to the State Environment Impact Assessment Authority, Bhubaneswar where a high level committee will decide and take decision for grant of the above project proposal. Finally he ratified the minutes of meetings with the views and demands of public.
