

Proceedings of the public hearing meeting of Koira Iron Mines of M/s. Essel Mining & Industries Ltd. for enhancement of iron ore production from 4.0 Million TPA to 6.0 Million TPA over an area of 90.143 hectares at villages Koira, Nuagaon, Kadodihi & Harischandrapur, Tehsil Koira of Sundargarh District held on 30<sup>th</sup> October, 2018 at 10.30 AM at the Nuagaon Primary School Playground under Koira Block of Sundargarh District.

The public hearing meeting of Koira Iron Mines of M/s. Essel Mining & Industries Ltd. for enhancement of iron ore production from 4.0 Million TPA to 6.0 Million TPA over an area of 90.143 hectares at villages Koira, Nuagaon, Kadodihi & Harischandrapur, Tehsil Koira of Sundargarh District held on 30th October, 2018 at 10.30 AM at the Nuagaon Primary School Playground under Koira Block of Sundargarh District.

Sri Bhaskar Chandra Turuk, OAS (SAG), Additional District Magistrate, Sundargarh supervised and presided over the meeting along with Sri Hemendra Nath Nayak, Regional Officer, State Pollution Control Board, Rourkela, Odisha.

At the outset, Sri Hemendra Nath Nayak, Regional Officer, State Pollution Control Board, Rourkela welcomed the public present in the meeting. He briefly described the objective of the public hearing as per the EIA Notification S. O. 1533 (E), dated 14<sup>th</sup> September, 2006 of the Ministry of Environment, Forests & CC, Govt. of India. He informed that, the date, time and venue for conducting the public hearing of Koira Iron Mines of M/s. Essel Mining & Industries Ltd. for enhancement of iron ore production from 4.0 Million TPA to 6.0 Million TPA over an area of 90.143 hectares at villages Koira, Nuagaon, Kadodihi & Harischandrapur, Tehsil Koira of Sundargarh District was advertised in the Odia Daily "The Samaja" and the English Daily, "The Times of India" on 25<sup>th</sup> September, 2018 (**Papercuttings of the advertisements are enclosed**).

Additional District Magistrate, Sundargarh welcomed the public who were present at the venue for participating in the public hearing and informed about the objective of the public hearing.

On behalf of the Project Proponent, Dr. Khageswar Mahanta, Advisor (Geology) welcomed the dignitaries on the dais and the gathering. He gave a brief introduction of the mine highlighting the present status of the mine with respect to various environmental

protection measures and the environment management plan for the proposed expansion from 4.0 mtpa to 6.0 mtpa. He also informed about the proposed enhancement of production of the mine. He described that the highest altitude of Koira Iron Mines is 630 mtr above MSL. The lease area comprises of 59.458 Ha of forest land & 30.658 Ha of non-forest land. He also briefed about the mineable reserve of the mine which is estimated to be about 37 million tonne. The validity of the lease is up to 26.08.2021 and accordingly the mine will be operative for next 3 years. He stated that the mine is certified with ISO standards. The project cost of the proposed expansion proposal will be Rs. 37.08 crores. He mentioned that presently wet drilling with dust extraction system, controlled blasting, water sprinkling on haul road through mobile water tankers, dry fog system at screening & crushing plant, tarpaulin cover of transporting vehicles, use of road grader to maintain the internal roads are being carried out to control the air pollution. Regular maintenance of the mine machineries inside own workshop, provision of PPEs to the workers and plantation were undertaken to control the noise level. He also explained that how the waste dumps are stabilized through slope terracing followed by grass seeding & plantation along with construction of retaining wall. During enhancement phase, the generated waste will be utilized for pit back filling. Generated surface runoff from the mine are being channelized to the rain water harvesting pond through series of garland drains, the waste water generated from the workshop is treated in ETP & the treated water is reused. He also informed that the mining activity will not intersect the ground water level. They have undertaken plantation over an area of 9.455 Ha inside the ML area. A nursery has also been developed within the lease area for plantation purpose. He further stated that, company has provided direct and indirect employment to the local people. The company has also undertaken various peripheral development works, health care facilities, educational facilities etc. They have undertaken many welfare activities through Aditya Birla Jana Seva Trust such as imparting vocational training, free distribution of saplings, training programs to SHGs, solar street light facility, drinking water facility, provision of school bus, additional teachers at village schools, scholarship to students, free ambulance service, awareness program on health issues, agricultural facilities including distribution of power tiller & tractor, establishment of rice huller, development of road infrastructure, construction of community center and livelihood support. He has assured that, the company will also continue to undertake these activities during enhancement of production. At the end, he has appealed to the public to render their support for the proposed enhancement for local benefit, employment and socio economic development of the area.
