

PROCEEDINGS OF THE PUBLIC HEARING MEETING HELD ON 26.10.2018 (AT 10.00 AM) IN DANAGADI BHAWAN FOR ENVIRONMENTAL CLEARANCE IN RESPECT OF M/S. JAJPUR CEMENT PRIVATE LIMITED FOR ESTABLISHMENT OF 1.50 MILLIONTPA CEMENT GRINDING UNIT AT KALINGANAGAR INDUSTRIAL COMPLEX, TEHSIL DANAGADI IN THE DISTRICT OF JAJPUR, ODISHA

The public hearing in respect of the project proposed by M/s. Jajpur Cement Private Limited for establishment of 1.5 Million TPA capacity Cement grinding unit was held on scheduled date & time in Danagadi Bhawan in the district of Jajpur with reference to:

- I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006
- II. Interim Operational Guidelines till 13th September 2007 in respect of applications made under EIA-1994

The Panel consisted of the following members:

Sri Santosh Kumar Mishra, Additional District Magistrate, Kalinganagar, supervised & presided over the public hearing process and assisted by Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by M/s. Jajpur Cement Private Limited.

Welcoming the public, Sri S.K. Mishra, Additional District Magistrate, Kalinganagar explained that the views, comments, objections and opinions of the

public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Sri Mitu Behera, Representative of M/s. Jajpur Cement Private Limited addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, afforestation programme and various other peripheral developement activities envisaged in the proposed project.

Then Sri Mishra, ADM, Kalinganagar, requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

1. Sri Duryodhan Behera, Kendudihi, Mantira

He expressed his support to the proposed 1.5 Million TPA Cement Grinding project of M/s Jajpur Cement Private Limited and asked the company to provide education, drinking water and health facility and take step for pollution control in the area.

2. Sri Pritam Kumar Ray, Trijanga

Welcoming the panel He expressed his support to the proposed 1.5 Million TPA Cement Grinding project of M/s Jajpur Cement Private Limited. He demanded education, health facility and steps towards Environmental pollution control in the area. Further he said that the local area will be developed by the proposed project.

3. Sri Madhabananda Behera, Chandia

Expressed his support to the proposed cement grinding project and urged the company to provide local employment, education, health and transport facility.

4. Akash Samal, Jakhapura

Supporting the proposed project, he urged the company to provide local employment, education, health facility and take up plantation activity in the area. Further he expressed his pleasure for the proposed project in Kalinganagar area.

5. Sri Kalmes Seth, Jakhapura

Welcoming the gathering, he expressed his displeasure on local employment and other facilities by the existing plants established in the area. He also told that He is supporting the project but showed his concern on non appointment of local people in the existing plants in Kalinganagar Industrial area.

6. Sri Krushna Chandra Pal, Dakharapada

He welcomed the panel and expressed his support for the proposed project and requested the company to provide local employment and take care for protection of environment in the area.

7. Sri Urnesh Chandra Khillar, Rabana

Welcoming the panel and gathering he told that he is supporting the project and requested to provide health facility & steps may be taken first to protect the environment. He also urged the company authority to take plantation activity first before starting of the project.

8. Sri Alok Kumar Sia, Jakhapura

Welcoming the panel and gathering, he told that unemployment issue is not resolved in the area by the previous plants established in Kalinganagar area but is reduced by 50%. People are hopeful of getting employment and development of roads and transport facility in the area by establishment of the new plant. He urged the company authority to give commitment in written that steps shall be taken to prevent unemployment and keep the area pollution free. He also told that skin disease may appear due to air pollution and asked the company to take up plantation activity and keep the area free from pollution.

9. Sri Bidyadhar Patra, Dasmania, Mantira

He told that no employment has been given and no steps have been taken for prevention of pollution in the area. He further asked the administration to take step for betterment of health and environment in the area.

10. Sri Abhisek Samal, Jakhapura

He welcomed the panel & gathering and thanked the public. Supporting the project he requested the company to give commitment in written that local employment shall be given and unemployed people shall be supported in the area.

11. Sri Dillip Kumar Parida, Kendudihi

Welcoming the panel and gathering, he expressed his happiness for the proposed project. He told that the area and people will get benifited by

industrialization. He supported the project but urged the company for support in education, health and peripheral development activity.

12. Sri Ashok Kumar Das, Danagadi

He opposed the project and told that they are being neglected and companies are coming and giving commitment and not fulfilling their commitment.

13. Sri Subrat Kumar Sing, Mantira

Supporting the project requested the project proponent to develop a thick forest so that the local area will get benefit. He further requested for rehabilitation of people of affected area.

14. Sri Pradeep Kumar Sahoo, Rabana

Welcoming public he welcomed the project and asked the people if they have benefitted from the existing plants. He expressed his support for the project but showed his concern on not getting local employment, water supply, drinking water and asked the company to provide those facilities.

15. Sri Gourishankar Biswal, Jakhapura

Welcoming the panel and gathering, he thanked the media for getting information on the proposed project. He urged the people to support the project.

16. Sri Pragyan Ranjan Behera, Chandia

Expressing his support for the proposed project, he asked the company to take step for pollution control and local employment in the area.

17. Sri Biswajit Nayak, Jakhapura

Welcoming the panel and gathering, he welcomed the project and urged people to support the project as other existing plants are already established in the area. He further showed his displeasure on not getting a solution on his repeated request for road from Jindal plant to visa plant and visa to military chowk and thereby facing regular issue due to bad condition of above roads. He further expressed his pleasure on the estimated budget for the CSR activity as mentioned in the executive summary and requested the company to give commitment in written to follow the same. He further asked the administration to come up with a solution for common corridor road from Jindal plant to Visa Plant and Visa Plant to Military chowk.

18. Sri Parmanand Sethy, Sukinda road

Welcoming the panel and gathering, he expressed his support for the proposed project and told that there is issue of unemployment and pollution in the area. He requested the authority to come up with a plan to prevent

pollution and unemployment in the area. He asked for more plantation, local employment, and betterment of road & health facility in the area. He demanded 90% unskilled, 60% skilled and 30% high skilled employment to the local people for development in the area. Further he expressed his displeasure on police verification process for Jajpur district people before appointment in the kalinganagar area and asked to remove it.

19. Sri Pradeep Kumar Behera, Natimira chandia

Welcoming the panel, he told that he is unemployed for the last 3 years even after completing graduation as the industry in the area is asking for experience certificate. He urged the company to give employment and training so that they can perform the job.

20. Sri Sudhanshu Sekhar Behera, Chandia

He welcomed the project and asked for local employment for the nearby villages.

21. Sri Nabaghana Majhi, Rabana

Welcoming the panel and gathering, he expressed his concern in not getting a job in the established industry in the kalinganagar area and expressed his hope if he can get it in the proposed project.

22. Sri Chandan Deo, Kacherigaon, Tangarsahi

He told that, he came to know about the public hearing on the proposed project through Newspaper. He requested for local employment in the proposed plant.

23. Sri Sudhanshu Sekhar Bhanja, Danagadi

Welcoming the panel & gathering, he welcomed the project and requested the district administration to ensure that all the agreement made between the government and company to be followed properly.

24. Sri Kishore Jena, Jajpur Town

He told that priority is to be given for local employment and they are hopeful of getting other local facility from Jajpur Cement Private Limited.

25. Smt. Jayanti Jena, Dhabalgiri

Welcoming the panel & gathering, she welcomed the Jajpur Cement Project. She urged the local people to be self aware for their development. She further expressed her concern for employment of local people in non executive posts and outsiders in the executive posts. She expressed her views that conducting the meeting at the proposed site could have been better. She

expressed her support and asked the administration to look into the matter for fulfilling of demand of local people in the area.

26. Sri Bidyadhar Mohanty, Jajpur Road

Welcoming the panel & gathering, he explained his pleasure that the company is using the name Jajpur Cement i.e. the district name. He expressed his concern on issues like involvement of Jharkhand area vehicle and people in local business, removal of local employee in the plants of Kalinganagar area. He told people about the agreement made between the State Government and the company to be followed by the company and asked the public to get information through RTI and file complain if they come across any and the district administration shall take necessary action.

The Panel has received 99 nos. of written representations during the hearing which are enclosed herewith in original those have been annexed. Sri Santosh Kumar Mishra, ADM, Kalinganagar asked the project proponent to present their comments to the people with respect to the demands raised by the public in the public hearing meeting. Sri Mitu Behera, Representative of M/s. Jajpur Cement Private Limited made the commitment on issued raised by the public. The statement of issues and concern of the public with comments of the applicant prepared in odia and English language and annexed separately. The meeting was ended with thanks to the chair.
