PROCEEDINGS OF THE PUBLIC HEARING MEETING HELD ON 14.11.2018 (AT 1.00 PM) IN DANAGADI BHAWAN FOR ENVIRONMENTAL CLEARANCE IN RESPECT OF M/S JINDAL STAINLESS LIMITED, JAJPUR FOR THE PROPOSED ESPANSION OF CRUDE STAINLESS STEEL PRODUCTION FROM 0.8 MTPA TO 2.2 MTPA AND COLD ROLLING MILL FROM 0.8 MTPA TO 1.6 MTPA AT KALINGANAGAR INDUSTRIAL COMPLEX, TEHSIL- DANAGADI IN THE DISTRICT OF JAJPUR, ODISHA

The public hearing in respect of the expansion project proposed by M/s Jindal Stainless Limited, Jajpur for expansion of Crude Stainless Steel production from 0.8 Mtpa to 2.2 Mtpa and Cold Rolling Mill from 0.8 Mtpa to 1.6 Mtpa was held on scheduled date & time in Danagadi Bhawan in the district of Jajpur with reference to:

Sri Santosh Kumar Mishra, Additional District Magistrate, Kalinganagar, supervised & presided over the public hearing process and assisted by Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by M/s. Jindal Stainless Limited.

Welcoming the public, Sri S.K. Mishra, Additional District Magistrate, Kalinganagar explained that the views, comments, objections and opinions of the
