PROCEEDINGS OF THE PUBLIC HEARING MEETING HELD ON 09.11.2018 (AT 10.00 AM) IN SUKINDA BHAWAN FOR ENVIRONMENTAL CLEARANCE IN RESPECT OF M/S. BALASORE ALLOYS LIMITED FOR EXPANSION OF FERRO ALLOYS PLANT [FERRO CHROME FROM 15, 600 TPA TO 91, 374 TPA); ALONG WITH ZIGGING PLANT (20 TPH), BRIQUETTING PLANT (35 TPH) AND INSTALLATION OF CHROME ORE BENEFICIATION PLANT (1, 98, 000 TPA)] AT NIZIGARH, TEHSIL - SUKINDA IN JAJPUR DISTRICT, ODISHA

The public hearing in respect of the aforementioned proposed expansion and establishment of project by M/s. Balasore Alloys Limited was held on scheduled date & time in Sukinda Bhawan in the district of Jajpur with reference to:

- I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006
- II. Interim Operational Guidelines till 13th September 2007 in respect of applications made under EIA-1994

The Panel consisted of the following members:

- 1. Sri Mihir Prasad Mohanty, Additional District Magistrate, Jajpur
- Sri Manmohan Murmu, Assistant Environmental Engineer (AEE), Regional Office, State Pollution Control Board, Odisha, Kalinganagar.

Sri Mihir Prasad Mohanty, Additional District Magistrate, Jajpur supervised & presided over the public hearing process with assistance of Sri Manmohan Murmu, AEE, Regional Office, State Pollution Control Board, Kalinganagar, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, Sri Manmohan Murmu, AEE, State Pollution Control Board, Odisha, Kalinganagar welcoming the participants of the public hearing meeting, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by M/s. Balasore Alloys Limited.

Welcoming the public, Sri Mihir Prasad Mohanty, Additional District Magistrate, Jajpur explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public gathered in the Page 1 of 11

meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Sri Basanta Kumar Parida, DGM (Corporate Affairs) of M/s. Balasore Alloys Limited addressed the committee members and assembled public and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, afforestation programme and various other peripheral developmental activities envisaged in the proposed project.

Then Sri Mohanty, ADM, Jajpur requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

1. Sri Amalendu Behura, Sukinda

Sri Behera greeted the panel and the public. He welcomed the project proposal by the industry. He emphasized that the project expansion and establishment will definitely help local people employment. He demanded the company to provide water supply and take step for improvement of Roads in the local area. He expressed his support for the project

2. Sri Rai Charan Mohanty, Sukinda

Sri Mohanty urged the industry to take necessary action towards local people employment opportunity. In addition to employment opportunity to the local people he emphasized the environment safeguard of the locality by the project proponent. He expressed his happiness and supported the project and asked the company to take step for development of Sukinda area.

3. Smt. Swapna Behera, Sukinda

Greeting the panel Smt. Behera said that the industry should employ local people on priority and qualification basis. She told that Balasore Alloys is the only industry in the Sukinda Gram Panchayat area and she is not opposing the proposed expansion project. Further she demanded employment, road improvement, water supply and initiative for education of the under privileged students of the project affected area

4. Sk. Jahangir Khan, Sukinda

Sk. Jahangir at first greeted the panel of the public hearing and the public gathered there. He requested the project proponent to arrange light facility to the graveyard adjacent to the plant boundary, concrete the kachha roads of Sukinda Gram Panchayat, sprinkle water on roads etc. He further told that people have high hope from the expansion project.

5. Sri Ranjit Kumar Behura, Sukinda

Sri Behura welcomed the project expansion and establishment. He told that local people have been employed in Balasore Alloy Plant and urged the company to supply drinking water and take up development activity of Sukinda Community Health Centre. He further told that they are supporting the expansion project and company should take step for development in the Sukinda area.

6. Sri Bibekananda Bose, Sukinda

Sri Bose welcomed the project and expressed his support for expansion and establishment proposal of M/s Balasore Alloys Limited. He requested the panel to direct the project proponent to take step for local employment & environment pollution control in the area.

7. Sri Ganeswara Acharya, Sukinda

Sri Acharya welcomed the project. He expressed his preparedness of tolerating and digesting the pollution to be caused by the project in expense of development in his locality. He informed the public that M/s Balasore Alloys Limited is the only production unit established in the area. He further said that he is not opposing the proposal but demanded employment of the unskilled people of the area. He expressed his support for the proposed expansion project and the project proponent shall follow take and give policy.

8. Sri Chakradhar Mallick, Sukinda

Welcoming the panel, dignitaries and the public he expressed his thankfulness for getting opportunity to speak in the public hearing meeting. He suggested the employment to be made on the basis of education qualification and warned future agitation if deviation happens. He also expressed his concerned on local public getting affected by the project. He enquired and

9. Sri Swayamjit Das Samanta, Baradi

Welcomed the panel and gathering. He welcomed the project and demanded development like education and communication. He further said that Sukinda people are facing health issues like kidney diseases etc. He supported the project based on the fulfillment of demands of public by the project proponent.

10. Sri Jigyansu Sahoo, Sukinda

Sri Sahoo expressed his concern unemployment in the area and said that M/s Balasore Alloys has taken steps for development in the area. He demanded employment, water supply, plantation etc to be taken up by the project proponent. He supported the expansion proposal. He also submitted a written representation to the panel.

11. Sri Amiya Das Samanta, Baradi

Sri Samanta welcomed the panel and public gathered in public hearing. He informed the gathering that M/s Balasore Alloys Limited is the only plant established in the Sukinda area. He expressed his happiness that local people are employed in M/s Balasore Alloys Limited. He requested the company to take step for improvement of communication and health care facility in the area. He supported the project proposal.

12. Sri Jagat Mohan Behura, Sukinda

He welcomed the gathering. He expressed inaction of the concerned department although complaint regarding encroachment of forest land by the industry has been made several time. He warned that if no action is taken against the industry he will not hesitate to agitate against the company in future. He enquired the reality of local people employment in M/s Balasore Alloys Limited. He further informed that the unit is deliberately discharging the wastewater to the nearby water bodies and suggested to look into the matter for compliance.

13. Sri Bimalendu Behura, Sukinda

Sri Behura welcomed and supported the project proposal. He informed that about 500 people are getting benefit directly or indirectly form the existing unit of Balasore Alloys Limited and 70 - 80% of them are local people. He said that by such expansion by the industry more people will get employment

Further expressed that people are getting affected by dust from mines and industries and requested the project to give priority on health, education, communication and environment safeguard in Sukinda area. However, he asked the company to come with more such expansion proposal in future and at last he expressed his support to the proposal with a demand to employment opportunity to the local educated people.

14. Sri Swadhin Das, Sukinda

Sri Das supported the project proposal and submitted his written representation.

15. Sri Santosh Kumar Puhan, Jamupasi

Sri Puhan said it is true that M/s Balasore Alloys Limited is established at Nizigarh under Sukindagard Panchayat. But it is also true that Ampolaba Gram Panchayat starts at 500 m away from the plant site and M/s Balasore Alloys Limited is annexed to Ampolaba Panchayat. He opined that the emission from the plant will affect the nearby Panchayat also. He suggested development activity by the industry should also be extended to Ampolaba Panchayat. Finally he supported the project proposal.

16. Sri Satyajit Dash, Sukinda

Sri Dash expressed his support for the upcoming project proposal by the industry. He demanded the peripheral development to be made to the extent of 10 km radius from the project site.

17. Sri Nimalendu Behura, Sukinda

Sri Behura supported the project establishment and expansion. He suggested the industry to adopt CHC Sukinda for better health facility of the local people.

18. Sri Biswanath Patra, Mulakhamba, Sukinda

Sri Patra welcomed and supported the project establishment and expansion proposal. He expressed his concern of pollution. He suggested the project proponent to come up with a solution for control of pollution in consultation with the local people. He informed that unemployment in the area is a major issue. So employment should be given to the local people for development of the area.

Sri Mohanta demanded to include Lembo Gram Panchayat under development activity by the project proponent. He supported the proposal and demanded local employment. He further demanded drinking water to be supplied free of cost to the local people.

21. Sri Prakash Chandra Behera, Sukinda

Sri Behura welcomed the panel and the gathering expressing his support for the proposal. He said that they are facing dust nuisance in the area. He further said that transportation, education facilities are in neglected condition in their village. He demanded to provide developmental activity to his village and the surrounding area. He suggested the project proponent to provide ambulance service and take adequate control measures for dust pollution. He emphasized employment to be offered on qualification and as per the requirement of the company.

22. Sk. Ajam, Sukinda

Sk. Ajam told the gathering and the panel that he supported the established industry by giving his land to the company for construction of approach road. He expressed his concern of local people facing dust issues and skin disease along with kidney ailment of the local people. The industry has not fulfilled the earlier commitment towards his employment till date. He demanded medical and electricity facility to the local people. He express that few local people have been employed by the industry and demanded for more employment.

23. Sri Sukadev Das, Singadia

Sri Das said that the area is facing water scarcity during summer and asked the company to provided drinking water facility. He demanded to employment opportunity to Lembo Gram Panchayat people in the proposed expansion project.

Sri Mohanta welcoming the panel and the gathering expressed his support for the project expansion and establishment of new unit.
