PROCEFDING OF THE PUBLIC HEARING HELD ON 03.01.2019 AT 10.30 AM AT KUNDREN PLAY GROUND OF VILLAGE SIARMAL OF HEMGIR TAHASIL OF SUNDARGARH DISTRICT ODISHA FOR SIARMAL OPEN CAST PROJECT OF COAL PRODUCTION CAPACITY 40.00 MTPA AND PEAK 50.00 MTPA OVER AN AREA OF 2290.450 HA. OF M/S MAHANADI COALFIELDS LIMITED. BASUNDHARA AREA, HEMGIR TAHASIL OF SUNDARGARH DISTRICT.

As scheduled, the public hearing for Siarmal Opencast Project of coal production capacity 40.00 MTPA and peak 50.00 MTPA over an area of 2290.450 Ha. of M/s Mahanadi Coalfields Limited in Basundhara Area, Hemgir, Sundargarh was conducted at Kundren Playground, Siarmal village, Hemgir, Sundargarh on 03.01.2019 at 10.30 AM. Shri Bhaskar Chandra Turuk, OAS (S), Additional District Magistrate, Sundargarh supervised and presided over the Public Hearing Process, assisted by Sri Niranjan Mallick, Regional Officer, State Pollution Control Board, Jharsuguda, The State Pollution Control Board, Odisha, Bhubaneswar had advertised in Odia daily - The Dharitri on 01.12.2018 and in English daily-The New Indian Express on 01.12.2018. The Public Hearing in respect of the above project stated as per the schedule and the venue decided by the District Magistrate in accordance with the EIA Notification S.O.1533(E) dated 14.09.2006. The officers of MCL and people representatives i.e Sarpanch of Gopalpur Gram Pranchayat, Tumulia Gram Pranchayat, Balinga Gram Pranchayat, Kiripsira Gram Pranchayat, & Sumura Gram Pranchayat, Chairman, Hemgir Block and public of nearby villages were present. The attendance sheet of the members present in the public hearing is annexed as Annexure - I and the attendance sheet of the members delivered their views is annexed as Annexure - II.

At the outset of the meeting, Regional Officer, State Pollution Control Board. Jharsuguda welcomed the panel member, the assembled public and the media. The Regional Officer briefly explained the objective of the proposed coal mining project and procedure followed for conducting such public meeting as per EIA notification No. S.O. 1533 (E) dated 14.09.2006 of the Ministry of Environment & Forests and Climate Change (MoEF&CC), Govt. of India.

ADM, Sundargarh, welcomed the Regional Officer, SPCB, Jharsuguda and the villagers of Siarmal and the public of Gopalpur Gram Panchayat for the Public Hearing. He requested the public to maintain peace & come forward one by one to put their views/ opinion for the project. He invited the public to present their views about the proposed project on environmental consideration only.

Regional Officer, SPCB Jharsuguda advised the Project Proponent to make a brief presentation about the various aspects of the proposed project to be undertaken, for better understanding of the Public.

On behalf of the project proponent Sri Bijay Kumar Panda, Area Survey Officer, Basundhara Area, MCL gave a brief presentation about the proposed project. He also briefed about the peripheral developmental work to be taken up, rehabilitation of displaced families and environmental management practices to be adopted including

the pollution control measures.

The views expressed by various speakers present in the meeting are as follows:

Shri Rabiratna Patel, Siarmal Village: "Due to opening of these mines, so many problems have been solved. In this regards we are putting our demands in front of all. Non fulfillment of these demands may create problems for us, therefore you please fulfill these demands and we have no objection for opening of this mine. Now I am presenting our demands and all are requested to listen patiently.

We have placed the demands of displaced families of Siarmal Village before the General Manager, Basundhara Siarmal Area, MCL. We are the displaced families of Siarmal Village. The preliminary coal mining activities in Siarmal village has been started since 2012 but it is sorry to say that the compensation, employment & R&R benefits of so many villagers have not been properly completed till date. For this we have repeatedly approached MCL as well as Compensation Disbursement office and Hon'ble Claims Commission office but still the work is pending. For this we are submitting our demands and if our demands are not fulfilled we will not allow any mining work.

Compensation:

- Those who have not received compensation of land and house, payment should be made to them immediately.
- To pay compensation for the houses which have already been surveyed and compensation is still pending. It is pending for 48 houses.
- Immediate payment of Compensation to those who have already received patta on forest land.

Employment:

- To provide employment to all the eligible category I PAF (project affected family) immediately.
- Eligible persons of the village coming under category III should be provided employment at Siarmal OCP and written agreement is to be made for the same.
- Employment to be provided to boys and girls who have completed 18 years of age.
- Different categories unemployed boys and girls should be given preference for market complex and employment with the engaged private agencies.
- An agreement to be made for posting at Basundhara mining area for those gents and ladies who are undergoing training.

Rehabilitation & Re-settlement:

- New constructed house of Rs.14,50,000 to be provided to those who are interested to take newly constructed house.
- Those who are interested to construct house by themselves in their allotted plots, one time cash of Rs.15,00,000 to be given to them.
- Those who will not take constructed house & allotted plots, one time cash of Rs.21,00,000 to be given to them.
- Necessary steps may be taken to provide patta of Ac.0.10 dec. to the eligible interested families & patta to be issued at the time of plot allotment."

Tikeshwar Sa, Ratansara Village- "Today is Public Hearing, for the benefits of people this Siarmal Project, going to open for us. I am a part of this public hearing. myself Tikeswar Sa, village is Ratansara, Gopalpur Grampanchavat and Hemigr Block. Survey at our village was not done since long and now the survey work has been completed. The compensation roll is being prepared. We the villagers visited Claims commission office and saw that the work is going on. Our work was hampered due to delay and now the work is going on. I have full confidence that the work will be over soon. As we were not on the right path and therefore it has taken 34 years. Now why we all are present here, why ADM sir is present here, police & administration is present here and you all are present here? There is a rule of the government that without any public hearing no work will be done. Public hearing is to be organized for even small works. You all know that you should speak justice for justice and injustice for injustice. You people are saying to the Claims commission to provide employment. Without survey it is not possible. In our village so many quarrels are happening and uneducated and educated people are living. I offer my special thanks to Shri Mathais Oram of village Gopalpur region who has spent his own money by going to Delhi and fought for us and guided us by coming here in this respect. He went to Supreme court to fight against MCL and has won for us and was able to bring the order to complete the survey and compensate all the villages and provide employment by 2010. I request that our calculation of structures of our village be completed soon and necessary action may be taken for sprinkling of water on road to control dust. Categories for employment should be finalized at the earliest and employment should be provided at the earliest. I have no objection for opening of this mine by MCL."

Jadumani Das, Jhupurunga - "I am going to talk about my problems, I am not supporting this, so please keep quite. 06 years have been passed and hearing of Jhupurunga is going on and claims commission is to provide employment but MCL is not providing us employment."

Lokesh Dandsena, Ratansara – "If mines will run, it will bring impact on pollution. I request the persons on Dias to please explain what steps have been taken to control pollution."

Ujagar Baiga, Sarpanch Balinga – "Requested ADM to describe about the steps taken for pollution control. District administration and MCL authorities requested to take steps jointly for control of pollution."

Umesh Chandra Majhi, Balinga – "Respected ADM sir, I welcome the public hearing and opening of new mine."

Kumud Bandhu Padhan, Sarpanch Tumulia — "Our gram Panchayat is also affected but no copy has been provided to me. I have also told ADM sir in this regard. No letter in this regard has been provided by Pollution control board as well. Therefore I oppose this public hearing."

Susheel Nayak, Tumulia - "I oppose this public hearing."

Khemasheel Majhi, Sarpanch Gopalpur - "A gram sabha was conducted regarding this public hearing in Gopalpur panchayat office. A resolution was passed with full

consensus during the meeting and for the benefit of all I am presenting the same here.

A gram sabha meeting was held on 29.12.2018 at 11am under the chairmanship of Shri Khemasheel Majhi, Sarpanch Gopalpur, Hemgir Block. A brief lecture was deliberated by the Sarpanch about the Public Hearing going to be held on 03.01.2019 by MCL. The following decision was passed in the gram sabha after detailed discussion regarding Siarmal OCP to stop the public hearing:

- 1. Hon'ble Supreme court has passed order in the case of MCL Vs Mathais Oram on 10.07.2017 that "Issue directions to the Chairman and Managing Director of MCL and subsequently stop any illegal mining being undertaken by MCL on agricultural lands in any of the villages.
- a) The public hearing is to promote / propagate illegal mining as because in the villages coming under Siarmal OCP no patta have been issued on forest lands. employment, re-settlement and rehabilitation and approval has not been taken from the gram sabha under the Forest Right Act 2006 for handing over of forest land which will violate the Hon'ble Supreme court order.
- b) Hearing of the villages under Hon'ble Claims Commission for the affected villages coming under Siarmal OCP has not completed yet. No any data has been reflected for Ratansara Village in the EIA report Job no. 706124 Chapter VII Page-No. 12 Point no. 7.2 social impact, R&R Action plan (7.2.1). The status report of Ratansara Village is left blank and status report for Jhupurunga, Tumulia, Ratansara village has not been completed and there is no any report and R&R benefits.

From the above report it is not clear that how many families are going to be affected in the said project and it is unknown till date. Trying to open Siarmal OCP based on this incomplete report will be treated as illegal mining and contempt of Hon'ble Supreme court and therefore this public hearing is to be cancelled immediately.

- 2. Basundhara, Kulda, Garjanbahal OCP which are running under MCL Basundhara Area have violated the conditions stipulated in the CTE, CTO and the EC of the Pollution control board and severely affecting the life as well as property of the public by creating dust pollution in the coal transport roads and railway sidings. Pollution control board from Jharsuguda and Sambalpur are inspecting these mines from 2010 and issued show cause notices to MCL for violating the conditions stipulated but MCL has never tried to take any action to control the pollution as per the condition stipulated. Therefore the mines which are running earlier should obey the conditions and take major steps and after this public hearing should be held.
- 3. Gram Sabha will be held first and thereafter Public hearing should be conducted as these region is coming under 5th notified region and it has seen lapsed here.
- 4. There is provision under Forest Right protection act 2006 para -4(5) that the schedule tribe inhabitants and scheduled tribes who are cultivating and depending upon forest land should not be shifted forcefully anywhere. At present Patta for forest lands are yet to be received and enquiry in this respect has not been completed. Therefore this Public hearing is a pressure and torture to the scheduled tribe community and schedule caste people. Therefore it is passed in the gram sabha to cancel the public hearing.

It was decided to send the decision of the gram sabha for kind information and needful action to the Collector Sundargarh, ADM Sundargarh, Sub-Collector

Hence until all the processes are completed and obtaining necessary permission from Hon'ble Claims commission, this public hearing may be stopped."

Rajendra Kumar Naik, Ratanpur - "I am working on environment since many days and on the basis of that I want to present some data. Wherever the mines are opening, if it is specified that in how much area the mines will be operate then it will be possible to put our views. For example, a child is not born yet and the villagers are being asked if the child is beautiful or not, it is impossible. A child can be told beautiful or not only after birth. In such way, as the data provided to us is incomplete, it is not possible to put our views. This data has been prepared by MCL on Environmental Impact Assessment of Siarmal Opencast project. I am going to represent some data as provided in the report. Our demand is to cancel the public hearing as incomplete data has been provided in this report. Firstly, prior to me as my friend Sarpanch Tumulia told that if panchayat head quarter is to be shifted, and a panchayat is going to be rehabilitated by this project, then why no such report has been provided to him. Therefore it is required to cancel this public hearing. Kindly note it. As no proper information regarding public hearing was communicated to the public and specially to the public of Tumulia village where a large number of families are living there and this public hearing has been arranged without information to them, therefore this public hearing may be cancelled as it is against the rules.

It has been written in this report that there are 1089 displaced families in Gopalpur against which 492 have been employed and 136 is balance since 08 years. So many such type of data has been provided in this report.

It has been reflected in the report Job no. 706124 Chapter IV Page-No. 26, it has been reflected by MCL & CMPDI that how many families of Ratansara will be displaced due to this project. They have left the status blank in this report. The exsarpanch of Ratansara have said that it will be good if project is opened. What good will happen? You have left the report blank. If you had written that not a single family will be displaced we would have accepted the report. If you had written that 05 families will be displaced then we would have accepted. They have left this report blank. When the data will be filled in this report? After opening of this mines they will say that no family will be displaced. You are misleading the people & creating dispute by providing such type of data. This public hearing is fully incomplete. Please look into it again. Further, status of compensation, regarding payment of compensation given in Chapter no. 07 page no. 18. You have said in the report that for Jhupurunga, Tumulia, Ratansara village it has not been finalized. It has not been finalized yet that how much they should pay. You have mentioned in the report that Gopalpur village will be shifted to Sharangi jharia, but no process have been started yet. You have mentioned in the report that Siarmal village is to be shifted to Chhattenpali but no process have been started yet. In the past we have witnessed the opening of Kulda mines. Houses are situated within five meter distance of the kulda mines. It will be better to leave this place and conduct Public Hearing in the Kulda Mines. You will see the actual scenario there. As the mine is within 5 meter distance of the houses, there is a probability of felling down in the mines if child comes out from their houses. The same MCL is here. You please reply me the same process will be continued here and what guarantee is there that this will not repeat or happen here. Therefore it is saying

that the all these process are in incomplete, no proper information was given to the public, necessary Grama Sabha was not organized, therefore it is necessary to cancel this Public Hearing. Judgement has been issued by the Hon'ble Supreme Court on 10.07.2017 and there is an order that MCL will stop mining on agriculture land. If somebody is cultivating on forest land, mining work or any process will be started after issue patta. After handing over the forest land, public hearing is to be conducted and required to start process for mining work. As no pattas have been issued on forest land and mining work will be started after organizing public hearing, the scheduled tribe and tribal people depending on forest land will lose their right or not? If mining is started on forest cultivating land will be treated as illegal mining and contempt of Hon'ble Supreme Court. This Public Hearing is a proposal for snatching the cultivating land of schedule tribe and other tribal people. For this the public hearing should be cancelled.

Now come to the pollution matter, Regional Officer of pollution Board is here and he knows that I have lodged the maximum complaints to his office on matters related to environment and pollution. And the reason is pollution has increased so much and no one is caring. There are how many rules in pollution control, how many are being obeyed, how many times pollution control Board have inspected, how many times show cause notices have been issued to MCL, I have studied all these since last six months, and have released a ground truthing report on this. What is the ground reality related to pollution created by MCL in terms of coal transportation, coal siding and how much violation of rules is being done in large scale is mentioned in this book. It is also reflected in this book that in 2010 officers came from Jharsuguda for inspection and have seen that how pollution was done through coal transportation and no tarpaulin cover was there and accordingly directives issued to MCL for compliance of these violations have all been mentioned in this book for ground truthing. We have circulated this report to many places for necessary action but no action has been taken. Kulda mines which was started and is going to be closed but they are unable to control pollution. There are conditions stipulated by the pollution control board that wheels of outgoing coal loaded trucks should be cleaned before going to main road. I am not saying this, MCL has made agreement to implement this. You tell me, is there any system for wheel washing of trucks coming out to main road? If they are doing then who has accumulated 1 feet dust in front of police outpost? GM sir has done or other officers of MCL has done trip by trip. Even if this is being protested, and opposed by us in public hearing, whether they have cleaned the dust in Kulda? Have they developed any system for this? Not developed. Further, the coal trucks coming out should be covered by tarpaulin up till bottom. Are the tarpaulin covered? Not done. There is an agreement of MCL with Pollution control board that all roads in mines should be black topped or concrete. Has it been done? Not done. Where all it has not been concreted or black topped, dust suppression should be done by water spraying. Whenever mining work is done, facility of continuous water spraying should be there. Whether they have done so? No. Some sprinklers have been fitted in front of the mine for show up. That we also appreciate. But whatever is required to be done in large scale you have not taken care of. So this management is leading to mismanagement. Up to the destination wherever the coal is being transported, you have done agreement for sprinkling of water on road. Is water being sprayed? Sprinkling is being done at some road junctions. But they are not doing sprinkling on roads as per agreement. Why should we not oppose? There are such type of mismanagements. Vehicles going to railway sidings should go at a speed of 10 kms per hour as per agreement. Are they all moving at 10 kms speed anywhere? This is also being violated. After this coal will be transported from Siarmal OCP to Kanika railway siding. There is a requirement of construction of 3 mtr, wall in the

siding. The siding has been set up since many years but still the wall has not been constructed yet. There is an agreement with MCL for not releasing any coal dust water outside the siding, this has been violated. The land around siding of about 4 ac where paddy cultivation was done two times in a year has been accumulated with 5 ft dust. A pond of about 7-8ft deep was there has been accumulated with 4 ft dust on it. A show cause notice was issued for cleaning it by July 31st and it was flashed in Media as well. Has it been done by MCL? No it has not been done. Due to weakness of MCL the farmers in the 4-5 ac land nearby are unable to cultivate and who is MCL to destroy their rights. How much compensation has been paid by MCL? Show cause notice was issued and if required siding should have been closed. Anyway siding was not closed, mock was not removed, dust was not cleaned, land was not revived for cultivation and lastly no compensation was paid. Even after this MCL is opening so many mines one by one bravely. This is against the rules and that is why we are opposing the Public Hearing.

There is a provision for construction of 7 meter wall at Sardega Siding and Coal is required to be stacked within the 7 meter wall means 22 foot. If coal is stacked inside the wall, atleast dust will not spread to nearby villages.

Effect on Char, Mohul and kendu patra. Please note. People who are depending on Char, Mohul and Kendu for their livelihood are also affected. People are not able to collect Kendu Leaves from nearby places and their kedu leaves are not accepted by the Kendu leave Dept. People have been deprived for getting their benefit of thousands Rupees each. They have also been deprived for getting Rs 25000 to 35000 for education in engineering studies, Rs 25000 for marriage of their children. 10 wheeler truck is unable to be loaded due to shortage of kendu leaves. which affecting the livelihood and financial loss who will fulfill it. It is required to construct a wall of having height of 21 to 22 feet. Siding has already been started and if MCL wants there are so many contractors who could have constructed said wall immediately. But MCL does not wish to do so and that is why it has not been constructed. 3 meter wall at kanika siding could not be constructed, is there any scarcity of contractors in our area. If the work had been given to any of our brothers it would have been completed. MCL has an agreement for carrying out plantation of 15 meters width in kanika siding area. Has it been done? Not done? Whatever you have written, you are not following so why this public hearing is being conducted. I specially request all. So many discussions are going among the different global organizations regarding climate change is a great problem, Modi Govt. is also actively participating that climate will be severely change and world would be put into danger—I am doubting on this statement that it is true, as because Pollution Control Board and Ministry of Climate change are not taking any action against violation of these rules and agreements for pollution 'control. Amitabh Bachhan is spreading message in media that 10 lakhs people are dying every year due to pollution. Who is killing? Who is responsible? Pollution board is responsible and even ministry is responsible. We will die for pollution. We are eating coal, we are eating dust and MCL will gain thousand crores of rupees as profit. We are being killed and Government is giving the slogan for development. We will completely oppose it. We will not allow development by killing ourselves. That is why we are opposing. In presence of pollution control board effect of pollution is increasing day by day and world is in danger and you are responsible for killing people worldwide. It will happen one day all mankind will die due to pollution control board and MCL. No people of any religion, caste or project affected persons will die. People living in mine surroundings and those who are employed, their children will suffer someday due to pollution. We will not be the only sufferer. Those who gave lecture that it will be good, public hearing of Siarmal project should be conducted once again after obeying all these rules and where appropriate

people will come and give their opinions. All these illegal things are going on and due to this public hearing, pressure is increasing among the people as no rehabilitation, employment has been given and patta on forest land has not been issued and the people are being mentally tortured. Therefore you are requested that after completion of all these formalities, once again this public hearing may be conducted. You will have to give complete data that how much area will be acquired for Siarmal project, how many families of Ratansara village will be displaced and what type of facilities will be provided to them. This data should be completed and also provide all this data to the affected Tumulia gram panchayat thereafter this Public hearing may be conducted. Therefore this public hearing may be cancelled. Those people who will be violating in future, they can file 12 cases against me as and when required and we are agreeing for the same. You will also become a party, individual cases will be lodged by name who will try to open this project. We will make our future strategy and take action to serve notice against each and every one who will try to open this project. Therefore the public hearing may be cancelled."

Usha, Tumulia—"Whatever my brothers and sons said before is true. People who are here in big seats and giving big big lectures and if we would have been a part of your speech all the villagers of six villages would have been sitting here and heard your speeches. You people think about this my three generations have passed, my father in law, my husband and my son what we will do. I have told these things to everyone but no response has been received. Whatever my brothers and sons said before is true. We have not received any employment from claim commission as well as from MCL. Therefore this public hearing may be cancelled."

Surjokanti Patel, Tumulia, "I oppose this public hearing."

Sudharani Roudia, Chairman, Hemgir block- "I oppose this public hearing as because none of the villages have been displaced. I am telling this not one time but hundred times that I oppose this public hearing."

Damodhar Majhi, Ratansara - "MCL has acquired 15 villages and they have received compensation. The villagers of Gopalpur have received compensation for their land and homestead land. Those who are left, why they have not got employment and compensation? The first survey was completed in the year 2010 and why they are still deprived? For what reasons they have been deprived? Whoever got employment they have completed 9-10 years of service but for those who did not get employment, who will provide them the amount of salary for last 9 years? I am asking to MCL. They are doing this type of incomplete survey. The PAF list of Tumulia has also been published, whether compensation and employment for all the people have been published? It might not be there. You are going to displace 15 villages but you are going to give Kiripsira and Ratansara villages to a private company. Why have you imposed ban on the 15 villages? You have taken 13 villages and why you have two villages? Who will pay the compensation, answer me? There are scheduled tribe and tribal people in these 15 villages and they depend on the forest for their livelihood. You are saying to handover these forest lands, how can they do that. They will take our land, our homestead and forest land and we will not oppose it and there will be no need to organize this public hearing. I am supporting the forest right protection act and DLC also. Why the forest pattas are not being issued to the people? Clear all this first. Those who did not get employment may be provided with employment and those who did not get compensation may be paid so then only this public hearing be organized. Therefore I oppose this public hearing."

Mathais Oram, Gopalpur - "Here in this public hearing I am going to speak something. In May 1983, Central government had setup CMPDI camp at village Gopalpur for starting of Coal India and is still continuing here. 83, 84, 85, 86, 87, In 11.02.1987 Central government imposed 4(1) notification in Gopalpur area. Thereafter, on 27,05,1987, 11(1) notification was imposed. 9(1) notification was then imposed on 10.07.1989. 11(1) notification was imposed on 13.12.1990. In this way all the ban was imposed. On 23.02.1996, the then minister Shri Kishore Patel started the mines in Basundhara Area. That time we saw that rectification as reflected in the 4(1) notification was Rs 11000, 15000, 18000 thereafter calculating the interest was Rs 50000, 60000 and within Rupees 1 lakh per Acre land compensation was paid to Tiklipara, Bankibahal, Balinga and my village Gopalpur part Kulapara was released by MCL. In 1989-90 there was an estate manager of MCL management who acquired some of my land in Gopalpur after issue of notification. In 1999-2000 & 2001, the estate manager from MCL management, Shri Sanjeeb kr Patel cut my yadast and land. At that period I got some valuable time and filed a writ petition along with 12 persons against company in Hon'ble High court on 03.11.2003. Sanjeeb Kr Patel counter-filed against the writ petition on 06.12.2004 saving that the matter is unknown to me and may be known by Energy dept of Government of India. Thereafter I counter-filed against the ministry of energy, Government of India. After some days, ministry of energy counter-filed at the High court that the matter is unknown to me and Ministry of Coal may be knowing. Thereafter the coal minster himself came and counter filed that the notified area cannot be de-notified. The High court passed an order in my favour on 13.11.2006 to make compensation to Shri Mathias Oram and other persons with him within 06 months. But it is regretted that Shri Antarvami Behera, Estate Manager from the MCL management filed a writ petition against me at the Hon'ble Supreme court of India, New Delhi. This was a golden opportunity for me. Thereafter on 12 Jul 2007 while I was travelling in Kunal Bus in the night to counterfile at Delhi I thought that I have filed case for only 133 Acres of land then rest of the 14 villages will be left out. This was the golden opportunity. I did not ask any of the villagers of the 14 villages and asked the advocate Shri Upendra Kumar Samal, that this opportunity should not be left. I have the land details of all the villages along with the details of notifications, you please prepare an affidavit and I will sign it and send to Supreme court for counter-file. For 10 minutes the advocate did not speak anything to me. He then asked me whether you will file the case alone for all the villages? I said yes, this is a golden opportunity for the people of the area and I will do that. Thereafter, I mentioned all the villages and sent it to Supreme court. I did not go to any village and did not ask any knowledgeable person, and on my own gambled for the whole land of all villages. Thereafter on 13 May 2010 Supreme court passed an order to set up Claims Commission for Gopalpur, Tumulia & Balinga Gram panchayat of Hemgir block, Dist Sundargarh, Odisha. In 2010 the survey work was started in Gopalpur village and completed in 2012 and in 2014 the compensation was paid and employment was given. But it is a matter of regret that till now many people have not got employment and some people have not yet received compensation for want of succession certificate. All I want to say is that after setting up of Claims Commission there is a great change in this area. I am imagining that my land would not have been ever acquired by any company if I would not have brought the paper of counter-file lodged by the company where it was written that out of 32 Ha of land in Gopalpur village 268 Acres of land will be used for mining purpose and rest may be de-notified. In the same way all the land of revenue village Jhupurunga is lying pending for denotification. But the supreme court of India has passed an order to pay compensation. rehabilitation and give employment to all the notified villages. So I request the


