PROCEEDINGS OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT OF M/S. MEDIAID MARKETING SERVICES FOR DEVELOPMENT OF COMMON BIOMEDICAL WASTE TREATMENT AND DISPOSAL FACILITY AT ARAKHAPADA, PO. SHERAGADA IN GANJAM DISTRICT, HELD ON 26.02.2019 AT THE PLANT AREA OF M/S. MEDIAID MARKETING SERVICES OVER PLOT NO. 256, MOUZA ARAKHAPADA IN GANJAM DISTRICT, AT: 11.00 A.M

At the outset, Sri Mitrasen Majhi, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA notification, 2006 and the objectives of the public hearing. He stated that M/s Mediaid Marketing Services have proposed to have Environmental Impact Assessment for development of common biomedical waste treatment and disposal facility at Arakhapada, Po. Sheragada in Ganjam district and has applied to obtain Environmental Clearance from the Ministry of Environment, Forest and Climate Change, Government of India and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Odia Daily "The Sambad" dated 23.01.2019 and an English Daily "The Times of India" dated 23.01.2019 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report, Executive Summaries (Odia & English) and soft copy in the office of the Collector & Dist. Magistrate, Ganjam, Chatrapur, District Industries Centre(DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Chatrapur, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment, Govt of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing are made available to the Kumarpani Gram Panchayat and K. Karadakana Gram Panchayat, in the Dist. of Ganjam.

- Further announcements are also made through Mikes regarding Public Hearing for information of the public in the surrounding villages.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Administrative Officer, MKCG Medical College and Hospital, Berhampur, Ganjam, Sri Sudam Chandra Mandal, O.A.S (S) to kindly preside and supervise in the public hearing.

The Administrative Officer, MKCG Medical College and Hospital, Berhampur, Ganjam welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects only. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance from the Govt. of India. Then he asked the representatives of M/s Mediaid Marketing Services to brief about the project.

Sri Manoranjan Mishra, Representative of M/s. Mediaid Marketing Services presented the salient features of the project, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the project proponent to reduce the impact while executing the project in Odia language.

He concluded that a suitable Environmental Management Plan has been formulated and will be continuously upgraded to mitigate the impact on the different components of the environment such as Water, Air, Noise & Soil.

The Administrative Officer, MKCG Medical College and Hospital, Berhampur, Ganjam invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 50 persons were present in the public hearing meeting, only 39 nos. of persons signed in the attendance sheet, out of which 06 persons participated in the oral deliberation and signed in the oral deliberator's sheet. No written representations were received in the hearing. The attendance sheets, the Deliberator sheets and written representations are enclosed as **Annexure-I & Annexure-II** respectively.

The statements recorded are as follows.

#### 1. Sri P. Karesu Patra, Kumarapani

He addressed the chair and the gathering and stated that the Biomedical wastes usually pollute the environment. However such types of industries treat the Biomedical wastes and help the environment remain clean. He welcomed the project and said that in their village no any industries exist and establishment of such types of industries in their willage create lots of employment opportunity for the local youths.

## Sri Udayanath Pradhan, Barasingi

He addressed the chair and the audience gathered in the public hearing. He intimated that, being a representative of the Kumarapani Sarapanch, he welcomes the project and he expected that many unemployed in their village will get employment opportunity because of the industry.

#### 3. Sri Sudarsan Nayak, Sarapanch, Karadakana

He addressed the chair and other dignitaries along with the audience present in the hearing. He expressed his support for the industry and welcomed the project.

### 4. Sri Pitabas Pradhan, Kumarapani

He greeted the audience and the chair and stated that now a days Govt. is promoting the MSME industries. But everywhere it is not implemented and no MSME units exists in Sheragada area. But they feel very fortunate that this project has been established in their village, as a result the youths from their village need not go outside for jobs and at least some of the youths will get employment in the company. He prayed to lord Jagannath that the company runs well and thus he welcomed the project.

#### 5. Sri Keshab Pradhan, Kumarapani

He welcomed the chair and the audience and welcomed the company. He said that local development will occur and many people will get employment opportunity because of the company.

#### 6. Sri Rama Nayak, Barasingi

He welcomed the chair and the audience and showed his concern whether any problem may arise due to this project. Therefore, he suggested that the company should look into everyone's complaint and suggestions if any in the future. He showed his happiness & concluded by singing a song.
