PROCEEDINGS OF THE PUBLIC HEARING MEETING HELD ON 06.03.2019 (AT 10.00 AM) IN DANAGADI BHAWAN FOR ENVIRONMENTAL CLEARANCE IN RESPECT OF M/S. CHETTINAD CEMENT CORPORATION PRIVATE LIMITED FOR ESTABLISHMENT OF 2X1.0 MILLION TPA CAPACITY CEMENT GRINDING UNIT AT KALINGANAGAR INDUSTRIAL COMPLEX UNDER DANAGADI TEHSIL IN THE DISTRICT OF JAJPUR, ODISHA

The public hearing in respect of the project proposed by M/s. Chettinad Cement Corporation Private Limited for establishment of 2x1.0 Million TPA capacity Cement grinding unit was held on scheduled date & time in Danagadi Bhawan in the district of Jajpur with reference to the EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and Interim Operational Guidelines till 13th September 2007 in respect of applications made under EIA-1994. The Panel consisted of Sri Santosh Kumar Mishra, Additional District Magistrate, Kalinganagar, Jajpur and Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Odisha, Kalinganagar.

Sri Santosh Kumar Mishra, Additional District Magistrate, Kalinganagar, supervised & presided over the public hearing process and assisted by Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting the Regional Officer, State Pollution Control Board, Kalinganagar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by M/s. Chettinad Cement Corporation Private Limited.

Welcoming the public, Sri S.K. Mishra, Additional District Magistrate, Kalinganagar explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Sri Mitu Behera, representative of M/.s Chettinad Cement Corporation Private Limited addressed the committee members and assembled public and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, afforestation programme and various other peripheral developement activities envisaged in the proposed project.

Then Sri Mishra, ADM, Kalinganagar, requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

1. Sri Ashwini Dhal, Jakhapura,

He questioned on the location chosen to conduct the public hearing meeting instead of conducting at the project location. He requested the ADM to reject the public hearing. He further told that the company has expressed false information that no habitation exist in the surrounding, however around 5 tribal habitation and one natural nalah exist in the surrounding area. Further, he told that the company has not published the public hearing notice in local odia language violating the norms. He finally told that the hearing is illegal and should be rejected.

2. Sri Ram Chandra Palei, Jakhapura

Welcoming the panel, Sri Palei told that the Kalinganagar industrial area is developed for steel plant project and Proposed Cement plant is not having any merit to be established in the area. He further told that they favored for one steel plant but 13 plants have already been established in the area. He expressed his concern on non rehabilitation of the affected local people in the area. He opposed the proposed Cement Grinding Plant Project.

3. Sri Suresh Kumar Jena, Jakhapura

He expressed his unwillingness for the proposed Cement grinding project and asked to stop the public hearing meeting.

4. Sri Raj Kishore Panda, Jakhapura

Welcoming the gathering, he questioned on the proposed establishment of a Cement grinding project as people in the area are already suffering from dust pollution issue. He told that the public hearing should be conducted at the project site. Further people are facing many diseases due to pollution in the area, greenery in the area has been destroyed. He argued to develop greenbelt before establishment of the project. He also told that there is no point of establishment of the plant before rectification on issue of dust pollution and greenbelt development in the area. He further expressed his concern on the unemployed educated people in the area.

5. Sri Ramrai Lagori, Kachereigaon

He told that the nearby village area is facing issue of pollution and various diseases. He opposed the project.

6. Sri Pitamber Rout, Danagadi

He opposed the project and argued that the hearing to be conducted at the proposed project site.

7. Sri Ashok Kumar Das, Danagadi

Sri Das supported the project and asked the company to fulfill their demands.

8. Ms Lopamudra Naik, Chairman, Danagadi Block

Welcoming the panel, she opposed the project and expressed her view on Public hearing to be conducted at the project site. She told that cement plant is a polluting unit and till date the issue of some of the localized villages is not resolved. Further Companies are not fulfilling commitment and not employing local people. She asked the administration to stop the cement plant project.

9. Sri Kalandi Sethi, Jakhapura

He expressed his concern on establishment of another cement plant in the area. He asked to stop the project.

10. Sri Deepak Rout, Jakhapura

He expressed his concern that they are not getting any development activity/facility from the local industries. He asked to stop the cement plant project.

11. Sri Sudhanshu Shekhar Bhanja, Danagadi

Welcoming the panel & gathering, he informed the people that the project has come through the make in Odisha initiative. He requested the people to represent their issues like rehabilitation, development activity, education and health in proper way to the administration so that the same can be resolved. He further informed that the cement company has came forward by the initiative of the Hon'ble Chief Minister of Odisha through the make in Odisha programme and expressed his support for the project. Sri Das further told that He is not against industrialization but demand of the locals should be fulfilled. He finally requested the public to support the project and demanded local employment and CSR activity in the affected area.

12. Sri Chandan Mallick, Jakhapura

He objected the conduct of the hearing at the Danagadi Bhawan. He informed the public about the ill effect of the project and opposed the project. He asked to stop the public hearing as the hearing was not conducted at the proposed project site.

13. Sri Bidyadhar Mohanty, Jajpur Road

Welcoming the panel & gathering, Sri Mohanty informed that the company has come through the make in Odisha programme. Issues like rehabilitation should be resolved by discussing with the administration and people should not involve in law & order situation. He expressed his support for the project and requested that the opposition made against the project to be withdrawn.

He further informed that industrialization is a part of development and urged to support it. He advice the people not to oppose industrialization and asked the company to take up development activity in the area. He informed that waste material generated in the nearby plant will be used in the cement plant.

14. Sk. Sabir Husen, Kalinganagar

Welcoming the dais, he asked the company to discuss with the villagers in the nearby project area to resolve the local issues. He supported the project and asked to rehabilitate the people to be getting affected by the proposed project.

15. Sri Pitamber Mallick, Jakhapura

He opposed the project.

16. Sri Sumanjit Harichandan Singh, Jakhapura

He opposed the project.

17. Sri Hemanta Kumar Sahu, Jakhapura

He welcomed the panel & gathering and asked to conduct the hearing as per guideline. He told that he is not opposing the company but the cement grinding project. He intimated that he will support steel plant project but not the cement grinding unit is more polluting unit. He informed that already 3 cement grinding project has been approved. He asked to conduct hearing at the proposed project site. He finally informed the climatic impact of CO and CO2 in the environment. He opposed the project.

18. Sri Prashant Kumar Ray, Danagadi

Welcoming the panel & gathering, he informed that people have supported industries in the past and they are not opposing industrialization but expressed his concern on non fulfillment of commitment of employment and other facility in the area. He finally told that industry will prosper only with the collaboration of the local people and hoped that the industry will collaborate with the local people for the proposed cement plant project.

19. Sri Ramesh Chandra Sethy, Jakhapura

He informed that the public hearing is violating provisions of the guidelines. The people are supporting the make in Odisha initiative but asked to conduct the hearing at the project site. He informed that the atmosphere in the area will be polluted by cement plant. He finally opposed the project but told that they are in favor of Steel plant project but not the Cement plant project.

20. Sri Kailash Chandra Sahu, Jakhapura

He told that they are not going to allow the cement plant to be established in the area.

21. Sri Dinabandhu Das, Jakhapura

Welcoming the panel & gathering, he told that he is not supporting the project. He told that they will allow cement plant to be established only after rehabilitation of the affected people and resolving local issue of the local village.

22. Sri Kishore Jena, Jajpur Town

He expressed his concern on the development of the local area and people, further no specific plan has been made for employment of local people. He informed that Kalinga Nagar Industrial area is well known as the steel hub in the country. He asked the government to first judge the industry and then give permission for establishment.

23. Sk. Abid Raja, Danagadi

Welcomed the make in Odisha programme of the Hon'ble CM of Odisha. He further welcomed the project and asked the people to support it.

24. Sri Soumyadeep Pruthveeraj, Jakhapura

He welcomed the panel & gathering and told that they are opposing the project as rehabilitation of the nearby affected villages is not done till date.

25. Sri Prafulla Naik, Jajpur Road

He told that they are not in opposing of industrialization but expressed his concern on non development in the neaby village. Further, the public hearing should be conducted at the project site. He opposed the project and asked to shift the project to a different location in consultation of local people.

26. Sri Trilochan Jena, Danagadi

He informed that already so many plants have been established in the area. He supported the project.

27. Sri Bijay Kumar Das, Jakhapura

He raised the issue of rehabilitation of the nearby villages and told that industry should come after rehabilitation. Further, he informed that the project will be opposed if rehabilitation is not done before establishment of the project.

28. Sri Parmanand Sethy, Jajpur Road

Welcoming the panel & gathering, Sri Sethy told that they are not opposing industrialization but expressed his concern on the different issues faced by the local people. He further reminded that local employment is a major issue in the area. He intimated that he is not opposing the project but demanded development & employment of the local people. He finally thanked the gathering.

29. Ms Subhadra Mahanta, Jakhapura

She informed that demand for rehabilitation has been submitted several times but is not fruitful. Also she informed dust issue and various diseases that the local people are facing. She expressed her displeasure and informed that local people are only getting contractual employment through contractors. Finally she told that cement plant may be established in the area provided the demands for employment and rehabilitation are fulfilled.

30. Ms Malati Das, Jakhapura

She informed that they are not rehabilitated even after requesting several times to the administration. She requested the ADM to rehabilitate their villages.

31. Sri Jaladhar Khillar, Kubhorgodhi

Welcoming the gathering, he expressed his concern on engagement of local people only in temporary employment, nonpayment of salary in time etc. He further informed that waste water from the Plants in Kalinganagar industrial area is mixing with the village water source and causing death and health hazard in the area. He requested the District Administration to conduct Public hearing at the proposed site or to be ready to face opposing of the project.

32. Sri Sk Alauddin, Danagadi

He supported the proposed cement plant project of M/s Chettinad Cement Corporation Private Limited.

33. Ms Fulan Mohanta, Jakhapura

She expressed her grievance for not rehabilitate till date and told that they are facing issues of non employment in the area. She requested the District Administration to rehabilitate them.

34. Ms Malati Das, Jakhapura

She requested the District Administration to rehabilitate the affected villages.

35. Ms Jayanti Jena, Jajpur Road

Jan State St

She welcomed the gathering and told that locals have some demands and their demands should be fulfilled. She expressed her support for the proposed cement grinding project but asked the company to provide fundamental facility to the affected villages. She further requested the company to discuss with the locals and build the factory by taking the view of the people.

36. Sri Bijay Kumar Biswal, Danagadi

He expressed his hope that the company will take step for environmental pollution control, education and other developmental work in the area. He supported the project.

37. Sri Suresh kurti, Arasahi

He told that they will be affected by dust pollution by the cement plant. He requested the District Administration to rehabilitate them first and then give permission for establishment of the cement plant or else the project will be opposed by the local people.

38. Ms Rajani Das, Kudumisahi, Jakhapura

She requested to rehabilitate them and then establish the cement plant.

39. Sri Jahir Hasan, Danagadi

Sri Hasan welcomed the company and demanded Health water and Electricity facility in the local area.

40. Sri Pandav Badara, Tangarasahi

He expressed his concern on the local people not getting permanent employment in the plants of Kalinganagar Industrial area. He told that they will not support the project till they are not rehabilitated.

41. Sri Sourav Ranjan Nayak, Jakhapura


He supported the project.

He asked the District Administration to rehabilitate them first and then give permission to the industry.

45. Sri Sukanta Behera, Kacherigaon

He demanded rehabilitation of the affected villages and then establishment of the Cement grinding plant.

46. Sri Kanhu Charan Das, Trijanga

He supported the project of M/s Chettinad Cement Corporation Private Limited.

47. Sri Puspakanta Naik, Jakhapura

He opposed the project and requested the District Administration to conduct the hearing at Jakhapura.

Total 47 nos. of people out of the total people those who have registered their name for deliberation, delivered their views on the public hearing of the proposed cement grinding project of M/s Chettinad Cement Corporation Private Limited. Total 209 nos. of written representations have been received by the Panel during hearing and by the State Pollution Control Board, Regional Office, Kalinganagar prior to the hearing and those have been enclosed herewith in original. Sri Santosh Kumar Mishra, ADM, Kalinganagar asked the project proponent to present their comments to the people with respect to the demands raised by the public in the public hearing meeting.

Sri Mitu Behera, representative of M/s Chettinad Cement Corporation Private Limited made the comments on issued raised by the public. The statement of issues and concern of the public with comments of the applicant prepared in Engilish and Odia language and annexed separately.

The meeting was ended with thanks to the chair.
