

**PROCEEDINGS OF THE PUBLIC HEARING MEETING HELD ON 04.10.2019 (AT 10.00 AM) AT AMBATOTA, DEHUDISAHI OF VILLAGE PATNA, G.P. CHINGUDIPAL, DIST: JAJPUR FOR ENVIRONMENTAL CLEARANCE IN RESPECT OF ENHANCEMENT OF IRON ORE PRODUCTION CAPACITY FROM 3.0 MTPA TO 6.0 MTPA OVER LEASE AREA OF 1018.3085 HA. AT TALAPADA, REBANA RESERVE FOREST IN HARICHANDANPUR TEHSIL IN KEONJHAR DISTRICT AND DAITARI PROTECTED FOREST IN JAJPUR DISTRICT (FOR JAJPUR DISTRICT).**

The public hearing in respect of the proposed expansion project of Daitari Iron ore Mines of M/s Odisha Mining Corporation Limited, at Talapada, Rebana Reserve Forest in Harichandanpur Tehsil in Keonjhar District and Daitari Protected Forest in Jajpur District was held on scheduled date & time at Ambatota, Dehudisahi of Village Patna, G.P. Chingudipal, Dist: Jajpur with reference to:


- I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006
- II. Interim Operational Guidelines till 13<sup>th</sup> September 2007 in respect of applications made under EIA-1994

**The Panel consisted of the following members:**

Sri Santosh Kumar Mishra, Additional District Magistrate, Kalinganagar, supervised & presided over the public hearing process and assisted by Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar and the representatives of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, gave a brief introduction about the guidelines to be followed for the public hearing in the



light of EIA Notification, 2006 and interim operational guidelines till date, in respect of expansion project proposed by M/s Odisha Mining Corporation Limited.

Welcoming the public, Sri S.K. Mishra, Additional District Magistrate, Kalinganagar explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public.

On behalf of the Project Proponent, Sri Subrat Mishra, Regional Manager, Daitari Region of M/s Odisha Mining Corporation Limited addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed expansion project, environmental management, pollution control measures, waste management, afforestation programme and various other peripheral development activities envisaged in the proposed project.

Then Sri Mishra, ADM, Kalinganagar, requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

1. Sri Kuna Besra Bayer, Patna  
Welcoming the panel & gathering, he expressed his willingness towards the expansion proposal and hoped for engagement of local vehicles and employment of the local people in the expansion project of Daitari iron ore mines of M/s Odisha Mining Corporation Limited. He further requested for engagement of some local transporting vehicles, local employment and carry out the list of development works submitted through representation to the Regional Manager, OMC. Finally he supported the expansion proposal.

He supported the expansion proposal and demanded for fulfillment of written representation submitted to the chair.


57. Sri Sagar Mahakud, Patna



He thanked the public for expressing their views and supporting the expansion proposal of M/s OMC. He committed to certain issues raised by the public as follows:</p> <p>Sri Behera informed that about 1250 nos. of people will be employed out of which 350 nos. will get regular employment and 900 nos. will get contractual employment. About 6000 nos. of people will be benefited indirectly. He assured that employment will be given to local people as per requirement of the mine.</p> <p>He told that M/s Odisha Mining Corporation will take step to supply drinking water facility in the area.</p> <p>He told that peripheral development will be carried out in the local area. He further told that repairing and development work of the school shall be carried out.</p> <p>DMF should be used for local area development and M/s OMC shall request the district administration to utilize the DMF fund for development of local area surrounding the mine.</p> <p>M/s OMC will follow up with the school and mass education department if any proposal for establishment of a +2 college in the area has been initiated. Establishment of college is under the school and mass education department. M/s OMC shall request the Govt. and school &amp; mass education department for opening of a college in the area.</p> <p>He assured that SHG and local people will be given</p>



He assured that flora and fauna in the area will be conserved and protected.</p> <p>M/s OMC will support solar energy installation proposals. He informed that M/s OMC had imparted training on awareness on open defecation. ## NOTICE

It is brought to the notice of all concerned that M/s OMC Ltd. has proposed to have Environmental Assessment for Daitari Iron Ore Mines for enhancement of Iron ore production capacity from 3.0 MTPA to 6.0 MTPA over lease area of 1018.3085 Ha at village Talpada, Rebana Reserve Forest in Harichandanpur tehsil in Keonjhar district and Daitari Protected forest in Jajpur district (for Jajpur district) to obtain Environmental Clearance from the Ministry of Environment, Forest and climate change, Govt. of India. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.

By virtue of Ministry of Environment, Forests & Climate Change, Government of India Notification No. S.O. 1533 (E) Dtd. 14.09.2006, the Board has been authorized to conduct environmental public hearing and as such invites suggestions, views, comments and objections on matters relating to environmental aspects of the proposed project from all the persons including bonafide residents, environmental groups and others located at the proposed site/sites of displacement/sites likely to be affected. For the above purpose, a person will only mean:

- A. Any person who is likely to be affected by the grant of Environmental Clearance.
- B. Any person who owns his control over the project with respect to which an application has been submitted for environmental clearance.
- C. Any association of persons whether incorporated or likely to be affected by the project and / or functioning in the field of environment.
- D. Any local authority within any part of whose local limits is within the neighborhood, wherein the project is proposed to be located.

Persons as above who desire to submit their views, comments, objections etc. relevant to the project, may do so in writing within 30 days from the date of publication of this notice addressing the same to the Member Secretary, State Pollution Control Board, Odisha through Registered Post. Besides this, persons interested to submit their views relevant to the proposed project in writing or orally may also do so during the public hearing to be conducted on **04.10.2019 at 11.00 A.M. at Ambatota, Dehudisahi of village Patna, G.P - Chingudipal in Jajpur district.**
