PROCEEDINGS OF THE PUBLIC HEARING MEETING HELD ON 25.10.2019 (AT 9.00 AM) IN JCDL COMPLEX AT PANKAPAL, KALINGANAGAR, DIST: JAJPUR TO HAVE ENVIRONMENTAL ASSESSMENT FOR EXPANSION OF INTEGRATED STEEL PLANT OF M/S TATA STEEL LIMITED FROM 6 MTPA TO 8 MTPA OF CRUDE STEEL AND 9 MTPA FINISHED STEEL AT KALINGANAGAR INDUSTRIAL COMPLEX, DUBURI IN JAJPUR DISTRICT.

The public hearing in respect of the proposed expansion project of M/s Tata Steel Limited, at Kalinganagar Industrial Complex, Duburi in Jajpur District was held on scheduled date & time in JCDL Complex, at Pankapal, Kalinganagar, Dist: Jajpur with reference to:

- I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006
- II. Interim Operational Guidelines till 13th September 2007 in respect of applications made under EIA-1994

The Panel consisted of the following members:

Sri Santosh Kumar Mishra, Additional District Magistrate, Kalinganagar, supervised & presided over the public hearing process and assisted by Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar and the representatives of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of expansion project proposed by M/s Tata Steel Limited.

Welcoming the public, Sri S.K. Mishra, Additional District Magistrate, Kalinganagar explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public.



On behalf of the Project Proponent, Sri R. R. Satpathy, General Manager (Corporate Services) of M/s Tata Steel Limited addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed expansion project, environmental management, pollution control measures, waste management, afforestation programme and various other peripheral development activities envisaged in the proposed project.

Then Sri Mishra, ADM, Kalinganagar, requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

1. Sri Biswajit Nayak, Jakhapura
Welcoming the panel & gathering, he expressed that the second era of development to be started by the extension project of M/s. Tata Steel Ltd. He said that sukinda as well as kalinganagar will be more developed if the project comes and more development work will be carried out by TATA Steel Ltd. He expressed his willingness towards the expansion proposal and said that living style of local people has been improved because of TATA Steel. Rehabilitated people are also get benefitted. CSR & Many developmental works have been done in his village. He emphasized about the child labour & education. He said that People are getting quality health care through mobile medical facilities along with free of cost medicine. He demanded quality technical education for local & sukinda peoples with free of cost by the year 2020, so that their skill can be developed and they can easily get job.
2. Ms Laxmipriya Mohanta, Ramsulia
She said that old age education has been initiated by TATA steel Ltd for which old age peoples become literate. Apart from education TATA steel ltd provided different training programme like cleanliness drive, kitchen garden etc. They have done cleanness drive at roads, ponds, tube wells and other areas. Now she is working on kitchen garden by the training of TATA steel. She demanded If company provides them land it would be better for them and also suggested to include nearby villages in kitchen garden programme.
3. Sri Pradeep Ojha, Mandapada
He expressed his views through a poem and narrate that kalinganagar is a beautiful place and such opportunity will never come again to make a plant by M/s TATA steel. Huge investment is there and there will be no deficient of money for each of them. Health care facilities, Medical, Medical facilities & free medicine to local villagers, lift irrigation facilities, tube well construction, drinking water facilities to villages have been provided by TATA Steel Ltd. Plantation have been done by TATA steel to restrict air pollution. They are getting safety & respect because of TATA steel ltd and if the plant will safe they will be safe. Their business is rising day by day & living style is also much more improved because of TATA Steel Ltd.
4. Sri Sushanta Samal, Member of Jilla Parishada, Manitira.

Greeting to the panel & gathering, he expressed that the Kalinganagar becomes an industrial hub because of former chief minister late Sri Biju Pattnayak, whose dream about industrial complex in Kalinganagar. He requested to ADM & TATA Steel that one park should be provided for local people at duburi where the former cheif minister inaugurated the steel hub. He also suggested to provide a sports complex inside kalinganagar industrial area to enhance the ability of local boys as the local people give their land to the plant and at present they have no land with them to make a play ground. He also told that opportunity for contract of different works inside the plant should be facilitated to different people who have the ability and it should not be limited to few people. He told that the few people to whom the plant has given different contract works, have spent the money for unsocial activities should be black listed. At last he demanded to provide a park and a sports complex.

5. Ms Laxmipriya Mohanta, Ramsulia

Welcoming the panel, gathering & print media, He said that TATA steel have done more developmental works the area. The plant has provided education & drinking water facility in this area. TATA steel has done more works on environment. The plant also looks after to the local tribal peoples & their living standard has been changed because of TATA steel. Now tribal children will go to different schools & colleges for education. He expressed that if the plant will come then more development work will be carried out by the plant. At last he gave thanks to TATA steel and requested to the tribal peoples to attached with TATA steel for more development in future.

6. Ms Bhagya Laxmi Rout, Duburi

Welcoming the panel, gathering & print media, She said that TATA steel has made developmental work only in few panchayat so that all people are not get benefitted. All the panchayat should be included in the developmental work. Although Duburi & Bargadia panchayat is nearest to TATA steel but facilities has not been provided there. She suggested to provide a play ground in nearby area. She also told that free medical facilities should be provided to local people. Mobile medical van is not covering all the panchayat. She also told that a play ground should be provided & she also emphasized on permanent employment. She suggested that the labour colony should be far away from local habitation so that it will be safer for local girls & ladies. She told that training should be given to appropriate people so that they will be get benefitted and they can earn money. She said that TATA steel has done works including some SSG group and she requested to TATA steel authority to include all panchayat in the SSG group so that more people can be benefitted. She expressed that their expectation will higher when it comes to TATA steel ltd. At last she told that the few people to whom the plant has given different contract works, who have spent their money for unsocial activities should be black listed.

7. Ms Kausalya Patra, TATA Colony

Greeting to the panel & gathering, She said that TATA steel has provided them training for tailoring & paintning. If TATA steel will support them more, they will be advanced much more. She supported TATA steel and requested to give more man power to their SSG group.

8. Ms Manjulata Mohanta, Sulia



Greeting to the panel & gathering, She said that TATA steel has provided her training for cultivation of mushroom and provided a room for the purpose of mushroom firming in which she earned money. During cyclone "fani" the room provided by TATA is damaged and she requested to repair the room.

9. Ms Sanghamitra Roy, Sarpanch, Pankapal

Welcoming the panel & gathering, She said that mistake will not be repeated again and care should be taken to local people. She emphasized on health, education & employment. She requested to make more CSR activities in all the villages. At last she told that importance should be given on education, drinking water facility and local employment.

10. Sri Akshaya Singh, Manitira

Welcoming the panel & gathering, He told that they always support the plant and will extend their co operation in future. He demanded that some of the local people will not find employment which should be resolved.

11. Ms Sobha Nayak, Sukinda

She said, M/s. Tata Steel Ltd, Jamsedpur has given her quality education and training on sports and she also trained many students of her village. She expressed her gratitude to M/s. Tata Steel Ltd.

12. Sri Kalandi Sethy, Jakhapura

Welcoming the panel & gathering, He told that development has been done because of industries in kalinganagar area. He requested TATA steel authority to give more importance to the environment and to provide a beautiful park at abandoned area in Jakhapura village.

13. Ms Sambiti Mishra, Gobardhanpur

She said that environment & water is being polluted however TATA Steel Ltd is doing best efforts to mitigate these problems. Gobardhanpur Panchayat has come under the development area of M/s. Tata Steel Ltd. She said M/s. Tata Steel Ltd has provided them knowledge to use rain water in their daily water usage. She suggested to give training programme to local people to deal with skin diseases & other diseases. Every panchayat should be included in its peripheral development programme.

14. Ms Rasmita Hembram, Baghuapal

She said that there are many industries but only Tata Steel Ltd listen the views & problems of people. She said that over Tejaswini Programs conducted by TATA steel Ltd, in which the hidden talents of the women were developed & later they got employment in different plants of M/s. Tata Steel Ltd. The tribal people have developed their life style, education and can ride the Everest Mountain and it happened because of M/s. Tata Steel Ltd. She demanded not only displaced people but also all the areas should be developed and Baragadia and Duburi village should be included in the developmental work.

15. Sri Pritam Ku Ray, Danagadi

Welcoming the panel & gathering, He said that unemployment increases day by day. Local people are not getting employment in the plant, parks and cities are not developed by TATA

steel ltd like Jamsedpur. Skill harassment have been done to the local villagers. Mobile medical facilities have not been provided at Trijanga village. Health care facilities at TATA medica hospital is very much higher, so that ordinary people cannot afford. Now-a-days people are suffering from Heart, kidney and eye diseases in surrounding area of the plant. He stated that such type of development is not required. At last he told that he support to the expansion project subjected to employment of local villagers.

16. Ms Champabati Mahanta, Saliyanga
She said that TATA steel Ltd has made more developmental work in surrounding areas and she supported the project.
17. Ms Bhagabati Jena, Khurunthi
Welcoming the panel & gathering, She demanded that more employment should be given to local villagers.
18. Ms Arjyabala Singh, Asanabahali
She said employment should be provided to local youths
19. Ms Bebina Mallick, Baragadia
She said that she was given assurance to get job but till date it has not been done so far. If the matter was consider then she will be obliged to TATA steel.
20. Ms Nanika Jamuda, Gobaraghati, TATA Colony
She said that M/s. Tata Steel Ltd has taken many efforts for its peripheral development and will be continued in future. She welcomed the expansion project.
21. Ms Basanti Bediara, Sunsailo, TATA Colony
She said that she was selling country liquor(Handia) but now she get employed in TATA Steel and her living standard has changed.
22. Ms Swarnalata Dalai, Jagadhi
She told that she was associated with M/s. Tata Steel Ltd since 2016 and she is a mountaineer. Facilities and training has been provided by M/s TATA Steel Ltd, so that she was able to go south America and climb Everest mountain. It was happened due to TATA.
23. Ms Swarnalata Banara, Gobaraghati
Welcoming the panel & gathering, She told that TATA Steel provided better education facilities for small children. She welcomed the project and demanded more school and better education at displaced areas. Better Medical facilities should be provided to people. Displaced people must be given land Patta. The widows should be given employment opportunities.
24. Sri Babuli Purty, Gobaraghati
Welcoming the panel & gathering, He said the development should be made for local tribal people under Article 5 & 6 of Tribal Act. The tribal people must be given employment. He proposed for better education, communication and health facilities to the tribal people.

25. Ms Musi Nayak, Karadgadia
Welcoming the panel & gathering, She said, the women were given better training for livelihood creation. It was possible because of M/s. Tata Steel Ltd and it will be continue in future.
26. Sri Trilochan Mahanta, TATA Colony, Sansilo
Welcoming the panel & gathering, M/s. Tata Steel Ltd has developed the areas. Although 100% development have not been achieved, 60-70% development of the area is being developed by TATA Steel. The dropout students are going to school now. People do not go to Cuttack for health problem but are being treated in TATA Medica. He said the company will do more developmental work for people in future. He suggested providing a Hi-tech technical institute for better technical education & proper training should be provided to the youths.
27. Sri Surendra Kumar Haibru, Gadpur
Welcoming the panel & gathering, He said Air & water get polluted due to industry. Domestic animals affected by many diseases and could not survive. Nearby peoples are affected by skin, kidney and other diseases. He told that people are displaced without their knowledge. Agricultural field get damaged due to scarcity of water. Pollution control board will look after into the matter. He told that several complaints made to ADM regarding displacement but no result has been obtained so far.
28. Sri Binod Hembram, Bandhgan
Welcoming the panel & gathering, He told that TATA steel has done more developmental work in 48 villages since 2006. Drinking water, solar light, road communication, health care facilities have been provided. If the expansion project will come then more developmental work will be done and he supported the expansion. He suggested that pollution level of the plant should be minimised.
29. Sri Biswajit Ray, Baragadia
Welcoming the panel & gathering, He told that TATA steel has done more developmental work than other industries in kalinganagar area. He suggested to provide skill assessment training programme to local people of 48 panchayats of sukinda constituency.
30. Sri Dhruba Charan Mahanta, TUKU, Dholapathar
Welcoming the panel & gathering, He told that TATA steel has made his commitment. Plantation, Drinking water, road communication, health care facilities have been provided. He supported the expansion project and told that If the expansion project will come then more developmental work will be done.
31. Sri Birendra Jamuda, Trijanga
Welcoming the panel & gathering, He told that TATA steel has made more plantation in Kalinganagar as well as in Jajpur. He told that TATA has done more developmental work than other industries in kalinganagar area. He supported the expansion project and told that more employment will be generated if the expansion project will come. He also suggested that local people who were lose their land and houses will give more separate priority in employment.
32. Sri Biren Kumar Tudu, Bhitarmatika

Sri Tudu greeted the panel & gathering and thanked M/s Tata Steel to give opportunity to express his views in the public hearing meeting. He told that rehabilitated people have been benefited by all the facility but the surrounding area people are facing issue of dust and air pollution. He requested the panchayat members to submit representation to M/s Tata Steel for 10 to 15 % reservation in direct and indirect employment. He informed that earlier they were facing water scarcity in the area but the issue has been solved by M/s Tata Steel Limited. He again reminded Tta Steel to give employment to local people.

33. Sri Gyana Ranjan Sahu, Duburi
Welcoming the dais and gathering, Sri Sahu informed that local area has been developed by M/s Tata Steel. Local people have been engaged by direct and indirect employment, a local school i.e. Loyala School has been established by the company. He informed that local area will be developed by the expansion project. He urged people to support the expansion project of M/s Tata Steel.
34. Sri Sashibrata Swain, Duburi
Welcoming the gathering, Sri Swain expressed his support for the expansion project of Tata Steel Limited. He informed that the area will be affected by pollution, so Tata Steel is taking up plantation activity and other environment protective measures to protect the environment. He complaint that their names are not getting shortlisted in the name of police verification and requested to resolve the issue.
35. Sri Susanta Mallick, Sukinda
Welcoming the panel & gathering, He expressed his displeasure on the bad condition of Sukinda Duburi Road and Sukinda medical. He informed that they are facing issue of pollution and kidney affected disease in the area. He requested M/s Tata Steel Limited to fulfill the demand of public and then they will get support from the people. Further, he demanded employment to the local people. Finally he opposed the project.
36. Sri Susil Samal, Mantira
Sri Samal supported the project and requested widening of Brahmani chowk to Military chowk road.
37. Sri Subrat Kumar Singh, Mantira
He informed that M/s Tata Steel Limited is taking up CSR and development activity in the area. He urge public to support the company. He further informed that Tata Steel has established a shishu Mandir, develop classrooms in college in his village. He further requested local employment and opportunity to local contractors.
38. Sri Sudam Nayak, Golagaon
Sri Nayak greeted the panel and gathering and told that development activity has took place in the area. Industrialization will lead to development of local area and development of local area will further lead to development of the state. He urged people to support the expansion project of the company and demanded a stadium, transportation facility, health and education facility in the area. He expressed his support for the expansion project.

Welcoming the gathering, Sri Mallick expressed his support for the expansion project of M/s Tata Steel Limited. He demanded drinking water and healthcare facility in his village area.

44. Sri Juna Banara, Gobarghati

He demanded employment to the land losing people in the Kalinganagar Steel Plant project.

45. Sri Krupasindhu Samantray, Kumbhiragadia

Welcoming the dais and gathering, he supported the expansion project and requested to provide special package to the land losers in Kalinganagar steel plant project, removal of police verification for local people during employment

46. Sri Sini Soy, Gobarghati

She told that they are facing various due to establishment of Tat Steel plant. She further told that only people employed in the plant have benefitted but others are not getting any benefits from Tata Steel. She informed that many people who lost their land are yet to get any benefit from the company. She further told that they have lost cultivation, water is getting polluted and local people have died by kidney disease. She did not support the project.

She greeted the public and informed that people are facing air, water and soil pollution. They are getting dirty water from the borewell. She further informed that the medical facility provided by Tata Medica is very expensive.

48. Ms Draupadi Bahadur, Duburi

Welcoming the gathering, she has got training and support from Tata Steel Limited. She thanked Tata Steel for the support.

49. Sri Chakradhar Tamroy, Baghuapal

Greeting the dais and gathering, Sri Tamroy requested M/s Tata Steel to protect the environment. He further demanded employment and education facility and hoped for more development by the expansion project of M/s Tata Steel Limited.

50. Sri Biswaranjan Soren, Duburi

Welcoming the panel and gathering, Sri Soren expressed his grievance on differences in employment to local people as the local people are going through police verification process during employment. He complained that they are not getting drinking water supply, medical facility from M/s Tata steel Limited in his village. He further complained on high treatment cost and consultation fees at M/s Tata Medica Hospital, use of same road for transporting vehicles and local public etc. He urged M/s Tata Steel to provide medical facility, separate road, water supply and then only go for the expansion project.

55. Sri Pradeep Kumar Behera, Chandia

He greeted the dais and gathering and expressed his support on behalf of his village panchayat for the expansion project. He informed that the company has done many development work under CSR, however compared to development activity by M/s Tata Steel in Jamshedpur area, this area has not been developed. He demanded employment to local people and establishment of a stadium in the area.

56. Sri Ram Chandra Jamda, Baliapal

He told that, M/s Tata Steel has not planted trees as per requirement (33%) and local people are facing the issue of pollution by the plant. He opposed the project and informed that people will face further issue on pollution by the expansion proposal and complaint that

people outside the state are getting employment where as local people are not considered. He further informed that ground water level in his nearest villages have been depleted and they are facing drought issue and requested the administration to make enquiry and take suitable action to solve the issue.

57. Sri Gagan Behera, Golagaon

He informed that people in the surrounding area are facing kidney disease. He told that they are supporting industrialization but not environment pllution. He further informed that they are not getting water due to excess use of borewell water by the industries of Kalinganagar and the water is contaminated with iron dust. They are affecting by the flue gas emission from M/s Tata Steel. He told that earlier people from Golagaon had supported the Tata Steel Project but till now they have not benefited by the Tata steel project. People outside the state are getting employment but local people are not employed.

58. Sri Bikas Purty, Fuljhar

Expressing his happiness on the public hearing meeting, he requested to construct check dam in his village to help agriculture in the area.

59. Sri Narayan Hasdah, Baghuapal

He informed that local public have not benefited by the Tata Steel Plant. He informed that Tata Steel has not succeeded in fulfilling all the needs of the people in surrounding villages and requested cooperation from all other plants in the area. He urged the public to support the expansion project and requested M/s Tata Steel to take up further development activity in the area.

60. Ms Rukmani Laguri, Gobarghati

She informed that M/s Tata Steel has imparted training on tailoring, stationery and painting and which has helped her grow and earn for herself.

61. Ms Susama Sundi, Gobarghati

She thanked M/s Tata Steel for all the initiative taken by the company in her area.

62. Sri Narendra Mahanta, Mangalpur

Welcoming the dais and gathering, he informed the support provided by M/s Tata steel under CSR to the local people and supported the project.

63. Sri Satyabrata Das, Kumbhiragadia

He informed that they are associated with Tata steel for the last 10 years and Tata Steel has supported in all the Youth related programs for example in Mountain climbing. He thanked M/s Tata Steel Limited for providing the platform and supported the proposal.

He informed that local people came to know about CSR and periphery development only because of Tata Steel. He thanked M/s Tata Steel for providing drinking water supply, medicine, solar light and other periphery development activity.

He thanked M/s Tata Steel to provide bus service for transportation to Sukinda and providing support in Mountain climbing activity to local youth and carrying out other development work in the area. He supported the expansion proposal of M/s Tata Steel Limited.

He requested the project proponent to take protective measures during transportation of slag.

She greeted the gathering and told that they are getting benefitted by the Tata Steel Plant.
78. Ms Lina Samad, Sansilo, Sansailo
She supported the expansion project of M/s Tata Steel Limited.
79. Ms Tunji Patra, Sansailo
She informed that they have benefitted by the Tata Steel Plant project. She thanked Tata Steel and expressed her support for the expansion project.
80. Ms Priti Dungdung, Sansailo
She informed that they have benefitted by the Tata Steel Plant project. She supported the expansion project of M/s Tata Steel.

hence requested to install modern technology for dust and air pollution control in the area. He further stressed on conservation of ground water in the area.

Welcoming the gathering, he told that education and healthcare facility in the area has not developed. He demanded better education facility in the area.

87. Ms Diptimayee Mohanta, Rangitang
She informed various development activities taken by M/s Tata Steel Limited.

She informed that the company has supplied drinking water, established a club and old age education in her village and thanked for the support.
89. Ms Jamuna Patra, Tata Colony
She told that she is staying in Tata Colony. She expressed her support for the expansion project of M/s Tata Steel Limited.
90. Ms Saritamani Gogrei, Trijanga
She grieved that educational development has not taken place in the area. She further informed that Tata Steel has given training for self employment to local people and thanked for the initiatives of the company.
91. Ms Tikili Balai, Dakhinapasi, Dakhinapasi
Welcoming the gathering, she requested the project proponent to construct public toilet with water supply facility at market place of Duburi.
92. Ms Mamina Samal, Dakhinapasi
She welcomed the dais and gathering and informed that M/s Tata Steel had provided her training and she further cooperation from the company.
93. Ms Madhuri Bahadur, Baragadia
Welcoming the gathering, she informed that Tata Steel has given support for the training and demanded school and college in the area.
94. Sri Abhimanyu Mahanta, Gobarghati
He informed people that Tata Steel will do development activity as per their policy and local requirement. He reminded people of the Bhopal gas tragedy and demanded more plantation. He further requested the pollution control department to regularly test the emission and discharge quality of the industry and take necessary step for compliance.

95. Sri Laxmidhar Dalai, Jagadiha
He thanked Tata Steel for rehabilitating and providing necessary education to the child labors working in the area. He further requested M/s Tata Steel to financially help the family of the Everest climber Ms Dalai. He supported the expansion project of M/s Tata Steel Limited.
96. Sri Jogendra Das, Baragadia
He expressed her displeasure on Tata Steel for not providing adequate facility to the local rehabilitated people. Sri Das told that trees were cut for making widening of rads. People within 10km radius are socially backward due to non employment. He requested the company to take steps for employment of land losers. He further questioned the medical facility provided in Tata Medica as treatment is quite expensive to local poor people. He requested free medical service at Tata Medica to people staying within 10km radius from the Tata steel plant project. He reminded that dust bins we're requested for clean drive and repairing of shoos but was not provided. He informed told that he is not opposing the project but M/s Tata steel has not provided adequate facility as required and requested to give permission only after fulfilment of demands.
97. Sri Pradeep Kumar Mohanta, Sulia.
He informed that Tata Steel has commissioned many developemt activity in the area, however other plants have not taken such developement works which needs to be discussed. He thanked Tata Steel for doing development work in the area.
98. Sri Rabindra Kumar Jenamani, Baragadia
He informed people about the expansion project and thanked M/s Tata Steel for the expansion project. He expressed his support for the expansion proposal of the company.
99. Ms Zingi Hisa, Gobarghati

She told that M/s Tata steel has done many development work in the area. She requested to provide vehicle facility to local students.
108. Sri Salu Badara, Mirgichal
Welcoming the panel and gathering, he informed that Tata steel has done many development work in the area and taken various pollution control measures inside the plant to protect the environment.
109. Sri Ajit Kumar Aich, Baragadia
He complaint that few local people have got emplyment in the Tata steel Kalingsnagar project. He told that people are facing air pollution and requested pollution control Board to regularly check pollution level of Tata Steel Kalinganagar.
110. Sri Papu Deo, Baragadia
He informed that his village people are facing issue of kidney disease. TDS level of ground water in his village is very high and not drinkable. He expressed his concern that around 15000 unemployed people are living in the surrounding area. As per guideline, villages within 5km radius should be adopted and reservation (%) on local employment should be fixed, but those rules are not being followed by M/s Tata Steel. He requested Tata steel to give cooperation to local people.
111. Ms Subhadra Pradhan, Kendudihi
She told that the company has involved in many development activity and she is also hoped for many other development activity by Tata Steel. She supported the project
112. Sri Binod Bihari Sethy, Kaitha
Greeting the public, Sri Sethy informed that he is an employee of Tata Steel. He informed that the company is following all government rules and regulations and salary structure

provided by Tata Steel to Skilled and unskilled labors is good and better than other plants in the area.

113. Sri Deviprasad Mohanty , Kaitha

Sri Mohanta expressed his grivance for tree cutting by the company and not planting that nos. of trees. He further reminded that some tribal people lost their life during establishment of the existing plant project. He raised the issue of police verification of local people during employment. He told that development activity has been taken up by Tata Steel but environment protective measures has not been taken to that extent. He demanded Tata steel to explain the various steps that has been taken to protect the environment.

114. Sri Sunil Gagrei, Hudisahi

Sri Gagrei told that he has been rehabilitated by the Tata Steel Project. He informed that there is no developent in the area. He further informed that Hudisahi village condition is same as Nagada village and they are not getting facility of electricity, water etc. in their village.

Total 128 people had registered to deliberate, out of whom 114 persons deliberated during the public hearing. The Panel has received 331 nos. of written representations during the hearing and 1 no by State pollution control Board, Regional Office, Kalinganagar which are enclosed herewith. Sri Santosh Kumar Mishra, ADM, Kalinganagar asked the project proponent to present their comments to the people with respect to the demands raised by the public in the public hearing meeting. Sri R.R. Satpathy, General Manager (Corporate Services) of M/s Tata Steel Limited made the commitment on issues raised by the public. The statement of issues and concern of the public with comments of the applicant prepared in English and odia language and annexed separately. The meeting was ended with thanks to the chair.


