PROCEEDINGS OF THE PUBLIC HEARING HELD ON 28.08.2020 AT 10.30 AM AT KALYANI MANDAP, MARJITAPUR FOR ENVIRONMENTAL CLEARANCE IN RESPECT OF ANJIRA-MAKUNDAPUR HILLOCKS (CLUSTER-1) MINE FOR PRODUCTION OF BUILDING STONE / ROAD METAL OVER AN AREA 55.79 HA (15 NOS. OF MINING LEASE) AT ANJIRA & MUKUNDAPUR VILLAGE UNDER DHARMASALA TAHSIL IN THE DISTRICT OF JAJPUR, ODISHA

The public hearing in respect of the Anjira-Makundapur Hillocks (Cluster-1) mine for production of Building Stone/Road Metal over an area of 55.79 Ha (15 nos. of mining leases) at Anjira & Makundapur Village under Dharmasla Tahsil in Jajpur District was held on scheduled date & time at G.P. Office, Purunabaulamala in the District of Jajpur with reference to EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and amendment made thereafter.

The Panel consisted of the following members:

1. Sri Akshya Kumar Mallick, Additional District Magistrate, Revenue, Jajpur, Odisha
2. Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Odisha, Kalinganagar.

Sri Akshya Kumar Mallick, Additional District Magistrate, Revenue assisted by Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, the representative of State Pollution Control Board, Odisha, Bhubaneswar supervised & presided over the public hearing process.

At the outset, welcoming the members participated in the meeting Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date in respect of Anjira-Makundapur Hillocks (Cluster-1) mine for production of Building Stone/Road Metal over an area of 55.79 Ha (15 nos. of mining lease) at Anjira & Mukundapur Village under Dharmasla Tahsil in Jajpur District.

Sri A K Mallick, Additional District Magistrate, Revenue welcomed the public and explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He reminded the public about COVID-19 pandemic and requested all to follow guidelines contained in COVID-19 Master Circular on Social Distancing and also

COVID-19 SOP issued by the Government. He asked the Tahasildar, Dharmasala to deliberate people on the mining proposal.

Sri Saroj Kumar Panda, Tahasildar Dharmalasa, Applicant of the project, deliberated the public an overall idea on the proposed mining project and requested representative of M/s Kalyani Laboratories Private Limited (RQP) to explain in detail on mining proposal, environmental impact of the project and various environmental and CSR activity to be undertaken during the mining project.

Sri Jagabandhu Bisoi, Representative of M/s Kalyani Laboratories Private Limited briefed the mining proposal on behalf of Tahasildar, Dharmasala on Anjira-Makundapur Hillocks (Cluster-1) mine for production of Building Stone/Road Metal over an area of 55.79 Ha (15 nos. of mining lease). He addressed the committee members and assembled public and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, plantation programme and various other peripheral development activities envisaged in the proposed project.

Then Sri Mallick, ADM, Revenue, Jajpur, requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:



1. **Sri Bikash Ku. Das, Gahana**

At the outset Sri Das greeted the chair and the gathering. He said that most of the daily workers depends on stone quarry for their day to day earning. He suggested to convert the lease into small patches so that more employment will be generated.

2. **Sri Niranjana Rout, Zilla Parishada Member, Dharmasala**

At the outset Sri Rout greeted the chair and welcomed the gathering. He said that Balisahi, Mukundapur, Kusunpur & other villages are fully dependent on Anjira-Mukundpur Stone quarry for their living. In past days 13 lakh m³ stone have been excavated in Dharmasala Tehsil. He suggested converting the mining lease into small patches of an area of 2 Acres each which will be beneficial for all.

3. **Sri Krushna Ch Sahoo, Mukundpur**

At the outset Sri Sahoo greeted the chair and welcomed the gathering. He said that the mining lease should be auctioned according to rule & regulation. There is no irrigation facilities available in their area and hence their livelihood depends on the stone quarry.

4. **Sri Pramod Ku Behera, Mukundpur**

Sri Behera, greeting the chair, expressed that new company from outside are coming for excavation. He suggested converting the lease into small patches. He told that everybody from their area depends on the stone quarry.

5. **Sri Jagannath Mallick, Boungeadala**

Sri Mallick said that the mining lease should be granted.

6. **Sri Utkalamani Das, Gahana**

At the outset, Sri Das welcomed the panel and told that during the year 2025 to 2030, the stone quarry will be vanished. He told that Anjira-Mukundpur stone quarry is the life line of their area and lease should be given according to prescribed guideline. Farmers are becoming financially weak due to COVID-19. He suggested for granting the lease of quarry so that farmers will earn some money. He also suggested for converting the entire lease into small patches and lease should be given to nearby villagers so that they will be benefitted. He also told that local people will get affected due to blasting operation in quarry & crusher operation in the surroundings.

7. **Sri Bidyadhar Sethy, Anjira**

Sri Sethy welcomed the panel and suggested to convert the lease into small patches. He told that 80% people from their villages depend on the stone quarry for their earning. He also suggested for development of local school & peripheral development.

8. **Sri Santosh Rout, Godi Patia**

At the outset Sri Rout greeted the chair and welcomed the gathering. Sri Rout said that the entire quarry in the state should be given lease according to law. Earlier theft of stone occurred so that revenue to govt not generated. He emphasized on massive plantation should be done in surrounding quarry areas. He told that the anjira quarry was closed since seven months. 90% of local people depend on the quarry and hence lease should be given. He also suggested for arresting the theft in the surrounding areas.

9. **Sri Pabitra Ku Sahoo, Shyamsunderpur**



Sri Sahoo expressed that the lease should be converted into small patches.

10. **Sri Sumanta Ku Samantray, Gahana**

Sri Samantaray was thankful to the govt. for granting of lease. He told that majority of people from their locality depends on the quarry operation. He told that the entire lease should be converted into small patches and lease should be granted to local people so that they will get benefitted. He also suggested that wagon drilling should be banned.

11. **Sri Sudhansu Sahoo, Kalanda**

At the outset Sri Sahoo greeted the chair and welcomed the gathering. Sri Sahoo said that public hearing should be successful and quarry should be operated. He told that all the peoples in their locality depend on the quarry. He suggested for converting the entire lease into small patches so that more employment will be created. He also suggested for banning the village road for transportation of material by vehicles. He supported the project.

12. **Smt Ashanti Biswal, Natila**

She didn't tell anything.

13. **Sri Satish Biswal, Bhubanpur, Gadamadhapur**

At the outset Sri Biswal greeted the chair and welcomed the gathering. Sri Biswal informed about the flood occurred in jenapur village. He told about the necessity of safety, employment and development. He questioned about the existence of quarry for their next generation. He suggested for enhancing facilities for the provision of agriculture, handmade small scale industries, & irrigation facilities so that self employment will be created. He told that every labour who is working in the quarry should be registered so that they will get benefit on job security & educational facilities for their children. Water gets polluted because of quarry operation & runoff during rainy season. He told that quarry will be vanished one day. He told that the Anjira hillock was named as Baghua as more numbers of tigers were living in the hillock. But now-a-days tigers have been vanished, the type of land has been converted from forest to revenue. He suggested for forming a high power committee to enquire the above matter. He also told that wagon blasting operation is being practiced on daily basis so that the walls of their home are wrecked. He suggested for prohibition of wagon blasting and forceful approval of environment clearance to outsider. He told that labour registration are not occurred & suggested to grant the lease to local people. He also emphasized on backfilling of stone quarry. He told that special force has not been formed to calculate the excess mining of stone & application of satellite survey not implemented. He suggested for giving more importance to labors & farmers.



He further requested the administration to communicate the matter on theft of the black stone from the area and revenue losses to the Forest Department.

14. Sri Sankar Pratap Das, Gadamadhapur

At the outset Sri Das greeted the chair and welcomed the gathering. Sri Das told that the entire lease is not auctioned so that quarry is operated illegally. He also told that heavy machineries are used for mining operation so that more numbers of unemployment arises and local labour are going to outside for search of job. Stone quarry are looted instead of generating revenue to govt. & the day will come when the stone quarry will be vanished. He told that labors and farmers are not get benefitted and stone mafias are become richer. He told that if local people are finding employment then situation will be different. He also told that more number of local people is not present in the public hearing. He told that not only stone are looted but also sand and Murom. District administration should be more vigilant for this theft. He emphasized on local employment and steps should be taken for ban of bolangia road for stone & crusher mafia.

15. Sri Subrat Mallick, Madhupur

Sri Mallick said that Health, education & drinking water facility should be facilitated to the local people from the revenue generated due to excavation of mineral.

18 people had registered their name to express their views, comments, objections etc. out of which 15 people deliberated.

The Panel has received 02 nos. of written representations during the hearing which are enclosed herewith in original. Sri Akshya Kumar Mallick, ADM, Jajpur asked the project proponent to present their comments to the people with respect to the demands raised by the public in the public hearing meeting. Sri Saroj Panda, Tahasildar, Dharmasala made comments on the issues raised by the public. The statement of the issues and concerns of the public with comments of the applicant is prepared in Odiya and English language and annexed separately. The meeting was ended with thanks to the chair.

Registration of labour will be done according to law on priority basis. He further informed that 2% of project cost will be accorded for Corporate Environment Responsibility under which pollution control measures, plantation, water conservation and peripheral development such as road development, local employment of priority basis, health check-up, and distribution of educational material in primary schools will be done. He also informed that all the norms of the government will be fulfilled and finally thanked the public for supporting the project.</p>


