Public consultation (hearing) of M/s Rungta Mines Ltd. (Kamanda Steel Plant) was held on 09-03-2021 at 11 am in Anganwadi Centre of Munda Sahi in Kamanda village under Koira block of Sundargarh district in the state of Odisha for their application relating environmental clearance on expansion of production of semi-finished and finished steel in the existing steel plant. Addl. District Magistrate (A.D.M.), Sundargarh presided over the consultation (hearing) meeting.
