

PROCEEDINGS OF THE PUBLIC HEARING MEETING CONDUCTED ON DTD. 16TH OF MARCH, 2021 AT 11 AM IN BALARAMPRASAD VILLAGE (PLOT NO. 5092 & 5093 OF KHATA NO. 315) OF ODAPADA TEHSIL IN DHENKANAL DISTRICT, IN RESPECT OF ENVIRONMENTAL ASSESSMENT OF M/S MGM MINERALS LTD. FOR EXPANSION OF EXISTING SPONGE IRON PLANT PRODUCTION CAPACITY FROM 1,05,000 TPA TO 2,50,000,TPA AND POWER GENERATION THROUGH WHRB FROM 8 MW TO 16 MW, INSTALLATION OF SMS WITH INDUCTION FURNACE, LRF & CCM TO PRODUCE M. S. BILLETS OF 2,50,000 TPA, ROLLING MILL TO PRODUCE 2,50,000 TPA OF WIRE / TMT BARS, PELLET PLANT OF 0.6 MTPA & CFBC BASED POWER PLANT OF 2 X 16 MW AT NIMIDHA, HALDIABAHAL AND UPARPAL VILLAGES, ODAPADA TEHSIL OF DHENKANAL DISTRICT.

Public hearing in respect of Environmental assessment of M/s MGM Minerals Ltd. for expansion of existing Sponge Iron Plant production capacity from 1,05,000 TPA to 2,50,000,TPA and Power Generation through WHRB from 8 MW to 16 MW, installation of SMS with Induction Furnace, LRF & CCM to produce M. S. Billets of 2,50,000 TPA, Rolling Mill to produce 2,50,000 TPA of Wire / TMT bars, Pellet Plant of 0.6 MTPA & CFBC based Power Plant of 2 x 16 MW at Nimidha, Haldiabahal and Uparpal villages, Odapada Tehsil of Dhenkanal District. Sri Sasanka Sekhar Das, Additional District Magistrate, Dhenkanal District, supervised and presided over the meeting, assisted by Dr. Anup Kumar Mallick, Regional Officer, State Pollution Control Board, Angul and the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset Dr. Anup Kumar Mallick, Regional Officer, SPC Board, Angul welcomed the other panel member and the public, gave an introduction about the guidelines to be followed for the public hearing in the light of EIA Notifications 2006 in respect of Environmental assessment for of M/s MGM Minerals Ltd. for expansion of existing Sponge Iron Plant production capacity from 1,05,000 TPA to 2,50,000,TPA and Power Generation through WHRB from 8 MW to 16 MW, installation of SMS with Induction Furnace, LRF & CCM to produce M. S. Billets of 2,50,000 TPA, Rolling Mill to produce 2,50,000 TPA of Wire / TMT bars, Pellet Plant of 0.6 MTPA & CFBC based Power Plant of 2 x 16 MW at Nimidha, Haldiabahal and Uparpal villages, Odapada Tehsil of Dhenkanal District.

Sri Himanshu Sekhar Pattanaik, General Manager of M/s MGM Minerals Ltd on behalf of the project proponent addressed the committee members and assembled public and gave a brief description about the proposed project. He also briefed about M/s MGM Minerals Ltd. in the District of Dhenkanal. He also briefed about the peripheral development work that had been

taken up in this area, and made a presentation about the environmental management, pollution control measures, and solid waste-management of the related project.

Regarding public hearing of M/s MGM Minerals Ltd. at Nimidha, Haldiabahal and Uparpal villages of Dhenkanal District was publicized at the office notice Board of Nimidha Gram Panchayat Office, Bido Gram Panchayat Office Notice Board, Naya Bhagirathipur Gram Panchayat Office Notice Board, Balaramprasad Gram Panchayat Office Notice Board, BDO Office at Hindol, Tahasil Office Hindol, Jilla Parisad Office Dhenkanal and local villages of Haladiabahal, Nayabhagirathipur, Bido and Nimidha etc.

Dr. Anup Kumar Mallick, Regional Officer, State Pollution Control Board, Regional Office, Angul & representative of State Pollution Control Board Odisha then invited the public to present their views about the proposed project on environmental consideration.

The views expressed by various speakers are as follows:

1 Sri Faguram Behera, Haladiabahal village President

He welcomed the gathering of the public hearing and also welcomed the proposed expansion project of the industry. He mentioned that after establishment of M/s MGM Minerals Ltd. villagers of Nimidha, Haladiabahal, Kukurpal and Bido have been getting different types of CSR benefit but that is not adequate. He expressed that the proposed expansion would lead to development in the area and generation of more employment opportunity for the nearby villagers. He urged the proponent that with the expansion, there must be the more developmental programme for the surrounding village in an ideal way. His demands were

- a) Employment opportunity for the land displaced and unemployed persons from the nearby villages,
- b) Repair and maintenance of nearby village roads
- c) Provision of regular health check up facility
- d) Street light facility in the nearby villages
- e) Adequate pollution control measures
- f) Construction of additional room for Haladiabahal village school and
- g) Provision of drinking water supply to Haladiabahal village

He finally concluded that if the above demands will be fulfilled by the company, they will not make any objection for expansion proposal of the MGM company.

2 | Sri Kulamani Singha, Nimidha village, Local village Sabhapati

He welcomed the expansion proposal of the MGM company which will leads to more development in this area and generation of more employment in this area. His demands were

- a) Local employment opportunity based on their educational qualification.
- b) Employment opportunity for the land displaced persons,
- c) Repair and maintenance of Nimidha village roads

- d) Provision of Primary health center with Doctor
- e) Street light facility in the Nimidha villages for saving /distance maintaining from elephants
- f) Adequate dust pollution control measures
- g) Construction of additional room for Nimidha village High school with Teacher,
- h) Provision of drinking water supply to Nimidha village
- i) Repair and maintenance of village Lord Shiva Temple,
- j) Adaptation of Nimidha village for more CSR development and
- k) Protection of nearby forest.

He finally concluded that the above mentioned demands shall be fulfilled by the MGM company.

3 Smt. Anjana Sahu, Nimidha village (Samiti Sabhya of Haladiabahal GP)

She welcomes the public hearing. The expansion of the industry will lead to more development area and employment in this area. She has no objection for expansion proposal of MGM Company. She demanded to provide

- a) Local employment opportunity.
- b) Repair and maintenance of village roads
- c) Provision of health checkup facility
- d) Adequate dust pollution control measures
- e) Provision of drinking water supply to Nimidha village
- f) Repair and maintenance of Lord Shiva Temple of Nimidha village and
- g) Protection of nearby forest.

Expecting better employment opportunity and further development activities in the periphery, she made a strong opinion in favour of the project.

4 | Sri Rohit Chandra Rout, Nimidha village

He expressed that the villagers given land for set up of the industry since long time but till date the land displaced persons are deprived from any type of development. Peripheral developments were also not adequate. His demands were

- a) Employment opportunity for the land displaced persons,
- b) Repair and maintenance of Nimidha village High School approach road.
- c) Provision of Primary health center with medical staff and one Ambulance
- d) Provision of drinking water supply to Nimidha village
- e) Street light facility in the Nimidha villages,
- f) Adequate dust pollution control measures
- g) Construction of additional room for Nimidha village High school with Teacher,
- h) Repair and maintenance of village Lord Shiva Temple,
- i) Adaptation of Nimidha village for more CSR development and
- j) Protection of nearby forest.

He finally concluded that the industry shall give proper attention towards peripheral developmental work so that local people get benefited and subsequently this area will be developed. He expressed his views in support of the proposed expansion project.

5 Sri Khirod Chandra Sahu, Upparpal village, Gram Committee Member

His demands were

- a) Employment opportunity Upperbahal village people.
- b) Repair and maintenance of Upperbahal village roads
- c) Provision of health check up facility
- d) Adequate dust pollution control measures
- e) Provision of drinking water supply

Expecting better employment opportunity and further development activities in the periphery like improvement of village roads, provision of better drinking water, educational facility, and better health care facility at Upperbahal village and other villages should be provided. He expressed his views in support of the proposed expansion project.

6 Sri Tapan Kumar Das, Malibidda village Yuba President

He expressed that local villagers are not getting any type of benefit with respect to health check up facility. Doctors are not properly available. So he demanded to provide a permanent Doctor for regular health check up for the local villagers. Similarly he demanded that RWSS provided drinking water facility but the water is not treated properly. Without proper treatment the river water is being supplied to villagers. So he demanded to the company to make provision for supply of pure treated (filtered) drinking water. He expressed that education, health and drinking water should be given top most priority and to be strengthening further. He hopes that the development in the area can be happen with the proposed expansion.

7 Sri Rabi Narayan Sahu, Chintapokhari village President

He expressed that expansion in industrial activity and production will lead to all round development in the area. He demands were

- 1. Local employment opportunity based on their educational qualification.
- 2. Employment opportunity for the land displaced persons,
- 3. Health care facility
- 4. Repair of village roads
- 5. Adequate pollution control measures and
- 6. Pension facility for senior citizen (women).

8 | Sri Bijay Kumar Sethy, Nimidha village

He expressed that industry in an area is directly or indirectly related to the development in the surrounding area. He mentioned that M/s MGM has started their company since 14 to 15 years but their contribution towards CSR activity in this area is not adequate. He urged to the company that company should take proper initiative towards more peripheral development work so that villagers shall always appreciate MGM company in all respect. His demands were

- a) Repair and maintenance of Nimidha village High School and Health Center approach roads,
- b) Provision of Primary health center with Doctor
- c) One Refrigerator at the Health Center of Nimidha village
- d) Provision of drinking water supply to Nimidha village

- e) Local employment opportunity.
- f) Street light facility in the Nimidha villages
- g) Adequate dust pollution control measures

He finally concluded that the above mentioned demands shall be fulfilled by the MGM company.

9 Smt. Sagarika Behera, Sarpanch, Nimidha G. P

He welcomed the gathering of the public hearing and also welcomed the proposed project. She mentioned that MGM company has establish their industry during the year 2007. Till date the peripheral developmental work done by the industry is not adequate. The villagers demands are not fulfilled in all respect. The ground water level has been decreasing day by day. Villagers are not getting pure drinking water properly. She demanded to provide

- a) Provision for supply of drinking water through mineral plant,
- b) Employment opportunity for the land displaced and unemployed persons from the nearby villages based on their educational qualifdication.
- c) Repair and maintenance of Nimidha village High School approach road (from Gadia sahi to High School)
- d) Adaptation of Nimidha village and all Schools for more CSR development
- e) Provision of four times in a month for free health checkup facility
- f) Repair and maintenance of Lord Shiva Temple of Nimidha village
- g) Adequate dust pollution control measures
- h) Provision of Gochar type land to Nimidha village
- i) and adequate plantation.

Expecting better employment opportunity and further development activities in the periphery, she made a strong opinion in favour of the project.

10 Smt. Priyatama Biswal, Haladiabahal village

Without elaborating in detail she demanded that the industry should provide drinking water to their village.

11 | Sri Bhimsen Samal, Kunjabiharipur village

He expressed that MGM Company has acquired 5 acres of land from Sri Rameswar Baba and till date company has not given any type of assistance to him. He mentioned that in this regard he made a complained to the Collector. He requested to the Collector of Dhenkanal District to look into the issues of Sri Rameswar Baba.

12 | Sri Golak Bihari Nayak, Haladiabahal village

He expressed that earlier this area was deprived of any type of development. He mentioned that MGM company has establish their industry since long time but till date the peripheral developmental work done by the industry is not adequate. Women's are not given employment opportunity by the MGM company. He expressed that expansion in industrial activity and production will lead to all round development in this area. His demands were

- a) Local employment opportunity based on their educational qualification,
- b) Employment opportunity for women
- c) Adequate pollution control measures and more peripheral work.

13 | Sri Maheshwar Naik, Malibidda village

He welcomed the gathering of the public hearing and also welcomed the proposed expansion proposal of M/s MGM Minerals Ltd. He appreciated the company towards their extensive support to the nearby villages with respect to different peripheral developmental works done by the company. His demands were

- a) Local employment opportunity.
- b) Provision for Industrial Training facility for the local people who completed Higher Secondary exam or Matriculation exam.
- c) Necessary protection of crops from elephants

14 | Smt. Anjali Rana. Sarpanch of Malibidda village

Without elaborating in detail she demanded that the industry should provide local employment opportunity, street light facility on village roads and drinking water to their village. She supported the expansion proposal of the industry.

15 | Sri Nityananda Sahoo, Haladiabahal village

He welcomed the gathering of the public hearing and also welcomed the proposed project of the industry. He mentioned that in the year 2005 during land acquisition time MGM company has acquired land by giving Rs. 5000/- per Guntha of land cost and which was much cheaper at that time. About one acres of his land also encroached illegally by the company and till date company has not taken any steps to solve his land acquired problem. About 15 Acres of Gochar land also encroached by MGM company. During land acquisition time MGM Company assured to the villagers that they will provide another 15 acres of land outside their industrial area against the villagers Gochar land. Till date no steps taken by this company. Since inception of the company the peripheral work done by the industry has not been satisfactory. Expecting better employment opportunity, development in the village school and further developmental activities in the periphery, he made a strong opinion in favour of the proposed project.

16 Smt. Manorama Naik, Haladiabahal village

She welcomes the proposed expansion project. She mentioned that villagers given land to MGM company to establish their industry but till date company has not given adequate local employment opportunity. About 2000 people are living in Haladiabahal village but very less people have engaged in MGM Company. Without elaborating anything in detail she urged that the company to give priority for local employment benefit and necessary assistance towards higher education for the students of Haladiabahal village.

17 | Sri Bijay Kumar Biswal, Haladiabahal, Sabhapati MGM Karmachari Sanghya.

He mentioned that during the entire lockdown period of Covid-19 this industry has not stopped their production. The industry was in operation with limited manpower and the plant authority has paid full salary to their all employees. This year company has given employment to 650 people from the local villages. He welcomed the expansion project of the industry which will leads to more development in this area and generation of additional 650 no. of direct and indirect generation of new manpower. He urged to the company authority to take necessary steps for more CSR work in this area. He expressed his unhappiness towards some employees behavior of the company. Expecting better



employment opportunity and further development activities in the periphery, he supported the expansion project of the company.

18 | Sri Madan Naik, Haladiabahal village

He expressed that he was having land, house and trees but everything has acquired by MGM company. He mentioned that company security personnel did not allow him to enter into the factory. Without elaborating anything in detail he demanded that company authority shall give him employment benefits.

19 Smt Mamata Acharya, Nayabhagarathipur Village

She welcomes the public hearing. The expansion of the industry will lead to more development area and employment in this area. She has no objection for expansion proposal of MGM Company. She demanded to provide

- a) Employment opportunity for the land displaced and unemployed persons from the nearby villages,
- b) Local employment opportunity based on their educational qualification
- c) Adequate dust pollution control measures and
- d) Protection of environment.

Expecting better employment opportunity and further development activities in the periphery, she made a strong opinion in favour of the project.

20 Sri Dhuleswar Nayak, Haladiabahal village

He expressed that adjacent to the entrance point of MGM Steel Company he has small piece of land where a Debi Temple exists. Within the same temple premises idols of Lord Shiva, Lord Jaqgannath, lord Krushna and Goddess Devi Durga also exists. He belongs to a Priest. He told that he has 7 acres of land but due to family dispute he left his family members and entire land whatever belongs to him. He mentioned that there are so many accident happened on the National Highway where the temple exists adjacent to NH. He performed puja and mantra every day to bless the people. He also mentioned that Puja, the loving offering of light, flowers, and water or food to the divine, is the essential ritual of Hinduism. He mentioned that as a temple deity is considered a resident rather than a guest. He urged to MGM company authority to provide necessary assistance for develop the temple so that various pujas may be performed daily at various times of the day.

21 Smt. Sasmita Naik, Haladiabahal village

She expressed that industry has acquired land from these village land owners. Presently there are many family members those are unemployed and their living status is very poor. She also mentioned that the Haladiabahal village is having highly educated girls but they are unemployed. She requested to the company authority to make employment provision for women's/ladies. She told that some senior citizens of Haladiabahal village are very poor and they did not have any source of income. In this age they cannot do any type of job or cultivation. So she requested to the company authority to provide some monetary assistance for these poor senior citizens of Haladiabahal village. Village tube wells are not functioning properly. Water pipeline project for supply of drinking water to village has not been completed. Her other demands are

- a) Adequate dust pollution control measures and
- b) Provision of health checkup facility with Ambulance
- c) Provision of drinking water supply

	d) Protection of environment.

22	Sri Jitendra Kumar Dhir, Sarpanch, Balaramprasad Gram Panchayat		

He mentioned that this area is famous for Debi Pitha (Temple). So many meeting are being conducted here. He demanded to the MGM Company that necessary assistance shall be provided to this temple committee for completion of lighting facility around the temple premises, drinking water supply and development of park adjacent to temple.

At the same time 19 people submitted their written statements before the panel members are enclosed separately.

Observation:

Generation of local employment opportunity, education, drinking water facility, development of village roads, Development of Primary health center, development of village temples, pension for senior citizen, provision for women employment, adequate air pollution control measures, primary health center facility, Industrial Training Centre and aforestation etc. were the most important issues emerged during the discussion.

Dr. Anup Kumar Mallick, Regional Officer, State Pollution Control Board, Angul & representative of State Pollution Control Board, Odisha, prepared the summary of the public hearing proceedings accurately reflecting the views and concerns expressed by the speakers with the inclusion of comments of the applicant read over to the audience at the end of the meeting explaining the contents in the ODIA Language and the agreed minutes of public hearing meeting was prepared. The statement of issues and concerns of public with the comments of applicant, prepared in Odia and English language is annexed herewith separately.

The President of Public Hearing meeting Sri Sashanka Sekhar Dash, Additional District Magistrate, Dhenkanal District, ratified the minutes of meeting and with the views and demands of public. He then delivered vote of thanks to the public for extending co-operation in smooth conducting of the public hearing proceedings.

COMMENT RAISED BY THE PUBLIC

COMMENTS OF PROJECT PROPONENT

The issues raised at the public hearing meeting are mainly two fold. These are issues concerning to pollution due to proposed industry and its mitigation and issues relating to development of the area i. e, peripheral development.

The issues concerning to control of pollution are

- 1. Aforestation programme
- 2. Dust suppression and water pollution control

The issues concerning to development of the area are:-

- 3. Local employment opportunity based on educational qualification and provision for family members of land affected person.
- 4. Provision of regular health checkup facility with a Primary Health Centre and Ambulance to Haladiabahal, Nimidha and Ranibania village.
- 5. Provision for Ambulance with one regular Doctor,

Sri Himanshu Sekhar Patnaik, GM on behalf of the proponent who was present at the public hearing gave his comments to certain demands raised by public as follows.

- 1. Plantation has already started inside the factory and outside the factory premises.
- 2. Dust suppression and water pollution control management practices is being & will be complied as per norms of the State Government and as per the provision of Environment Protection Act.
- 3. Regarding employment issue company representative expressed that the locals will be given priority in employment and it will be continued. Priority will be given to the land displacement person.
- 4. Keeping in view of the health and hygiene issue, the company informed that they already appointed one Doctor on contract basis in this area for regular health check up for the locals on fort-night basis. Provision for primary health care facility in a centralized location will be considered in consultation with District Administration.
- 5. Ambulance will be provided to the village within a short time period.

- Provision of better educational facility with additional classroom for Primary Sachool and High School at Haladiabahal village,
- 7. Provision for additional teaching staff at Nimidha village school
- 8. Provision of drinking water with proper treatment facility.
- 9. Provision for repair and maintenance of village roads upto high School and Shiva Temple,
- 10. Provision of Industrial Training Centre
- 11. Adaptation of Nimidha School
- 12. Pension facility for Senior Citizens
- 13. Provision of more peripheral developmental work

- 6. Infrastructure facilities to the nearby village schools will be provided after consultation with local representative and District Administration.
- 7. Provisional of additional teaching staffs will be considered after consultation with local representative and District Administration.
- 8. The proponent has already provided drinking water facility to the nearby village and it will be continued to the nearby village in consultation with District Administration.
- 9. Company has already concreted major portion of village roads and in future phase wise more concrete road will be developed
- Every year Company is sponsoring 10 candidates for ITI training through CIPET. Also company will provide vocational training at regular intervals near our plant.
- 11. Adoption of Nimidha Village School in Consultation with concerned authority will be done.
- 12. Company will provide financial assistance to Self Help Groups (SHG) of women and elderly persons of Nimidha, Upperpal & Haladiabahal.
- 13. For other peripheral developmental works, the industry authority informed that PDC works will be fulfilled with the expansion of the industry and also in consultation with the nearby village committee members and local administration of this area.
