PROCEEDINGS OF PUBLIC CONSULTATION (HEARING) OF EXPANSION PROJECT OF KHATKURBAHAL LIMESTONE & DOLOMITE MINES OF M/S SHIVA CEMENT LTD. HELD ON 24-08-20021 (12 PM) BEHIND JAGANNATH TEMPLE OF KHATKURBAHAL VILLAGE UNDER KUTRA BLOCK OF SUNDARGARH DIST. (ODISHA)

Public consultation (hearing) of M/s Shiva Cement Ltd. was held on 23-08-2021 at 12 pm behind Jagannath village of Khatkurbahal village under Kutra Block of Sundargarh district in the state of Odisha for their application relating environmental clearance on proposed expansion of Khatkurbahal Limestone & Dolomite mines. Addl. District Magistrate (ADM). Sundargarh presided over the consultation (hearing) meeting. In the beginning, the Regional Officer, Rourkela of State Pollution Control Board, Odisha and ADM explained the villagers on the aspects of consultation (hearing) for environmental clearance under E. I. A. Notification, 2006 and invited M/s Shiva Cement Ltd, to address public on details of the expansion project of the existing limestone mine and its environmental aspects for their views onward. Sri Amardeep Mohanty, Dy. Gen. Manager of M/s Shiva Cement Ltd. addressed public on the expansion project and its environmental aspects. ADM then invited the public to address their views on environmental aspects of the project. In the beginning, Dr. Rajan Ekka, MLA (Raigangpur AC) intervened and told to consider grievance of all stakeholders and allow the interested public present to participate in delivering their views. 27 nos. of villagers opined their views as mentioned below. Attendance sheets of villagers present & signed and who addressed views are annexed in Annexure – 1 & 2 respectively.

They are supporting the company and company should also reciprocate the same by undertaking local development. 	



10	Smt. Suteng Soy, VillUperbahal	When school and boundary wall were constructed in Uperbahal, they were not allowed to move out. They are having difficulties for grazing their domestic animals. Tribals will not handover their land to the company.
11	Md. Shaban Khan, VillKhatkhurbahal	Welcome JSW for local development and local employment. He demanded employment to local youth and for educating of girls.
12	Smt. Munika Kandei, Vill-Kulenbahal	Opposes the company and stated that they will not handover their land to the company.
13	Sri Charan Jojo, VillKulenbahal	 Due to mines expansion they will suffer a lot such as noise and dust pollution will be there due to blasting. They have experienced that when displaced by SAIL and are yet to get benefits and roaming here and there. Land is their life and they will not give land to the company.
14	Smt. Alma Bilung, VillKulenbahal	 Opposes the company and stated that Due to expansion of mines they will suffer from dust pollution etc. They are happy with present status. They will not give their land to the company and also does not require any facility.
15	Md. Anwar Ahmad, VillKhatkurbahal	 Welcome and supports the company for development. Expansion of mines is required for supply of raw material for operation of the factory. Demanded for construction of park in khatkhurbaha village, construction of road, better education, construction of hospital, electrification, development of both Jagannath Temple and Masjid etc.
16	Md. Makaram Raja, VillKhatkurbahal	Demanded for construction of separate road for transportation of minerals to avoid traffic congestion in existing road.



		Supported the JSW for development and he agrees to hand over his land.
17	Smt. Monik Kullu	 Strongly opposed the company. They will not handover their land and Government cannot forcefully acquire it. Questioned why police has allowed such large gatherings during Covid-19?
18	Md. Rafique, Vill-Khatkurbahal	 JSW should demarcate the lease boundary and clearly mention the amount of compensation etc. Now-a-days government is taking steps for deployment irrespective of location of mines. If public will be displaced, that development will be for whom ? Issue of displacement will be there.
19	Sri Nicolas Kullu, VillKulenbahal	Farmers are not agreed to give their land to the company. Once they will lose their land, they will not get it again.
20	Sri Pradeep Kerketta, VillMagarkundu	 Whether District Administration of Company will take guarantee about the job, promise here? Company will not give employment under its pay roll rather they will be employed as contract worker, which has no value. They are opposing the company and they will not give their land.
21	Md. Masud, VillKhatkhrbahal	Supports JSW as they have constructed road and Aganwadi etc.
22	Smt. Bipati Ekka, VillKutra	 Opposes to the company and stated that they will not give their land to the company. Jal, Jungle and Jammen belong to them and they will not handover it. Gram Sabha is the main body not the Vidhan Sabha.
23	Sri Asim Tete, VillKeratali	 If all the tribal will be displaced than money will have no value. Few are supporting today as because they were influenced by company by taking money. Who will take

24	Smt. Anima Bebi, VillLanjibarna	 JSW is cheating local public and looting their land. Massive displacement will be there. They are opposing the JSW and they will not handover their Jal, Jungle and Jammen. She strongly opposed the expansion project.
25	Sri Sridhar Sahoo, VillKhatkhurbahal	Opposed the company as he depends upon his agricultural land.
26	Smt. Micha Toppo, VillKhatkurbahal	Faces difficulty to approach her agricultural land as mine manager has restricted her path through mines. She will fight for her agricultural land.

Manager of M/s Shiva cement Ltd. clarified the people on the raised issues which are listed in the Executive Summaries at Annexures – A & B respectively in English and Odia. Regional Officer, Rourkela of State Pollution Control Board, Odisha then extended vote of thanks and ADM closed the meeting. Four no. of representations received during the public hearing and video recording of the consultation (hearing) in pen drive are also annexed.



But due to restriction imposed by the State Government on public gathering for up-surge of COVID infection in the State the public hearing scheduled above has been postponed.
