PROCEEDINGS OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT FOR KHAIRABATHI STONE QUARRY OF SRI MANTU KUMAR PATTNAIK OVER THE MINING LEASE AREA OF 7.525 HA. IN KHAIRABATHI VILLAGE, SHERAGDA TAHASIL OF DISTRICT GANJAM, HELD ON 13.09.2021 AT 10.00 AM AT PLOT NO. 1691, KISSAM-GOCHAR (VACANT) WHICH IS SOUTH SIDE OF VILLAGE KHAIRABATHI UNDER SHERAGADA TAHASIL OF GANJAM DISTRICT

At the outset, Sri Mitrasen Majhi, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA notification, 2006 and the objectives of the public hearing. He stated that Sri Mantu Kumar Pattnaik has proposed to have Environmental Impact Assessment for mining lease area of 7.525 ha. at Khairabathi village, Sheragada Tahasil of District Ganjam and has applied to obtain Environmental Clearance from the Ministry of Environment, Forest and Climate Change, Government of India and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Oriya Daily "Dharitri" dated 12.08.2021 and an English Daily "The New Indian Express" dated 12.08.2021 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report, Executive Summaries (Odia & English) and soft copy in the office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre(DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment (Environment) Govt of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Makarjhola Gram Panchayat, Kurula Gram Panchayat, Alarigada Gram Panchayat, Rochilima Gram Panchayat and the Block Development Office, Sheragada, in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Addl. District Magistrate, Ganjam, Sri Amiya Kumar Sahoo, O.A.S (S) to kindly preside and supervise in the public hearing.

The Addl. District Magistrate, Ganjam, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects only. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance from the Govt. of India. Then he asked the Project Proponent of M/s. Khairabathi Stone Quarry to brief about the project.

Sri Mantu Kumar Pattnaik, Project Proponent of M/s. Khairabathi Stone Quarry presented the salient features of the project, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the project proponent to reduce the impact while executing the project in Odia language.

He concluded that a suitable Environmental Management Plan has been formulated and will be continuously upgraded to mitigate the impact on the different components of the environment.

The Addl. District Magistrate, Ganjam, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 60 persons were present in the public hearing meeting, only 48 nos. of persons signed in the attendance sheet, out of which 09 persons participated in the oral deliberation and signed in the oral deliberator's sheet. No written representations were received in the hearing. The attendance sheets and the Deliberator sheets are enclosed as **Annexure-I** and **Annexure-II** respectively.

The statements recorded are as follows.

1. Sri Dharmendra Padhy, At- Khairabathi

He said that if the proposed stone quarry will operate then they would get materials easily and people would get employment. He further added that if the stone quarry will operate there would be no any problem for them.

2. Sri Sudarshan Nahak, At- Khairabathi

He said that if the stone quarry will operate they would get material for construction and road making and hoped that there would be no problem if the stone quarry operate.

3. Sri Laxman Gouda, At- Khairabathi

He said that if the stone quarry will operate they would get the material easily and people would get engagement therefore he extended his support to the project.

4. Sri Amitabh Bisoyi, At- Khairabathi

He hoped that if the stone quarry will operate the people would get employment and further said that presently they are not getting the materials in their locality. If the quarry will operate they would get the material in cheap rate for their construction activities.

5. Sri Ashant Kumar Jena, At- Alarigada

He addressed the gathering and said that he is a business man and have one tractor. If the quarry will operate than he would get work in the local area. Hence he supported the project.

6. Sri Kanhu Gouda, At- Khairabathi

He supported the project and hoped that due to the project employment would be generated.

7. Sri Digambar Nahak, At- Alarigada

He addressed the chair and the gathering and said that if the stone crusher will operate then there would be no pollution with regard to Water and Air. He hoped that people would get their work and migration would be controlled. Also he added that due to the project people would get the materials for construction purpose. Therefore, he requested the authority to operate the crusher.

8. Sri Pitambar Swain, Sarapanch, Alarigada G.P.

He said that if the stone quarry will operate then the Gram Panchayat would get the raw materials. Hence he supported the project to operate.

9. Sri Santosh Kumar Pattnaik, At- Alarigada

He addressed the gathering and said that the hearing is for grant of Environmental Clearance to the proposed project. He showed his happiness and said that if the project will operate people would get their materials easily. However, he opined that the project proponent should develop more plantation and there should not be any affect to the local people.

CONCLUSION:

During the hearing the project proponent addressed the apprehensions raised by the public. Further the Addl. District Magistrate, Ganjam and Regional Officer, State Pollution Control Board, Berhampur also discussed on issues raised by the public.

Sri Mitrasen Majhi, Regional Officer, State Pollution Control Board, Berhampur & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns, expressed by the oral deliberators. The minutes of the public hearing were prepared which has been ratified by Sri Amiya Kumar Sahoo, O.A.S (S), Addl. District Magistrate, Ganjam with the views and concerns of the deliberators. The video recording of the entire public hearing is enclosed herewith for ready reference.

The statement of issues and concerns of public with the comments of the representative of the project proponent, prepared in Odia and English Language are annexed as **Annexure-III** and **Annexure-IV** separately.

The public hearing was ended with vote of thanks by the chair.
