Proceeding of the public hearing conducted on 28.09.2021 for Madhyasasan Sand Quarry on river Devi, Tahasil- Biridi in the district of Jagatsinghpur, Odisha

A public hearing was held on 28.09.2021 at 10.30 AM at Uttarasasana Hata (in front of R.I. Office) of Jagatsinghpur district for the above proposed sand quarry (5.99 Ha). Smt. Chinmayee Biswal, Additional District Magistrate, Jagatsingpur presided over the meeting. Er. Dillip Kumar Dash, Regional Officer, State Pollution Control Board, Odisha, Paradeep assisted during the public hearing. She welcomed the public, who were present at the venue for participating in the hearing. Attendance sheets of the officials present in the hearing and that of public present in the venue are annexed as Annexure-I and II respectively. 62 persons were present in the meeting, who have put their signatures in the attendance sheet. 11 persons intended to deliver their views and their list is annexed as Annexure-III. Out of these 11 persons, 03 persons remained absent and 08 persons delivered their views. 20 no.s of written statements were received during the public hearing. Video recording of the entire proceeding of the public hearing was done and it will be forwarded to State Environment Impact Assessment Authority (SEIAA), Government of Odisha as such along with this proceeding.

At the outset, Er. Dillip Kumar Dash, Regional Officer, State Pollution Control Board, Paradeep welcomed the public present in the meeting. He briefly described the objective of the public hearing conducted as per the provisions of EIA Notification No. S.O. 1533(E) of Dt.14thSeptember 2006 of the Ministry of Environment and Forests & Climate Change (MOEF & CC), Government of India and its amendment No. S.O. 141 (E) of Dt.15.01.2016 and the importance of the actual views of local public regarding the project. He also informed that the date, time and venue for conducting this public hearing was duly advertised in one Odia daily newspaper; Sambada dtd. 24.08.2021 and in one English daily newspaper, The New Indian Express dtd. 24.08.2021 following due procedure for intimation of public. Further, the same information was also propagated through notices displayed at various places in the area. Executive summary of the proposed project both in Odia & English were displayed at the meeting venue for ready reference of public. The executive summary was also made available in the website of State pollution Control Board, Bhubaneswar (www.ospcboard.org).

ADM, Jagatsinghpur and Regional Officer, Paradeep explained to public to place their views about the environmental impacts of the proposed project and emphasized that their statements should be related to environmental pollution and its control aspects. Then the Regional Officer requested Smt. Sagarika Priyadarshini,

Tahasildar, Biridi to describe before the public about the details of the project and is impact on surrounding environment.

Smt. Sagarika Priyadarshini, Tahasildar, Biridi presented and briefed about the importance of sand mining in construction sector and how the same contributes towards nation building. She highlighted about the details of the sand bed spreading over an area of 5.99 Ha in Madhyasasan village of Jagatsinghpur district. Mining plan has been prepared and approved. Auctioning of the quarry has been over and highest bidder has been selected. Sand mining capacity will be 14400 m³/year as per the approved mining plan. As per the provisions of OMMC Rules, 2016, sand mines need environmental clearance and for that purpose application for public hearing was filed. On behalf of the highest bidder, Sri Suryakant Pradhan described that baseline study has been carried out and pollution control measures will be taken up as required. Water sprinkling will be done to reduce air pollution. No trees will be cut during the mining. Transporting vehicles will be fully covered. Avenue plantation will be done at both sides of the road. Personal protective material will be provided to people for their safety during mine operation. Monitoring of air and water quality will be done in the area and corrective steps will be taken up accordingly.

Regional Öfficer, SPCB, Odisha, Paradeep then invited public for their deliberations. Details of deliberations are annexed at **Annexure-IV**.

After the deliberations by the public, Regional Officer, SPCB, Paradeep summarized various issues raised by the public and invited the authorized representative of the highest bidder of the proposed sand mine to offer his views on those issues. On behalf of the highest bidder, Sri Suryakanta Pradhan placed his views on the issues raised by the public. ADM instructed the project proponent to redress the issues raised by people in priority. As per the demand of public, it was stated by both ADM, Jagatsinghpur and Regional officer, SPCB that complaints can be filed in written at Tahasildar, Biridi and SPCB, Paradeep, in case of non-fulfillment of commitments made by the lessee.

The summary of the views and concerns of the public and the commitments made by the project proponent are annexed in Oriya language & English language as **Annexure-V** &VI respectively.

Finally the meeting ended with a vote of thanks to the chair and other participants.

Statements of the public participated in the deliberation during public hearing conducted on 28.09.2021 for Madhyasasan Sand Quarry on river Devi, Tahasil- Biridi in the district of Jagatsinghpur

1. Sudhir Ku. Mohanty, Nuagaon,

He remained absent.

2. Atulya Ku. Brahma, Madhyasasan

He stated that road condition at the nearby Samal sahi is poor and requested the district administration to look for its construction and repair. He also expressed his concerns about effective covering of the sand transporting vehicles to prevent sand spillage and air pollution. He requested for providing sand at concessional rate to the local people. He also wanted to know the name of authorities who should be contacted in case of noncompliance by the lessee.

3. Pratap Behera, Madhyasasan

He welcomed the project and requested for making sand available at concessional price for nearby villagers. Housing under Biju Pakka Ghara and Indira Awas yojana are getting delayed due to poor availability of sand. This mining will help local people on this aspect. He requested to extract sand away from the river bank so as to protect the river embankment.

4. Surendra Ku. Satpathy, Uttarasasana

He remained absent.

5. Dibakara Sahoo, Uttarasasana

He welcomed the project saying that sand will be lifted and environment will be protected. He also requested for providing sand at concessional rate to the nearby two panchayats. He emphasized on providing road to the Harijan sahi named as Samal sahi and look for their safety during sand transportation.

6. Pitambara Mohapatra, Hanumanta Brahmapur

He stressed on tree plantation in the area for developing a green belt and also to take adequate care for improving their survival. He emphasized the role of green belt in environmental protection. He also supported the demand for providing good road at Samal sahi. Vehicles should be driven slowly at the residential area. Personal protective material should be provided to the people while working in the quarry. Sand mining should not be done at the river bank to protect the river embankment. Water sprinkling on the road should be

carried out and proper covering of vehicles should be done to minimize air pollution.

7. Gitanjali Sahoo, Uttarasasana

She intimated that a child died due to speedy driving of a sand carrying vehicle a month before. Therefore vehicles should be driven slowly and carefully to protect human life. She also requested for proving sand at concessional price.

8. Sudarsana Panda, Madhvasasana

He wanted to know the name of authorities where complaint needs to be filed in case non-compliances with the commitments made by the representative of the highest bidder. He also requested for proving better road to the people of Samal sahi. He alleged that proper notification has not been made for this public hearing and he has arrived there after hearing from some people.

9. Bibhuprasad Dash, Madhyasasana

He wanted to know the mineable reserve in 5.99 area lease. He admitted that it's already said to take care of pollution problems by covering of vehicles and by water sprinkling. It's a flood area and mining should be done deep inside the river and not at the river bank for embankment protection. Green belt should also be developed on the private land available near the river bank. This will also help the villagers during flood time. He emphasized to take proper care for people of Samal sahi including healthcare facilities. Roads need to be repaired intermittently. He also wanted to know the name of authorities whom to be contacted during non-compliances.

10. Ganesh Samal, Madhyasasana

He remained absent.

11. Biswaranjan Kar, Baradapali

He appreciated the public hearing and welcomed the project. He emphasized on careful and slow driving of vehicles. He requested for concessional price for local people.

Points raised by the public during public hearing conducted on 28.09.2021 for Madhyasasan Sand Quarry on river Devi, Tahasil- Biridi in the district of Jagatsinghpur

The public raised the following issues and apprehensions for redressal by the project proponent.

- 1. Construction of road at the Harijan sahi (Samal sahi) and repair maintenance of local roads damaged due to sand transportation.
- 2. Careful and regulated driving of vehicles engaged in sand transportation on the village roads.
- 3. Proper covering of sand carrying vehicles and water sprinkling on roads to minimize air pollution.
- 4. Plantation of trees at the river bank and other areas and also avenue plantation.
- 5. Sand extraction away from the river bank for protection of embankment.
- 6. Heavy vehicles not to be used for sand transportation.

Views of Project Proponent on the issues raised by the public during the Public hearing.

Sri SuryakantaPradhan, authorised representative of highest bidder addressed the issue raised by public and intimated that

- 1. For construction of the roads including that near Samal sahi will be taken up with district administration so that the same can be done under district mineral fund.
- 2. Vehicles will be driven at slow and regulated speed on the village roads.
- 3. All the sand transporting vehicles will be covered properly with tarpaulin and water sprinkling will be done to minimize air pollution.
- 4. Plantation will be done at the river bank and other identified areas in the villages and care will be taken for their survival.
- 5. Sand will be extracted away from the river bank for protection of the embankment.
- 6. No heavy vehicle except tractors will be used for sand transportation.
- 7. Under CSR activities, developmental work for social organizations and free health camps will be covered.
