Proceeding of the public hearing conducted on 27.09.2021 for Chasikhanda Biluakhai Nadi Sand Quarry, Tahasil- Biridi in the district of Jagatsinghpur, Odisha

A public hearing was held on 27.09.2021 at 10.30 AM at R.I. Office, Purana of Jagatsinghpur district for the above proposed sand quarry (10.117 Ha). Smt. Chinmayee Biswal, Additional District Magistrate, Jagatsingpur presided over the meeting. Er. Dillip Kumar Dash, Regional Officer, State Pollution Control Board, Odisha, Paradeep assisted during the public hearing. She welcomed the public, who were present at the venue for participating in the hearing. Attendance sheets of the officials present in the hearing and that of public present in the venue are annexed as **Annexure- I and II** respectively. 59 persons were present in the meeting who have put their signature in the attendance sheet. 08 persons intended to deliver their views and their list is annexed as Annexure-III. 12 no.s of written statements were received during the public hearing. Video recording of the entire proceeding of the public hearing was done and it will be forwarded to State Environment Impact Assessment Authority (SEIAA), Government of Odisha as such along with this proceeding.

At the outset, Er. Dillip Kumar Dash, Regional Officer, State Pollution Control Board, Paradeep welcomed the public present in the meeting. He briefly described the objective of the public hearing conducted as per the provisions of EIA Notification No. S.O. 1533(E) of Dt.14th September 2006 of the Ministry of Environment and Forests & Climate Change (MOEF & CC), Government of India and its amendment No. S.O. 141 (E) of Dt.15.01.2016 and the importance of the actual views of local public regarding the project. He also informed that the date, time and venue for conducting this public hearing was duly advertised in one Odia daily newspaper; Prameya; dtd. 24.08.2021 and in one English daily newspaper, The Times of India dtd. 24.08.2021 following due procedure for intimation of public. Further, the same information was also propagated through notices displayed at various places in the area. Executive summary of the proposed project both in Odia & English was displayed at the meeting venue for ready reference of public. The executive summary was also made available in the website of State pollution Control Board, Bhubaneswar (www.ospcboard.org).

ADM, Jagatsinghpur and Regional Officer, Paradeep explained to public to place their views about the environmental impacts of the proposed project and emphasized that their statements should be related to environmental pollution and its control aspects. Then the Regional Officer requested Smt. Sagarika Priyadarshini, Tahasildar, Biridi to describe before the public about the details of the project and its impact on surrounding environment.

Smt. Sagarika Priyadarshini, Tahasildar, Biridi presented and briefed about the importance of sand mining in construction sector and how the same contributes towards nation building. She highlighted about the details of the sand bed spreading over an area of 10.117 Ha in Chasikhanda village of Jagatsinghpur district. Mining plan has been prepared and approved. Auctioning of the quarry has been over and highest bidder has been selected. Sand mining capacity will be 24282 m³/year as per the approved mining plan. As per the provisions of OMMC Rules, 2016, sand mines need environmental clearance and for that purpose application for public hearing was filed. On behalf of the highest bidder, Sri Suryakant Pradhan described that baseline study has been carried out and pollution control measures will be taken up as required. Mining will be done as per the approved mining plan. Within next 5 years, 2500 trees will be planted and no tree will be cut in the surrounding area. Monitoring of air and water quality will be done in the area and corrective steps will be taken up accordingly.

Regional Officer, SPCB, Odisha, Paradeep then invited public for their deliberations. Details of deliberations are annexed at Annexure-IV.

After the deliberations by the public was over, Regional Officer, SPCB, Paradeep summarized various issues raised by the public and invited the authorized representative of the highest bidder of the proposed sand mine to offer his views on those issues. On behalf of the highest bidder, Sri Suryakanta Pradhan placed his views on the issues raised by the public. ADM instructed the project proponent to redress the issues raised by people in priority.

The summary of the views and concerns of the public and the commitments made by the representative highest bidder are annexed in Oriya language & English language as Annexure-V & VI respectively.

Finally the meeting ended with a vote of thanks to the chair and other participants.

Statements of the public participated in the deliberation during public hearing conducted on 27.09.2021 for Chasikhanda Biluakhai Nadi Sand Quarry, Tahasil- Biridi in the district of Jagatsinghpur

1. Prabir Kumar Das, Manguli

He welcomed the project stating that lifting of sand from the river is better for protection of the river embankment. He supported auction of sand quarry as it is a source of revenue for government and for easier and cheaper availability of sand for local people. He requested for making the approach to the river (ramp) permanent by concreting it so that it does not get washed away every year during rain. He insisted that as per the commitments made, covering of sand loaded vehicles with tarpaulin sheet and water sprinkling on road should be carried out.

2. Sukanta Barik, Chasikhanda

He welcomed the public hearing and requested that covering of sand loaded vehicles with tarpaulin sheet and water sprinkling on roads should be done to prevent sand dust being air borne. He emphasized that the approach road/ramp to river bed should be concreted and care should be taken for protection of the river embankment.

3. Gayadhara Mohanty, Manguli

He highlighted the importance of plantation and expressed his satisfaction that sand mining operator is promising for plantation in the area. He stated that sand lifting is necessary for keeping water level in the river and it is required for maintaining ground water level in the area. He requested that road condition in the area is bad and the lessee alone cannot spend so much money to maintain the entire road network. Government should also spend for road construction and maintenance in the area.

4. Bimbadhara Das, Maindipur

He said that roads will be damaged due to plying of heavy vehicles. Therefore care needs to be taken for maintenance of the roads. He also supported the demand of concreting the approach road/ramp existing at the river.

5. Gyanaranjan Jena, Basandhara

He emphasized on water sprinkling on roads and repairing of damaged road.

6. Dillip Kumar Behera, Sanawaubari.

He expressed that people will be benefited due to the sand mining and he has no objections. He requested SPCB to look into the environment.

7. Krupasindhu Bhoi, Chasikhanda

He stated about the poor condition of the approach road/ramp at the river and requested the highest bidder and district administration to take care.

8. Arun Das, Chasikhanda

He stated that earlier there was sand mining without clearances. The present procedure should have been followed earlier to protect government property. He intimated that the local roads have been narrowed due to encroachment. He demanded for thicker roads so that there will be more load bearing capacity. He also demanded for wider roads by Government intervention so as to ensure road safety.

Points raised by the public during public hearing conducted on 27.09.2021 for Chasikhanda BiluakhaiNadi Sand Quarry, Tahasil- Biridi in the district of Jagatsinghpur

The public raised the following issues and apprehensions for redressal by the project proponent.

- 1. To strengthen village road by increasing its thickness so that load bearing capacity will be increased. Damaged roads should be repaired as and when required.
- 2. Approach road / ramp to river bed to be concreted so that it won't be washed away during flood or during heavy rains.
- 3. To plant trees in the river bank and other areas in consultation with villagers and district administration.
- 4. To transport sand by fully cover the vehicles to avoid spillage and to do adequate water sprinkling on the roads.

Views of Project Proponent on the issues raised by the public during the Public hearing.

Sri Suryakanta Pradhan, on behalf of the highest bidder addressed the issues raised by public and committed that

- 1. Strengthening of road shall be taken up with District administration by utilizing the district mineral fund. Transportation roads will be repaired as and when required.
- 2. Approach road / Ramp to the river bed will be concreted.
- 3. Plantation will be done at both sides of village road and other areas.
- 4. Sand transporting vehicles will be fully covered with tarpaulin and water sprinkling will be done on the roads.
- 5. Any other work required at schools/clubs will be taken up under CSR activities.
