PROCEEDINGS OF THE PUBLIC HEARING OF M/S HINDALCO INDUSTRIES LTD.- ADITYA ALUMINIUM REFINERY PROJECT (HIL-AARP) FOR ESTABLISHMENT OF ALUMINA REFINERY OF 3.0 MTPA ALONG WITH CO-GENERATION POWER PLANT OF 150 MW AT KANSARIGURHA VILLAGE UNDER KASHIPUR TEHSIL OF RAYAGADA & KORAPUT DISTRICT (FOR RAYAGADA DISTRICT) CONDUCTED ON 05.10.2021 AT 11.00 AM IN THE PLAY GROUND OF UTKALMANI GOPABANDHU HIGH SCHOOL, PODAPADI AT PUHUNDI UNDER KASHIPUR TEHSIL, DISTRICT-RAYAGADA.

The public hearing in respect of the above project was held on 05.10.2021 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in nearby villages of proposed project site and also published in Daily News Paper. The process followed for public hearing was adequate.

Er P Kar, Regional Officer, State Pollution Control Board, Rayagada welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Shri Somanath Pradhan, OAS(S) Additional District Magistrate, Rayagada presided over and supervised the public hearing. He briefed about the importance and objectives of such hearing and invited the project proponent to highlight on proposed project.

Dr Rama Chandra Rout, AVP of M/s Hindalco Industries Ltd explained about the proposed project and briefed about the Pollution Control measures to be adopted in the Project.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Rayagada.

1. Smt Jagyasini Kuria, Puhundi

Smt Kurai informed that, they have demanded for the Plant in their area before the Government since long & told mostly SC & ST people are residing here. She described Kashipur block area is undeveloped in health and education. She welcomed the company & stressed on establishment of the factory as early as possible. She hoped that Government & Company Authority will give attention for development Health, Education, communication provision of School & college in the locality. She informed that in 2014 Central Government framed Rules for Land acquisition & demanded for its implementation. She emphasised on establishment of good Schools & colleges in Kashipur Block for better education. She appealed to the villagers to support for establishment of the company in their area & not to disturb for overall development of the Region. She again welcomed the project & supported the hearing.

2. Sri Rajendra Duria, Podapadi

Sri Duria expressed his happiness & informed that they struggled for last 14 years for the project & now Government of Odisha has shown interest for establishment of the company through investment of Rs 8500 Crores. He thanks to District Administration & Company authority for the project & emphasised on establishment of the factory without further delay. He stressed on employment of the local youths, affected persons & development of Agriculture by the Odisha Government. He requested the company authority for setting up of the Alumina Plant with no time to make the public happy & extended his support for the Hearing.

3. Sri Pratap Chandra Singlal, Podapadi

Sri Singlal informed that, all are supporting for establishment of the plant by HINDALCO and expressed that, they have given their land for the project for development of the area. He further

informed that even Land belongs to Jagannath & High School also handed over to the HIDALCO for the project as everybody wants development of the area.

He informed that the site of the HINDALCO is unique as the mine is only 3 Km, Railway line is 1.5 Km & water source is 5 Km away. The project land is 50% General land, 30% SC/ST land & rest Government Land. He regretted for non-establishment of the plant even having such facilities. He explained the problems faced for which company could not be able to establish. He strongly recommended for establishment of Alumina refinery for the development. He expressed that they had given land for last 14 years without any benefit. He demanded employment of the locals for their livelihoods as all of them had given land & all are also supporting the project.

4. Smt Ribika Bagh, Puhundi

Smt. Bagh expressed that, their land has been acquired by Government for last 15 years, but no plant has yet been established. She informed that many of them had died with a hope of plant & demanded to declare when the plant will be established. She informed that their children are going to outside for the job & if such big industry will set up here then they will live happily. She appealed for unity & requested to fulfil their hopes.

5. Sri Bidyadhar Patra Choudhury, Kansariguda

Sri Choudhury informed that, Land was acquired long back for the project but due to some reason project could not be established. He described the unemployment as big pollution for the society and expressed that they had given land for development & employment of the locals. He requested to end the unemployment of the locality to curb pollution. He informed that, there is no medical facility in their area; however they are getting health facility from nearby hospitals of Utkal Alumina.

6. Sri Dinabandhu Jhodia, Kansariguda

Sri Jhodia informed that, after losing their land for so many years they are facing lots of difficulties & not able to get payment, not obtained certificate & their children are not getting admission in schools and even company did not help them. He requested to start the company immediately. He expressed that 09 persons of Kansariguda are still not able to get DP status. He demanded DP status of those 09 persons, Resurvey of households & Compensation as per Government norms.

7. Sri Arji Majhi, Kadapadar, Podapadi

Sri Majhi informed that Public hearing was conducted in 2008 for the company but company could not be established. He expressed that it seems from today hearing that their hope going to be fulfilled. He requested government to come forward for early establishment of the company for development of them and their area.

8. Sri Kansari Jani, Nartibeda

Sri Jani requested to make the office functional at Podapadi and to continue the developmental activities, Health facilities etc in their area for progress.

9. Sri Suresh Muduli, Puhundi, Podapadi

Sri Muduli welcomed the project on behalf of the local people & assured their cooperation for the project. He requested the Government for declaration of date on establishment of the project as there was Public Hearing in 2006-07 for the project but later that project could not be

established. He apprehended the repetition of the condition after this hearing & demanded for written declaration of the date of commencement & completion of the project through Government. If it is assured then they will completely cooperate & support the project.

10. Sri Nirakar Bash, Puhundi, Podapadi

Sri Bash informed that, Public Hearing was conducted in 2007 & and after 14 years again steps have been initiated for the project for which they are happy. He described about their struggle for the project & expressed that, all people of affected area & Kashipur block are supporting the project and requested to company to open the office after completion of public hearing for peripheral development work. He strongly demanded before the company for establishment of the HINDALCO Alumina Refinery project with 150 MW Power plant at Kansariguda as soon as possible to resolve local unemployment issues as they are going to outside for their livelihoods.

11. Sri Arjun Jhodia, Puhundi, Podapadi

Sri Jhodia expressed happiness as the plant is going to be established by Aditya Alumina and informed that unemployment problem in this area is very severe. Technical qualified youth i.e ITI, Diploma & Engineers are available in this area. They are going to Hydrabad, Viisakpatnam for job & hoped that, if Aditya Alumina Company will be established, those youths will get opportunity for employment & livelihoods to take care of their families. He welcomed the project & informed that their high school got acquired by the company & another school has been provided. Initially they got some grant from the company & later it has been stopped. Now 150 to 200 students are there in High School & facing financial crises. Presently they are getting 75% block grant & in future 100% will be provided for which Patta is required for the school. He requested the Collector to ask the company to provide Patta in favour of the school. He submitted a representation to the Chair.

12. Sri Bijay Ratan Choudhury, Kansariguda

Sri Choudhury expressed that, proposal for establishment of the project is there since long but not yet fulfilled. They are waiting for the project for last 23 years & displayed a document regarding advertisement for land acquisition of 08 villages in 1998. He drew attention of Government & company on difficulties faced by them in last 23 years. He informed that in 1998 there was no road, electricity, Bridge facilities in their area & initially they opposed the project & later they understood about the developments associated with the project & then supported the project with a hope. Further he informed in 2005 Company provided a High school as there school got displaced for the project. Later with help of Government 100 bedded hostel also constructed in the school but no Patta has yet been given in name of Podapadi Gopabandhu High school & he requested to provide the same for survival of school.

He informed that Kansariguda & Puhundi area is based on cultivation. In rainy season about 800 Ac & in summer 400 to 500 Ac get irrigated. He requested for commitment by company to protect & develop their agriculture in Ayacut for survival. Further he informed that the money they got in 2008-09 for their land has already been exhausted. He requested to start the company by 30th June 2022 or else they will go to Bhubaneswar to protest. He requested for establishment of company not assurance & hoped that they will get employment in the project. He suggested starting Training camp for the children of Land losers & affected area to make them fit for employment in the company. He expressed that there will be pollution due to such big Industry & urged that adequate preventive measures to be taken to protect them from pollution. He further informed that their area is a peaceful area & drew attention on two to three problems prevailing in their village. He requested to resolve the issues of the colony selected where many of them do not want to shift & the compensation to be given for the loss due to acquisition of land for last 10

to 12 years. He stressed on development of education, Health facilities for the public & issue of Patta to the school.

13. Sri Jawaharlal Bagh, Puhundi, Podapadi

Sri Bagh expressed that, they opposed for the plant in 1998 & in 2006 they got land cost & after starting the project work suddenly they stopped. The hope of better education, employment in the project ends there. He requested to declare the date of commencement of the project in this hearing before the media. He suggested for opening of the office, to start peripheral development work, Ambulance provision & Heath facilities by the company after completion of the hearing.

14. Smt Chanchala Jhodia, Puhundi, Podapadi

Smt Jhodia introduced herself as Tribal lady & expressed that, her only land had been acquired by the company and since last 10 to 12 years they are suffering due to lack of alternate livelihood. She expressed company should be established and demanded for stipend for old age people, education for the children and employment for two persons of their family. She informed that they do not have access to anybody & requested to fulfil her demand.

15. Smt Mathura Khara, Puhundi, Podapadi

Smt. Khara expressed that; company should be established as soon as possible. She informed land has already been acquired and there are no lands for cultivation for them. She informed that the Raw materials has been transported & questioned how company will be set up without raw materials. She demanded for declaration of the date for commencement of the company. She further informed that they are poor & no land for cultivation. She questioned that how they will survive & how their children get education as Government closed the school. She requested on behalf of SHG to the Government for establishing the company at the earliest and to provide employment to them.

16. Sri Threenetra Majhi, Kadapadar, Podapadi

Sri Majhi expressed that the gathering of the public in this Hearing is meant to welcome the project & requested to all to cooperate for fulfilling their hopes & dreams. He described their area as peaceful area & agriculture is the main source for them which have been destroyed for the project. He expressed that the public is having doubt on establishment of project as in spite of they welcomed the project since long but it yet to come. He supported the version of previous speaker regarding the unemployment is the main pollution of the area. He explained that the dreams of their youth in 2008 for getting employment in the project after their study have been destroyed. He informed that the education facility of the area is very bad & local students after completion of 10th standard are sitting idle in their home. He demanded for clarification on commencement of the project & requested to provide communication facilities to Laxmipur for the college going students of the locality. He further informed that the plant boundary passes through their village Kadapadar . Further he informed that Mines approached road & conveyor will also pass adjacent to their village & the river of his village also getting polluted, so he demanded DP status for their village. He stressed on declaration of commencement of the project by the Government & the company. He submitted a written representation to the chair.

17. Sri Khageswar Singh, Sialamala, Sungir

Sri Singh informed that they are not opposing for establishment of the company but the basic objective is development of the public of Kashipur Block. He questioned on quantum of employment given by Utkal Alumina and asked the villagers that how many Degree, Diploma, ITi,

BSc students of the locality got the employment in Utkal Plant. Further he expressed that if company will come they will develop, area will progress & youth will get employment. They are not opposing the plant & he informed company has written 8000 employment will be given. He questioned that how many employment given by the Utkal Alumina though they committed for 10000 employments. He demanded job for 90% of Kashipr public, ambulance provision in each hospital, High school in each Panchayat, English medium school in each Block & crematory ground in each village by the company. He urged that company should agree for the progress & Development of the Region by them prior to establish. Further he informed that they will submit their demands to the company in open stage and company has to fulfil their demands or else they will go for Andolan.

18. Smt Ahalya Mahapatra, Podapadi

Smt. Mahapatra submitted a written representation to the chair at the beginning of the hearing. She introduced herself as widow & informed she has given 10 Acs of land to the project. Her grandchildren are technically qualified but unemployed. She demanded for job to her grandchildren & 1 Crore as compensation.

19. Sri Damburudhara Sahani, Podapadi

Sri Sahani informed that their village is not included in DP list & demanded DP status for his village. He submitted a written representation to the chair.

20. Smt Manorama Bhatra, Puhundi, Podapadi

Smt. Bhatra queried about the purpose of this hearing & sought clarification whether this meeting is meant to take Kodingamali Bauxite or a false meeting for the plant. She expressed that they are poor & if big Company will be established they will get job for their survival. She demanded to declare the date for commencement of the plant as they already lost their hopes.

21. Sri Narendra Kandhapani, Puhundi, Podapadi

Sri Kandhapani demanded for written commitment of date of commence & date of completion of the project. He submitted a written representation to the chair.

The Regional Officer, SPCB, Rayagada read over the issues raised by the public in the hearing. Sri S K Mishra, Director of M/s Hindalco Industries Ltd responded to the issues raised.

The issues raised by the public and corresponding comments of the applicant were prepared in Odia and English and it is annexed with the proceedings as Annexure I & II respectively, list of the oral deliberators and participants in the hearing is annexed as Annexure III & IV respectively. 08 representations received during public hearing and seven representations received at venue after the hearing is annexed as Annexure-V (a to o). The videography of proceedings are recorded and submitted as DVD (I).
