

**PROCEEDINGS OF THE PUBLIC HEARING OF M/S GUNUPUR SAND BED II FOR EXPLOITATION OF RIVER SAND PRODUCTION OF 25100 CUM / ANNUM OVER AN AREA OF 5.261 Ha AT GUNUPUR VILLAGE, GUNUPUR TEHASIL IN THE DISTRICT OF RAYAGADA HELD ON 08.09.2021 AT 11.00 A.M. AT- TOWN HALL, GUNUPUR UNDER GUNUPUR MUNICIPALITY, RAYAGADA**

The public hearing in respect of the above project was held on 08.09.2021 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in surrounding villages and Gunupur Municipality areas of proposed project site and also published in Daily News Paper. The process followed for public hearing was adequate.

Er P Kar, Regional Officer, State Pollution Control Board, Rayagada welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Shri Somanath Pradhan, OAS (S), Additional District Magistrate, Rayagada highlighted on importance of such hearing & presided over the public hearing.

Sri Sarat Chandra Nayak, OAS (JB) Tehasildar, Gunupur & Sri Deba Prasad Choudhury, Project Consultant of M/s Gunupur Sand Bed II has explained about the proposed project and briefed about the Pollution Control measures to be adopted in the Project.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Rayagada.

**1. Sri Hrushikesh Ratha, Gunupur**

Sri Ratha expressed his dissatisfaction over the delay in starting the sand mines in spite of depositing the money & informed that due to delay public, Transporters & Labourers are economically affected.

**2. Sri Rabi Kaushalya, Gandhinagar, Gunupur**

Sri Kaushalya emphasized for supply of sand to the public for constructing their buildings under Abas scheme & requested the Government to start the sand mines at the earliest for the benefit of the public.

**3. Sri Devi Prasad Bauri, Bikrampur, Gunupur**

Sri Bauri supported the decision taken for sand mining & urged that it could have been done earlier so that it could be beneficial for construction under Abas Yojana, Government works etc. He also emphasized on supplying the sand at cheaper rate to the poor people.

**4. Sri Y. Ganapati Rao, Sriram Nagar, Gunupur**

Sri Rao explained the sand deficit problem in the area & expressed that transporters are unable to pay their loans & Labourers are not getting their livelihood due to non-functioning of sand mines. He demanded to ensure supply of sand to the Public of Gunupur & also the livelihood of labourers. He requested the Government to supply sand at cheaper rate to the Building constructed under

Pradhanmantri Abas Yojona & to the poor people of Gunupur by reducing Royalty & they have no objection to supply sand to other states.

**5. Sri Purna Chandra Mahankudo, Goudasahi, Gunupur**

Sri Mahankudo introduced himself as Retired Government Employee & informed that his own building construction has been stopped due to deficit in sand supply & COVID restrictions & also for very high price of sand. He requested to give permission to the auctioneer of sand mine at the earliest to supply sand to the public.

**6. Sri Purna Chandra Bauri, Bebartadehepa, Gunupur**

Sri Bauri informed that construction of Buildings under Abas Yojona was going on & also new construction will be started in near future by District Administration. Based on auction rate of sand, He requested to the Administration to find solution to help the poor people for their benefit. He informed that people are getting Rs 2 Lakh under Abas Yojona for their house & the sand price is around Rs 2000/- per tractor. He further informed that 30 loads of sand is required for house construction which costs Rs 60000/- per building & questioned that whether one can construct his house with such sand cost. He requested to the administration & to the public for finding a solution through discussion, so that people can get sand at the lowest price.

**7. Sri T Eswar Rao, Jailpada Street, Gunupur**


Sri Rao introduced himself as a poor person & expressed that sand cost is around Rs 1700/- to 1800/-. He requested that Government should get Royalty but they should get sand at cheaper price to construct their house as they have taken loans.

**8. Sri Naba Kishore Sahu, Secretary, Bansadhara Truck Association, Gunupur**

Sri Sahu informed that 04 to 05 years back there was tender for sand & about 40 to 50 Truckloads of sand got despatched to Visakapatnam & Vijayanagaram on daily basis but they could not benefited from Transportation. He supported the present auction process & also supported the previous speakers on price rate of sand for construction under Indira Abas & Pradhanmantri Abas Yojona. He further informed that now 10 to 12 wheelers Trucks are amply available in the area & requested to the administration to support them in transportation of sands to other states.

**9. Sri Subash Naga Bansha, Gandhinagar, Gunupur**

Sri Bansha expressed that no house can be constructed without sand. He informed that Hon'ble Prime minister Sri Narendra Modi declared Pradhan Mantri Abas Yojona in 2017. He told that Sand price per Truck load during that time was Rs 600/- & now it becomes Rs 2500/-. But the cost of House under that Yojona is still Rs 2 Lakh. He expressed his concern how the people will construct their house under Indira Abas & Pradhanmantri Abas Yojona & told that peoples under those schemes are suffering due to high price of sand. He further stressed up on the stoppage of sand Transportation to other states by the Government for benefits of local people. He further requested the Government that the beneficiaries of Abas Yojona should get sand at discounted price.





STATEMENT OF ISSUES RAISED BY THE PUBLIC AND COMMENTS OF THE

Sl No.	Issues raised by the public in hearing meeting	Response of the project proponent
i	No use of Mechnieries for sand mining.	The lessee shall be instructed to lift sand mining manually only not by using machinery. This specific point shall be reflected in the agreement deed to work out by the lessee and strict vigil shall be carried out to implement this point. In no way such machinery use shall be allowed.
ii	Engagement of local labourers for sand mining to get their livelihood	Naturally, local labourers are engaged in the lifting of sand mining. However, the lessee shall be instructed accordingly to look into the matter and engage local laborers to get their livelihood.
iii	Availability of sand in cheaper price for construction of house under Pradhanmantri Abas and Indira Abas Yojana to the public.	The lessee shall be instructed accordingly to provide sand at a cheaper price for the construction of Pradhanamantri Abash and Indira Abas Yojana to the beneficiaries. There is no provision of deduction of royalty under this scheme, it shall be provided at a cheaper price by the lessee.
iv	Engagement of local trucks for transportation purposes.	This is being used here and no outsider tractors is being used. Local tractors are being used for the transportation of sand mining. Accordingly, the lessee shall be instructed to use local trucks henceforth for transport of sand mining.
v	Stopage of sand transportation to other states for benefits of locals	As per instruction of guidelines from time to time sand mining is being transported to other states. Now, this shall be implemented as per the guidelines issued vide Sand Policy 2021 and this matter, the Tahasildar is not empowered to stop or issue direction for transportation of sand mining to other states.

But due to restriction imposed by the State Government on public gathering for up-surge of COVID infection in the State the public hearing scheduled above has been postponed. The same public hearing is now rescheduled to be held on 08.09.2021 at 11.00 A.M at Townhall, Gunupur under Gunupur Municipality, Rayagada district.

By virtue of Ministry of Environment, Forests & Climate Change, Government of India Notification No. S.O. 1533 (E) Dtd. 14.09.2006, the Board has been authorized to conduct environmental public hearing and as such invites suggestions, views, comments and objections on matters relating to environmental aspects of the proposed project from all the persons including bonafide residents, environmental groups and others located at the proposed site / sites of displacement / sites likely to be affected.
