**PROCEEDINGS OF THE PUBLIC HEARING FOR HAZARIDANGA STONE QUARRY (I-VIII) UNDER CLUSTER APPROACH FOR PRODUCTION OF STONE 27761 CUM/ANNUM OVER AN AREA OF 11.938 Ha AT HAZARIDANGA VILLAGE, UNDER KOLNARA TEHSIL OF RAYAGADA DISTRICT HELD ON 21.09.2021 AT 11.00 AM IN RMC GODOWN AT PEDALEKAPAI VILLAGE ( NEAR HAZARIDANGA MOUZA) UNDER KOLNARA TEHSIL, DISTRICT RAYAGADA.**

The public hearing in respect of the above project was held on 21.09.2021 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in surrounding villages of proposed project site and also published in Daily News Paper. The process followed for public hearing was adequate.

Er P Kar, Regional Officer, State Pollution Control Board, Rayagada welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Shri Somanath Pradhan, OAS (S), Additional District Magistrate, Rayagada highlighted on importance of such hearing & presided over the public hearing.

Sri Deba Prasad Choudhury, Project Consultant of Hazaridanga Stone Quarry (I-VIII) has explained about the proposed project and briefed about the Pollution Control measures to be adopted in the Project.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Rayagada.

**1. Sri KantaraoPirbakka,Bhatuli, Suri**

Sri Pirbakka informed that for 1<sup>st</sup> time such hearing being conducted in their area. He expressed that there are big pot holes in their approach road due to movement of crusher vehicles & suggested to fill up those pits with crusher dust & metals. He requested to support them for their development & provide chips & other supports for construction of their houses. He expressed that due to blasting stones are causing threat & get deposited on their fields. He suggested for taking safety precautions before blasting to avoid any damage to their live stocks & to people.

**2. Sri BipindarKantaBaga, Goudilelibadi, Kolnara**

Sri Baga emphasised on job opportunity for local unemployed youths to get their livelihoods. He urged that the commitment made in executive summary should be followed for their betterment. He informed that local youths are getting benefitted.

**3. Sri Naresh Nimaka, Hazaridang, Kolnara**

Sri Nimaka expressed that blasting being done at 50' depth leading to depletion in drinking water level & their live stocks are suffering. Further he told that the lands exist nearby getting affected & urged to stop deep blasting. He expressed that the crushers operating in their area causing dust pollution & affecting nearby agricultural lands. He suggested for water sprinkling & to provide tin barriers to protect their lands & for their benefit. He informed that they got road after submitting application before two years but road get damaged due to movement of heavy vehicles & they are facing problems for carrying patients & in communications. He requested to resolve the problems.

**4. Sri RamaraoKilaka,Attarada, Suri**

Sri Kilaka expressed that due to deep hole& heavy blasting, cracks developed in their houses & water get polluted. He apprehended that their livestockwill be affected for blasting & suggested for preventive measures to protect them. He informed that even blasting being carried out in morning hours & emphasised to follow the Blasting Rules. He requested to provide job opportunity to the local people for their livelihood& urged that wages should be given as per Government norms. He demanded that the Boulders & chips should be supplied to them at half of the rate for Indira Abas Yojana& other Government works.

**5. Sri GangadharHikaka, Sarpanch, Suri**

Sri Hikaka supported the demands of his previous speakers & appealed to provide job to the local village migrating labourers. He requested to supply metal, chips etc at cheaper rate to them.

**6. Sri Mohan Gouda, Bhujabala, Kolnara**

Sri Gouda expressed that due to operation of stone crushers local peoples getting employment & earning for their livelihoods. Vehicles are engaged leading to job opportunity for Drivers & labourers & they are getting good incomes.

**7. Sri AshutoshKillaka, ZillaParishad Member, Kolnara Block**

Sri Kilka initially speaks in his local language & then informed that there are two roads exist for Hazaridang & suggested to sprinkle water on roads from November to June for dust suppression & to maintain the road. He told that local people wants job in quarries to extract metals. Further he informed that the actual Lease holders of the Quarry are carrying out the blasting in proper way whereas the quarries sublet to others are doing the blasting in careless manner.


**8. MsSanjuMadangi, Hazaridang**

Ms Madangi drew attention regarding problems of her village &informed that their houses getting cracked repeatedly in spite of repairing due to blasting. She complained that the blasting are being carried out in haphazard manner & dusts emitted from blasting get deposited on their houses & on their agricultural lands causing reduction in yields.

Further she complained about bad road conditions causing problems for patients to reach in times & expressed her unhappiness over non-responding to such problems. She raised the problem of discrimination of gents & ladies labourers to get job & question on how ladies will survive. She demanded for help & cooperation for them.

**9. Sri ChidiBansaBasudev, Blugabal, Kolnara**

Sri Basudev expressed that it is a great day for them as they can express their views here on problems & benefits due to operation of stone crushers in their Panchayat. He informed that they used to go to Andhra or Bijayawada for their livelihoods but due to establishment of crushers in their panchayat they are getting good wages & able to save. He urged that crusher owners should give more job opportunity to local Drivers, Labourers, Ladies etc for their benefits. He informed that there is increase in Pollution in the locality & affecting their agriculture. He stressed on the prevention of pollution. Further he emphasised on proper action & attention on problems raised by the public.





It is brought to the notice of all concerned that The Tahsildar, Kolnara has proposed to have Environmental Assessment for Hazaridanga Stone Quarry (I to VIII) under cluster approach for production of 27761 cum/year of stone over an area of 11.938 ha. at Hazaridanga village, Kolnara tehsil of Radagada district to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Odisha. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.

By virtue of Ministry of Environment, Forests & Climate Change, Government of India Notification No. S.O. 1533 (E) Dtd. 14.09.2006, the Board has been authorized to conduct environmental public hearing and as such invites suggestions, views, comments and objections on matters relating to environmental aspects of the proposed project from all the persons including bonafide residents, environmental groups and others located at the proposed site/sites of displacement/sites likely to be affected.
