

PROCEEDINGS OF THE PUBLIC HEARING FOR BADA AGULA DECORATIVE STONE MINES CLUSTER WITH CLUSTER AREA OF 28.15 Ha (BADA AGULA DECORATIVE MINES 16.131 Ha AND BADA AGULA DECORATIVE MINES 12.019 Ha) OF M/S HINDUSTAN MINERALS INDUSTRIES HELD ON 30.09.2021 AT 11.00 AM IN THE FOREST BEAT SITUATED NEAR HUMAGUNJI VILLAGE UNDER BADA AGULA GRAM PANCHAYAT OF MUNIGUDA TEHSIL OF RAYAGADA DISTRICT

The public hearing in respect of the above project was held on 30.09.2021 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in surrounding villages of proposed project site and also published in Daily News Paper. The process followed for public hearing was adequate.

Er P Kar, Regional Officer, State Pollution Control Board, Rayagada welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Shri Somanath Pradhan, OAS (S), Additional District Magistrate, Rayagada highlighted on importance of such hearing & presided over the public hearing.

Sri Surya Kanta Sahu of M/S Hindustan Minerals Industries & Sri Jagabandhu Bisoi, representative of Kalyani Laboratories Pvt. Ltd, Consultant of the unit has explained about the proposed project and briefed about the Pollution Control measures to be adopted in the Project.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Rayagada.

1. Sri Purendra Pidikaka, Kanda Madakhalo


Sri Pidikaka complained that the approach road to his village in very bad shape & hoped that there will be some improvement due to mines. He informed that there childrens are going to Keral & Bombay for job & if mine will come up near to their village their children will get job there. He expressed that they will be happy if project comes. Further he expressed that they are facing many problems in their area due to lack of good road during rain & in spite of writing to Government there is no result. He hoped that the Mines will improve the road condition & youth will be employed. The local poor peoples will get their Livelihood & lead a happy life. He demanded that his Panchayat unemployed educated youth should be recruited in the mines & they will not allow for other panchayat youth to get recruited. He questioned on benefit of the project if their unemployed youths will not get job.

He stressed upon good road & water for their survival.

2. Sri Pramod Pradhan, Paika Madakhalo

Sri Pradhan hoped that the project will bring development in their area, road communication will be improved. He expressed his unhappiness regarding waste of time by their unemployed youths. He questioned on objection made by some people about the project & questioned whether they want development or not. He explained that the road will be developed due to project & it will open opportunity for their people to economically develop.

He expressed the difficulties faced by them due to lack of proper road & complained nobody wants their development. He appealed the villagers to cooperate for the project for their overall development.



3. Sri Subash Praska, Niali, Bada Agula

Sri Praska hoped that the mines will provide job to the local youth who used to go to other states as Dadan for their livelihood. He urged that if company helps then there will be development of road, education facilities, Health facilities & water supply in their area. He expressed that if the mines operate the local people will be benefitted.

4. Sri Wabika Adi, Kariguda, Agula

Sri Adi expressed that in last 30 years no body listen to them & there is no road, drinking water, electricity, Anganwadi & Doctor in Kariguda village. He informed that he is working in a Temple which is deprived of road, electricity & drinking water supply & requested Government officials to help & resolve the problems.

5. Sri Damodar Kadraka, Humagunji, Agula

Sri Kadraka expressed that if permission will be given to the mines to operate, the local people will get their livelihood & able to take care of their children & will give good education. He expressed due to bad condition of nearly 2 km road connecting from their village to Niali patients are suffering much. He stressed up on the repair of their village road for overall development.

6. Sri Biranchi Narayan Deo, Paika Madakhalo

Sri Deo supported the demands of previous speakers & expressed that proper work being done from Panchyat to city level but nothing is gained from city to Panchayat level.

The Regional Officer, SPCB, Rayagada read over the issues raised by the public in the hearing and Sri Jagabandhu Bisoi, representative of Kalyani Laboratories Pvt. Ltd, Consultant for project responded to the issues raised for M/s Hindustan Minerals Industries.

Shri Somanath Pradhan, OAS (S), ADM, Rayagada has given concluding remarks on the hearing and elaborated the process to be followed for submission of the proceeding to the SEIAA, Bhubaneswar for further action. He extended thanks to the public participated in the hearing and for offering their views, suggestions and objections.

The issues raised by the public and corresponding comments of the applicant were prepared in Odia and English and it is annexed with the proceedings as Annexure-I & II respectively, list of the oral deliberators and participants in the hearing is annexed as Annexure-III& IV respectively. Three numbers of written representation received from public during hearing are annexed as Annexure- V (a to c). The videography of proceedings are recorded and submitted as DVD (One number).



It is brought to the notice of all concerned that M/s Hindustan Minerals Industries has proposed to have Environmental Assessment for Bad Agula Decorative Stone Mines Cluster with cluster area of 28.15 Ha. (Bad Agula Decorative Mines 16.131 ha and Bad Agula Decorative Mines 12.019 ha.) in village Bad Agula under Muniguda tahsil of Rayagada District to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Odisha. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.

By virtue of Ministry of Environment, Forests & Climate Change, Government of India Notification No. S.O. 1533 (E) Dtd. 14.09.2006, the Board has been authorized to conduct environmental public hearing and as such invites suggestions, views, comments and objections on matters relating to environmental aspects of the proposed project from all the persons including bonafide residents, environmental groups and others located at the proposed site/sites of displacement/sites likely to be affected.
