PROCEEDINGS OF THE PUBLIC HEARING HELD ON 10.10.2021 (AT 11.00 AM) AT KHATA NO. 90 (RAKHIT), PLOT NO. 11/643, PURUNADIHI VILLAGE (GUPTESWAR HIGH SCHOOL) WITH RESPECT TO THE ENVIRONMENTAL ASSESSMENT OF DUBUNA SAKRADIHI IRON & MANGANESE ORE MINES OF M/S ODISHA MINING CORPORATION (OMC) LTD FOR PRODUCTION OF 3.0 MTPA IRON ORE AND 0.05 MTPA MANAGANESE ORE OVER MINING LEASE AREA OF 1332.019 HA. AT-DUBUNA AND SAKRADIHI VILLAGES OF KEONJHAR DISTRICT FOR ENVIRONMENTAL CLEARANCE.

The public hearing in respect of the project proposed by M/s. Odisha Mining Corporation Limited for production of 3.0 MTPA iron ore and 0.05 MTPA Manganese ore within mining lease area of 1332.019 Ha. in village Dubuna and Sakradihi in Barbil Tahasil of Keonjhar district was held on scheduled date & time with reference to:

I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and Amendments thereafter.

Shri Bishnu Prasad Acharya, Project Director, D.R.D.A, Keonjhar, supervised & presided over the public hearing process and was assisted by Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting, the Regional Officer, State Pollution Control Board, Keonjhar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of the project proposed by Dubuna Sakradihi Iron & Manganese ore mines of M/s. Odisha Mining Corporation (OMC) Limited.

Shri Behera explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public, gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Sri Abanikanta Pradhan, Regional Manager of M/s OMC Ltd. addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management and various other CSR activities envisaged in the proposed project.

Then Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar requested the public to give their views, comments, objections and opinions on the proposed project.

## The views expressed by various speakers on the proposed project are as follows:

#### 1) Smt. Laxmi Naik, General Secretary (OMJD), Basantpur, Sakradihi, Keonjar.

While speaking in favour of the Project, she was happy that ultimately Public Hearing could happen which was scheduled to be held on 24.4.2021, but due to Covid-19 restriction this was cancelled. She stated that with the efforts of the then Keonjhar Collector Mr. Balbant Singh the land pattern could be changed and the forest land was converted to non-forest land and the operation of mine could be started. Many people died in-between which is a matter of regret. Further, she told that people of three revenue villages depended upon OMC where 10-12 Contractors were engaged and economic condition of the local people was good. OMC has provided Electricity, Bore well, Tube well and school bus for this locality. She further demanded for construction of Maa Tarini temple, construction of school boundary wall, construction of concrete roads, employment to the 50% locals according to their qualifications, Electricity, Street light, Road, compensatory afforestation, fixing of street light, drainage and Education facility, promote of sports activities. She urged that mine should run with 80% manually and 20% through machines. Outside people should not be allowed for employment. One committee to be formed consisting of OMC officials and villagers to address the grievance of the local people time to time.

## 2) Sri Abhiram Naik, Ex-MLA, Kaijoda, , Keonjhar Sadar:

He expressed that since long the mine was not operating and now the Public Hearing is being conducted for opening of mine. So he urged the locals to ensure smooth operation of the mine. During operation many trees will be eradicated, hence they requested for compensatory afforestation at the same area. With the operation of mines, the movement of loaded vehicle will be increased for which OMC Management should ensure the road clearance. They said two numbers of water tankers are not sufficient for water sprinkling activities which needs to be increased to 4-6 tankers per day. Since this is a forest area, the elephant's nuisance happens, hence a proper elephant corridor to be explored. The 33/11 KV electric line need to be provided as the standard of the electric wire is very poor which should be looked into. Street light at Basantpur & Badakalimati need to be provided. Since it is an interior area and malaria prone area one ambulance is not sufficient to cater the need of the people. Moreover, Government 108/102 Ambulance is not always available, hence demanded for 2 (two) nos, of ambulance to be provided by M/s.OMC. He requested to provide school bus from Kalijoda to Basantpur. Since people of this area depend upon agriculture, he requested OMC to continue to provide seeds and fertilizers like previously done. Part time Teachers should be provided for 6/8 schools operating here as Government teachers are engaged for election duty and other Govt. jobs maximum times. Further, boundary wall in all the schools should be provided. Skill development programme and training for sports should be provided by M/s OMC. The employees who were deployed before closure of the mine should be rehabilitated. The Mines should operate with 80% manually and 20% through machines.

#### 3) Sri Sanatan Barik, Secretary (BKDS), Badakalimati Panchayat, Handibhanga:

While supporting the Public Hearing, he expressed that M/s.OMC should take care of Education by opening good schools like DAV, Adarsh and Ekalabya Bidyalaya. Further he told that proper health care facility, cold storage facility, training on sports, construction of temple to be provided by M/s OMC Ltd. He also requested the OMC to take the consent of the local people for employment whenever any further expansion of mine with belt line/ pipe line will take place. Further he demanded permanent employment for 80% of the local youth. He requested for training on Agriculture, providing lift irrigation, managing poultry firm, diary firm etc.

#### 4) Sri Santanu Barik, Ex-PS Member, Basantpur,:

While supporting the project, he told that private company operating here are not providing employment to them and hope with the operation of OMC Mines, employment will be generated. Further, he demanded for health care facility, supply of drinking water, developmental work in the existing schools, providing teachers, construction of 4-lane road, plantation to be done in the same locality where trees will be eliminated in view of mine expansion.

#### 5) Sri Balabhadra Patra, President (BKDS), Dubuna:

While speaking in favour of the proposed project, he expressed that in 1956 OMC started its mining operation and at that time the residents of this locality were facing great deal of difficulties. This area is mostly Adivasi populated area. The education standard is very poor. Hence, he demanded for good education facility by setting up schools like DAV & Ekalabya, a modernized well-equipped hospital with facilities of blood bank, construction of concrete road, implementation of proper rehabilitation policy for the affected person who will be displaced during expansion of the mine, plantation, street light, road safety, employment as per qualification. CSR fund details to be discussed for which he suggested to form a committee of villagers and M/s OMC Ltd. He suggested displaying the CSR fund/job details

#### 6) Sri Prafulla Tanty, Sakradih, Naibuga:

While speaking in favour of project, he told that due to closure of OMC mines since last 15 years, everybody could realize the bad impact. He demanded door to door water connection through deep bore well with tower mounted water tank, providing pucca house with toilets, providing free electricity, roads from Bamebari to Kalimati needs since the private buses are not able to ply due to bad road condition and plantation in the area. He requested State Govt. officials as well as OMC Management to look after to improve the road condition.

With regard to health care situation, he expressed that the district Govt. Medical is 50 KM away from here and many times the ambulance is delayed due to severe jam, hence requested for set up a 50 bedded well equipped modern hospital with facilities of CT scan, Ultrasound, X-ray and pathology in this locality and arrangement should be done to shift the critical patients to Bhubaneswar/Cuttack whenever required and the expenditure to be borne by OMC Ltd..

With regard to education, necessary teachers along with dance/sports teachers should be provided by the company which will attract the children towards education since this Adivasi populated area. He also requested for a general college and Engg. College for this locality. With regard to Sports, he demanded for providing training for sports and one mini stadium.

With regard to expansion of mines, he requested to follow rehabilitation policy for the displaced persons. He requested to do afforestation by massive plantation of trees.

## 7) Dr. Niladri Bihari Mishra, President Paribesh Surakhya Samiti, Joda:

While supporting the proposed project, he raised his concerned that now days pollution & Environment is a prime concern. Though environmental pollution is a concern nevertheless the developed countries like Africa Canada, USA etc. has not stopped their mining activities and they are doing this activities through new technologies. During Mines Environment and Mineral Conservation week (MEMC), conservation of minerals

especially with regard to Manganese ore is being discussed in detailed. Requested OMC management to take utmost attention during excavation Manganese ore so that it does not become dust as this is a very soft ore. He expressed his concern that cooperation from neither the Government nor from the public is there for wild life conservation. Moreover, for safe movement of elephant he requested to look for an elephant corridor.

#### 8) Sri Hiranya Kumar Naik, Ex-Sarpanch Basantpur, Kaijoda:

While supporting the project, he expressed that due to operation of Mines, rampant transporting activities will be there as a result the condition of road will further deteriorate. Parking arrangement should be done for the vehicle so that management of transportation can be done systematically. He told that the recruitment for the 4<sup>th</sup> grade staff should be conducted at Barbil not at Bhubaneswar. The sports activity should not be restricted to foot ball only there should be cricket, volley ball and other also.

#### 9) Sri Bibhisan Tanty, Naibuga, Dubuna:

While speaking in favour of the project, he stated that there should be a permanent solution for electricity supply. On many occasions, the power cut continued for 3-4 days due to heavy rain and thunderstorm. Only providing pole, wire and electrician is not enough, rather the OMC officials should think about underground electricity supply from Jurudi to Dubuna. He also demanded the concrete 4-lane road to overcome the problem of heavy traffic. Further, he demanded an alternative road for movement of bus, ambulance and bike etc. Free computer Education, a general and technical college, renovation/development and boundary wall of existing schools, Plantation etc. With regard to sports activities, he stated that from this area many sports persons have participated in state level and won gold, bronze and silver medal and proper training needs to be imparted to them to participate in National and International level.

#### 10) Ms. Sashi Sinku, Naibuga Panchayt, Basantpur:

While speaking in favour of the proposed project of M/s OMC Ltd., he stated that monetary help should be provided to them and priority should be given to ladies.

#### 11) Sri Dibakar Behera, Katupali:

While speaking in favour of the project, he raised his concerned about the adverse impact on agriculture due to mining activities. The livelihood of many villagers is depend upon agriculture. Run of mine water carrying the iron sludge are accumulated in their cultivation land, which result in infertility of land. In his address he stated that due to rampant mining operation the perennial source of natural stream getting dried day by day. So he requested to look into his concern so that there is continuous flow of water.

## 12) Smt. Jaymani Munda, Dubuna, Mundasahi:

She spoke in favour of the project proposed by M/s OMC Ltd.

#### 13) Smt. Astami Munda, Dubuna:

While speaking in favour of the project, she stated that with the operation of OMC, employment will be generated.

## 14) Sri Monoj Kumar Tanty, Sakradihi:

While speaking in favour of the project proposed by the mine, he requested OMC Management for proving teachers, construction additional adequate rooms for accommodation of teachers, construction of school boundary wall, plantation and employment, development of cattle grazing field. The people of this area are staying in forest land since last 50 years, so before their displacement due to mining expansion/activities they should be properly rehabilitated.

## 15) Sri Bapuji Mohakud, Jamupani, Dubuna:

While speaking in favour of the project, he demanded permanent employment, old age pension, new transformer and free electricity supply.

#### 16) Sri Satyananda Mohakud, Basantpur G.P.:

While supporting the Public hearing, he expressed that there should not be any partiality, hence a committee to be formed who will look after all the issue of the locality.

## 17) Sri Umakanta Barik, Pidhapokhari, Dubuna:

He expressed his concern that with the mining operations and eradication of trees the persons who were depend upon the forest products will be affected. Hence, he request for afforestation programme. He stated that as a result of opening of mine definitely the CSR activities will increase. He thanks OMC for obtaining NOC for construction of road. Further he demanded for 50 % employment to local youths, plantation and providing network facility, and attention to provide proper health care.

#### 18) Sri Radhakanta Naik, Nayagarh, Bamebari:

While speaking in favour of the project, he stated that this place is mostly Adivasi populated area. So he demanded for Adibasi hostel in their locality through ITDA.

#### 19) Smt. Shantilata Khuntia, Dubuna:

She supported the project proposed by the mine.

#### 20) Smt. Simadini Patra, Dubuna:

While supporting the public hearing, she stated that if the mine runs everybody will be benefited.

#### 21) Ms. Anami Champia, Dubuna:

While supporting the project proposed by the mine, she stated that earlier when the mine was in operation they were getting all the facilities but as a result of the non-operation of mine they are deprived of these facilities. So she hopes for operation of mine.

#### 22) Smt. Mina Patra, Dubuna:

While supporting the proposed project, she stated that by starting of the mine poor people will be benefited.

## 23) Smt. Basanti Patra, Active Member BKDS, Joda:

While supporting the project, she requested to look after repairing of the road, which is in very bad shape.

## 24) Smt. Bimala Penthei, Active Member BKDS, Khojuridihi:

She expressed her happiness and told that if this mines runs their local people will be benefited.

## 25) Smt. Surekha Patra, Active Member BKDS, Naibuga:

She supported the project and urged for smooth operation of mines.

#### 26) Smt. Rajani Patra, Purunadihi:

She opined for smooth run of mines as this mines has been closed since long. Further, she demanded that Bhubaneswar Head Office of M/s OMC Ltd. needs to be shifted to Dubuna.

#### 27) Smt. Geeta Naik, Purunadihi:

She supported the project proposed by the mine.

#### 28) Sri Prasanna Mohakud, Purunadihi:

While supporting the project of the mine and opening of the mines, he stressed upon the basic necessities like road construction, improvement in education, supply of drinking water.

## 29) Smt. Meena Naik, Naibuga:

While supporting the public hearing with respect to operation of mine, she requested the OMC authority to visit the nearby villages for identifying the issues in consultation with the villagers and try to solve.

#### 30) Smt. Baigani Naik, Naibuga:

She Supported the project proposed by the mine.

#### 31) Smt. Dolly Patra, Naibuga:

She supported the project proposed by the mine.

#### 32) Smt. Koili Patra, Sakradihi:

She expressed that her husband was working in this mines but after the demise of her husband she was in great trouble. So, she supported the Public Hearing and given her consent to operate the mines so that they can earn their livelihood.

## 33) Smt. Surekha Behera, Purunadihi:

While supporting the proposed project, she expressed her concern for noncompliance of road construction job since last one year the Kuchha Road could not be converted to pucca road. Further, she raised her concern by expressing that due to machine mining many people will lose their job.

## 34) Ms. Panapati Munda, Pidapokhari:

She supported the proposed project.

## 35) Sri Braja Kishore Mahakud, Basantpur:

While supporting the opening of the mines, he stated that the two villages Basantpur and Kalimati is Adivasi populated villages where 90% of the population is uneducated. So, he requested OMC Management to look after their interest for given them job as per Odisha Govt. mining guidelines.

#### 36) Sri Madan Patra, Purunadihi:

He requested for more manual mining operations than mechanized mining, so that people will not lose their job. Further, he requested permanent employment for the affected villages.

#### 37) Sri Gangadhar Barik, Jamupani:

He expressed his concern that due to the mine dump, in the rainy season the run of mine water carries iron ore sludge flows and fall onto their agriculture land and that accumulates on to their land. Due to sedimentation their fertile land becomes infertile. So he requested to give proper attention on to this issue. Further, he requested for elephant corridor safe movement and let the villagers live peacefully. Further he requested to provide electrical light post. At the end he supported the proposed project.

## 38) Sri Kabul Behera, Purunadihi:

While supporting the project, he requested the company authority to give direct and indirect employment to local youths. At the same time he stressed for focusing more on proper education of the children. He was more concerned for child health; in this regard he requested to deploy one child specialist.

## 39) Sri Parameswar Patra, Dubuna:

While supporting the proposed project of the mine, he demanded that all the transportation related jobs to be entrusted to locals who are affected by the mining operations instead of outside contractors.

#### 40) Sri Sudarshan Behera, Active Member BKDS, Dubuna:

Supporting the Public Hearing he pointed out that earlier residents of this area were dependent upon agriculture but due to the massive mining their agricultural lands become infertile. As a result they are compelled to depend upon the mines for their livelihood. He further requested to include their demand under EIA.

## 41) Sri Soren Daraiburu, Naibuga:

While supporting the Public Hearing he stated that most of the people of this area are Adivasi. So, he requested to look into the issues related to Advasi and provide employment.

#### 42) Sri Triban Champia, Active Member BKDS, Dubuna:

He supported the Public Hearing and requested to look into the electric line and network issues.

## 43) Sri Umakanta Barik, Pidapokhari:

He has given his view in writing to the Pannel Members. While supporting the project he requested that the demand of village Pidhapokari needs to be fulfilled.

#### 44) Sri Manoj Damal, Chudisahi, Basantpur:

He requested to utilize 1 to 2% of the DMF fund for the development of this area and their commitment needs to be fulfilled.

#### 45) Sri Arabinda Mahakud, Active Member, BKDS, Dubuna:

While supporting the proposed project of the mine, he requested to include their demand under EIA.

## 46) Sri Kirtan Munda, Active Member, BKDS, Dubuna:

Supporting the proposed project of the mine he stated that he has passed B.Com before 2 years but due to 2 years gap he is lagging behind to compete for the employment with the fresher's. So, he requested to arrange for training for their employability. Their demand should be included under EIA notification.

#### 47) Sri Bharat Chandra Mahanta, Basantpur:

He has given his consent to run the mine because since last 15 years the people of this locality has faced immense trouble due to unemployment. If mine will run, direct/indirect employment will be generated.

## 48) Sri Somnath Ghana, Katupalli, Dubuna:

He supported the proposed project of M/s OMC Ltd and demanded for permanent employment. He also stated that the demand of BKDS needs to be resolved through EIA notification.

## 49) Sri Ashok Kumar Maharana, Badakalimati:

While speaking in favour of the project, he told that the demand of BKDS needs to be resolved through EIA notification.

#### 50) Sri Nanda Kishore Barik, Kalimati:

He supported the proposed project of the mine and stated that the demand of BKDS needs to be resolved through EIA notification.

#### 51) Sri Sarat Patra, Naibuga:

He supported the project proposed by M/s OMC Ltd.

#### 52) Sri Gurba Munda, Sakradihi:

He supported the project proposed by M/s OMC Ltd.

#### 53) Sri Madan Mohan Behera, Katupalli:

Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns expressed by the speakers with the inclusion of comments of the applicants, read over to the audience at the end of the proceedings explaining the contents in Odia language and the agreed minutes of public hearing meeting is prepared. The statement of issues and concerns of public with the comments of applicant, prepared in Odia and English language is annexed as per Annexure- 1 & II. List of participants is annexed as per Annexure- III.

The President of Public Hearing, Shri Bishnu Prasad Acharya, Project Director, D.R.D.A, Keonjhar ratified the minutes of meetings with the views and demands of public. He extended his vote of thanks to the public for rendering their co-operation for smooth operation of the public hearing.

The meeting ended with a vote of thanks to the chair and the participants.

The issues raised at the public hearing meeting are the following:	Shri Ashok Kumar Behera, General Manager (Personal & Administration) of M/s Odisha Mining Corporation (OMC) Ltd. in his reply to the issues raised during the public hearing stated as below:
> Employment to local people	Shri Behera assured for 499 direct employment and around 2000 indirect employment. Skill development trainings will be conducted for the youths of the concerned locality for skill up-gradation and the youths will be engaged accordingly. Focus will be given for SHG group for women empowerment.
➤ Health	Regarding health, he said that one 20 bedded hospital having all the amenities will be set up in the locality very soon for the benefits of the locals. Further, two numbers of ambulances will be provided for emergency needs of the people.
➤ Education	Shri Behera said that already a 40 seated bus has been provided for the school children, which is presently not running due to COVID-19 pandemic but it will continue further. Necessary renovation of schools and its boundary wall constructions will be carried on. Regarding Computer education, OMC management will visit and explore the possibility for computer education. He also assured that initiatives will be taken for small children for easy attraction towards studies.
> Agriculture	He said that agriculture is a most important issue as most of the people depend on agriculture. So, for getting better yield from agriculture and for enhancement in agricultural sector different training programs will be arranged for students and farmers of the locality.

He said that for the safety of the environment responsibility has been given to IIT Bhubaneswar to conduct research on how to conserve the perennial water and nallahs of Dubuna, and how to make ground water recharge through check dams and preserve the water for reuse in summer so that the locals will not face water scarcity. Further he added that necessary dump management and pollution control measures will be taken care of.

Plantation

He said that OMC will carry out more plantation work in the coming days and it will be carried out from the CSR funds.

Road Safety

Shri Behera said that Dubuna-Kalimati road will be constructed very soon after getting the forest clearance. 


