Public consultation (hearing) of Sri Prabodh Mohanty for KJST Iron Ore and Bauxite Mines was Held on 29.09.2021 At 11.00am at Sidimba Community Centre near Anganwadi Centre at Sidimba village of Dengula G.P under Koira Block of Sundargarh District in the state of Odisha for their application relating environmental clearance for expansion In Iron Ore Production Capacity from 2.0169 To 2.80 MTPA Rom (2.41 MTPA Iron Ore + 0.39 MTPA Mineral Reject), Iron Ore waste 1.50 MTPA, Top Soil 0.008 MTPA and Bauxite Production Capacity 0.13 MTPA ROM, Bauxite Waste 0.10 MTPA (Total Excavation 4.538 MTPA) along with 3 Crushing Units (2 Existing 1 Proposed) and 5 Screening Units (3 Existing 2 Proposed) over ML Area of 188.268 Ha. in villages Kalamanga, Jaldihi, Sidimba and Tentigarm. Addl. District Magistrate (ADM), Sundargarh presided over the consultation (hearing) meeting. In the beginning, the Regional Officer, Rourkela of State Pollution Control Board, Odisha explained the villagers on the aspects of consultation (hearing) for environmental clearance under E. I. A. Notification, 2006 and invited representative of KJST Iron, Manganese and Bauxite Mines to address public details about expansion project and its environmental aspects for their views onward. Sri Prabodh Mohanty, Lessee of the mine addressed public on the expansion project and its environmental aspects. ADM then invited the public to address their views on environmental aspects of the project. 41 nos. of villagers opined their views as mentioned below. Attendance sheets of villagers present (Annx. I) and addressed views (Annx. II) are annexed.




