PROCEEDINGS OF THE PUBLIC HEARING MEETING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT OF SUBARNAPUR SAND BED MINES PROPOSED BY TAHASILDAR, CUTTACK SADAR ON RIVER KATHAJODI OVER AN AREA OF 8.30 HECTARE OR 20.50 ACRES AT VILLAGE SUBARNAPUR UNDER CUTTACK SADAR TAHASIL OF CUTTACK DISTRICT

The Public Hearing meeting in respect of Environmental Impact Assessment of Subarnapur Sand Bed Mines proposed by Tahasildar, Cuttack Sadar on River Kathajodi over an area of 8.30 hectare or 20.50 acres at village Subarnapur under Cuttack Sadar Tahasil of Cuttack district was held on 24.09.2021 at the entry point of Subarnapur Sand Bed Mines, Cuttack Sadar Tahasil in Cuttack district, Odisha at 11.30 am with reference to:

- 1. EIA Notification S. O. 1533(E) dated 14.09.2006.
- 2. Interim Operational Guidelines.

The Panel consists of the following members:

- 2. Dr. Sohan Giri, Regional Officer, State Pollution Control Board, Odisha, Cuttack

At the outset, welcoming the members participating in the meeting presided over by the Additional District Magistrate, Cuttack, the Representatives of State Pollution Control Board, Odisha, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by the Tahasildar, Cuttack Sadar.

Welcoming the public, Dr. Sohan Giri, the Regional Officer, State Pollution Control Board, Odisha, Cuttack, explained the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public.

The Tahasildar, Cuttack Sadar, project proponent, addressed the committee members and the assembled public and informed that they have engaged Environment Consultant i.e. M/s. Kalyani Laboratories Pvt. Ltd., Bhubaneswar for this project and requested them to make a presentation about the project. Sri Sudir Kumar Barik, representative of M/s. Kalyani Laboratories Pvt. Ltd addressed the panel members and the assembled public made a brief

presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, afforestation programme and various other CSR activities envisaged in the proposed project.

Then Dr. Giri, Regional Officer, State Pollution Control Board, Cuttack requested the public to give their views, comments, objections and opinions on the proposed project.

The following speakers gave their views on the above said project, which is given as follows:

1. Sri Swadhin Mohanty, Chandini Chowk, Cuttack:

He welcomed the dignitaries and public present in the meeting. He said that Subarnapur sand quarry is an old quarry and it is benefited for the local people, many vehicles and truck owners. He also informed that Government is doing many development activities in which many construction activities are done for which sand is required. Further he mentioned that local people had lost their income due to non-operation of this sand quarry since last one and half year and they have also suffered due to Covid-19 restriction. He said that local people will be benefited if the sand quarry will operate.

2. Sri Partha Mohanty, Chandini Chowk, Cuttack:

He welcomed the dignitaries and public present in the meeting. He said that if the sand quarry will be operated then local people will be benefited. So the sand quarry should be allowed.

3. Sri Satyajit Mohanty, Chandini Chowk, Cuttack:

He welcomed the dignitaries. He informed that he is a businessman connected with sand business and he is affected due to the non-operation of the sand quarry and he will be benefited if it would operate. Further he mentioned that people will get employment due to the operation of the sand quarry and urged that this sand quarry should be operated as soon as possible.

At the outset total three nos. of people had registered their names to express their views, comments etc. and deliberated their views accordingly.

After all the speakers completed their respective opinion and suggestion, the Regional Officer, Cuttack asked the project proponent to give relevant reply, if any to the issues raised. Sri Sambit Kumar Garnayak, Tahasildar, Cuttack Sadar as well the project proponent committed that he will take necessary pollution control measures

and comply with the conditions given in the Environmental Management Plan. Finally the Regional Officer requested the Additional District Magistrate, Cuttack to give his views on the public hearing meeting.

He said that due to operation of sand quarry sand will be easily available for the construction activity. He also mentioned that the water bearing capacity of the river will increase due to excavation of sand from the river bed. He stated that as observed in the meeting people have no objection regarding operation of the Subarnapur sand quarry so the project proponent should carry out with the promises and the CSR activities as mentioned in their project report.
