PROCEEDINGS OF THE PUBLIC HEARING HELD ON 06.12.2021 (AT 11.00 AM) AT BAITARANI RESERVE FOREST (03 KMS FROM VILLAGE KHANDBANDH AND ABOUT 20 METERS FROM DALPAHAD BASTI UNDER BAITARANI RESERVE FOREST (A) AREA) WITH RESPECT TO ENVIRONMENTAL ASSESSMENT OF KHANDBANDH IRON ORE MINE OF M/S SREE METALIKS LIMITED FOR ENHANCEMENT OF IRON ORE PRODUCTION CAPACITY FROM 0.702 MTPA TO 1.5 MTPA ALONG WITH CRUSHING AND SCREENING PLANTS OVER MINING LEASE AREA OF 35.774 HA. IN BAITARANI RESERVE FOREST NEAR KHANDBANDH VILLAGE UNDER BARBIL TAHASIL OF KEONJHAR DISTRICT FOR ENVIRONMENTAL CLEARANCE.

The public hearing in respect of the project proposed by Khandbandh iron ore mines of M/s. Sree Metaliks Limited for enhancement of iron ore production capacity from 0.702 MTPA to 1.5 MTPA along with crushing and screening plants over mining lease area of 35.774 Ha. in Baitarani Reserve Forest near Khandbandh village under Barbil Tahasil of Keonjhar district was held on scheduled date & time with reference to:

I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and Amendments thereafter.

#### The Panel consisted of the following members:

- 1. Sushma Bilung, Additional District Magistrate, Keonjhar
- Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar, Odisha

Sushma Bilung, Additional District Magistrate, Keonjhar, supervised & presided over the public hearing process and was assisted by Shri Puskar Chandra Behera, Regional Officer. State Pollution Control Board, Keonjhar, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting, the Regional Officer, State Pollution Control Board, Keonjhar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of the project proposed by Khandbandh Iron Ore Mines of M/s. Sree Metaliks Limited.

Shri Behera explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public, gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Sri Satya Sundar Kar, Vice President (Commercial) of M/s Sree Metaliks Limited addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed project, environmental management. pollution control measures, waste management and various other CSR activities envisaged in the proposed project.

Then Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar requested the public to give their views, comments, objections and opinions on the proposed project.

## The views expressed by various speakers on the proposed project are as follows:

#### 1) Smt. Tulashi Babonga, Ex-Sarpanch, Present PS Member of K-13, Mereda Panchayat:

She expressed her joy by stating that M/s. Shree Metaliks will enhance their production capacity due to which many poor persons will be able to earn their livelihood and create employment opportunity. She wholeheartedly supported the proposed production enhancement of the mine.

#### 2) Sri Santosh Kumar Bal, Ex- Counselor Bichakundi:

While supporting the production enhancement of the mine, he expressed that due to mining operations many old perennial trees will be destroyed but this can be overcome if we follow the Government's given afforestation guidelines for compensatory tree plantation. At the same time he told that raw material production is a must which adds 10-11% to our annual GDP and now a day's people cannot fully depend upon the cultivation. So, he stressed upon the company authority for direct/indirect employment to affected persons. At the end he requested for providing drinking water, quality education, Central Point Play School, Transportation facilities, regular water sprinkling for dust suppression etc.

#### 3) Sri Abinash Sahu, Ward No.14, Bichakundi:

While supporting the Public Hearing he expressed that with the enhancement of production of the existing mine the businessmen can flourish. At the same time he requested for employment to the persons residing around the radius 5/10 KM and development through CSR activities and take appropriate steps to mitigate the dust pollution.

#### 4) Sri Ullash Chandra Parida, Khandbandh:

He supported the Public Hearing as company is going to enhance its production capacity. He requested for looking after the education, health, sponsoring Govt. sponsored residential education to the poor, repairing of road, one ambulance. He requested to specially focus on health condition of local people by proper councilling.

#### 5) Sri Bikram Das, Ward No.14, Bichakundi:

He supported the proposed production enhancement of the mine and requested for providing facilities like education, drinking water and employment.

## 6) Sri John Hembrom, Kundurpani:

While supporting the Public Hearing, he expressed that they are depend upon this mines since their God father's period.

# 7) Smt. Pankajini Giri, Kundurpani:

While supporting the Public Hearing she expressed her happiness as many persons are working in this mine as driver and due to transportation their people can earn their livelihood by selling handia and rasi and opening other shops.

# 8) Sri Bibek Mishra, Dalpahar:

While supporting the production enhancement of the mine he raised his concern for the bad road condition and dust generation. He requested for water sprinkling on the road. He also requested for providing medical facilities, education as most of the local people are very poor and cannot afford for getting education in private schools. He requested company authority to specially look into upliftment of sports activities and employment.

#### 9) Sri Suresh' Patra, Khandbandh:

While supporting the proposed production enhancement of the mine he gave suggestion for basic necessities of the local people:

- As education facilities are not good in the area and no provision of higher education, so he requested to look into this.
- > Basic requirements of the existing schools need to be fulfilled by providing teachers.
- He requested for Anganbadi and one play school for the local children so that this will attract them for further higher education.
- > Communication facilities to be provided for medical emergencies by providing one Ambulance
- Providing employment
- As the telephone networks are very poor in the area, he requested for providing proper network facilities.

# 10) Sri Surendra Mohan Sahoo, Khandbandh village:

While supporting the Public Hearing he raised his concern that few years back they were moving in this area fearlessly. There was no pollution concern. So he requested to take appropriate steps for dust control. At the same time he requested for providing education facilities, medical facilities and employment.

#### 11) Sri Anadi Pingua, Khandbandh:

While supporting the Public Hearing he expressed that by enhancing the production capacity will increase the employment opportunities.

#### 12) Smt. Sabita Pradhan, President, Bichakundi Mahila Samiti:

While supporting the proposed production enhancement, she requested the Company Authority to supply the saplings for plantation in her area and provide employment.

#### 13) Sri Pramod Kumar Behera, Ward No-14, Bichakundi:

He supported the Public Hearing.

#### 14) Smt. Sujata Naik, Khandabandh Village:

While supporting the Public Hearing, she requested the company to provide Medical support, Education and Employment.

#### 15) Smt. Lalita Lohar, Ward Member, Khandbandh village:

While supporting the Public Hearing, she requested the company to provide employment, drinking water and electricity to the local villagers and to construct the roads of their locality. Further she told that since they have no landed property, they depend on Mines for managing their livelihood but because of stoppage of transportation they are facing difficulties. With regard to roads, she requested for repair of road from Khondbond to Jurudi. She also told that the Company should look into their day to day problem.

#### 16) Smt. Laxmi Deogam, Kundurpani:

While supporting the Public hearing, she stated that Company should fulfill all their demands/grievances.

#### 17) Smt. Kuntala Patra, Dalpahar:

While supporting the Public hearing, she told that there is no fencing in the bore well and solar panel, so she requested company to provide boundary wall and to provide street light in their villages.

### 18) Sri Bishnu Lohar, Kundurpani:

While supporting the Public hearing, he requested the company to provide bus facility, supply of drinking water and sports activities.

#### 19) Sri Pradumna Kumar Behera, Ward No:14, Bichakundi:

He supported the Public hearing.

#### 20) Sri Rasika Birua, Khandbandh:

He demanded the company for employment.

#### 21) Smt. Rajani Naik, Kundurpani:

While supporting the Public hearing, she requested for construction of road, providing lady teacher to their school, bus for school going children and an ambulance as the patients are facing difficulties while shifting to Joda for better medical treatment.

# 22) Sri Shyam Sundar Samasi, Khandbandh village:

While supporting the public hearing wholeheartedly, he told that 7 years back Public hearing was conducted at this locality and they supported it. He further told that unemployment is the prime concern of this locality. So, with the operation of the Mines, unemployment problem will be solved and there will be all round development of these areas. He requested for providing employment as per their educational qualifications.

The Panel received **03 nos.** of written representations of the local people demanding different facilities in the locality during the hearing which are enclosed herewith in original.

#### Observation:

The overall opinion of the public about the proposed project was favorable. However, the local people have some aspirations as laid down in their deliberations.

Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns expressed by the speakers with the inclusion of comments of the applicants, read over to the audience at the end of the proceedings explaining the contents in Odia language and the agreed minutes of public hearing meeting is prepared. The statement of issues and concerns of public with the comments of applicants, prepared in Odia and English language is annexed as per Annexure- I & II. List of participants is annexed as per Annexure- III.

The President of Public Hearing, Sushma Bilung, Additional District Magistrate, Keonjhar ratified the minutes of meetings with the views and demands of public. She extended her vote of thanks to the public for rendering their co-operation for smooth operation of the public hearing.
