The Public Hearing meeting in respect of Environmental Impact Assessment of Brahmapur Sand Bed Mines proposed by Tahasildar, Cuttack Sadar on River Kathajodi over an area of 5.26 hectare or 13.00 acres at village Brahmapur under Cuttack Sadar Tahasil of Cuttack district was held on 28.10.2021 at Community Hall near Sapneswar temple, Brahmapur, Cuttack Sadar Tahasil in Cuttack district, Odisha at 11.30 am with reference to:

- 1. EIA Notification S. O. 1533(E) dated 14.09.2006.
- 2. Interim Operational Guidelines.

The Panel consists of the following members:

- 1. Sri Purna Chandra Mishra, OAS (S), Additional District Magistrate, Cuttack
- 2. Er. Rashmita Priyadarshini, Regional Officer, State Pollution Control Board, Odisha, Cuttack

At the outset, welcoming the members participated in the meeting presided over by the Additional District Magistrate, Cuttack, the representatives of State Pollution Control Board, Odisha, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by the Tahasildar, Cuttack Sadar.

Welcoming the public, Er. Rashmita Priyadarshini, Regional Officer, State Pollution Control Board, Odisha, Cuttack, explained the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. She asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public.

Sri Sanjay Kumar Panda, Additional Tahasildar, Cuttack Sadar, on behalf of the Tahasildar, Cuttack Sadar (project proponent), addressed the committee members and the assembled public and informed that they have engaged Environment Consultant i.e. M/s. Kalyani Laboratories Pvt. Ltd., Bhubaneswar for this project and requested them to make a

presentation about the project. Sri Mrulyunjay Das, representative of M/s. Kalyani Laboratories Pvt. Ltd addressed the panel members and the assembled public. He made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, afforestation programme and various other CSR activities envisaged in the proposed project.

Then Er. Rashmita Priyadarshini, State Pollution Control Board, Cuttack requested the public to give their views, comments, objections and opinions on the proposed project.

The following speakers gave their views on the above said project, which are given as follows:

1. Sri Samir Kumar Panda, Secretary Bayalish Mouza Durga Puja Committee,
Cuttack:

He welcomed the dignitaries and public present in the meeting. He said that the sand quarry will operate and government will get revenue but due to its operation problem should not occur. There should not be problem on road, pollution should be controlled, accident should not be happened and the vehicles movement should done in a proper way so that public should not face any problem. He requested the administration to take care of the issues of blockage of road by Cattles. He also requested to administration that the sand quarry will provide help to their Dutga Puja committee. He mentioned that the possibility of conversion of land to Gharabari has been stopped in this area and if it will not be done than where the sand will be used. He requested the administration to look into the issues of land conversion, traffic management and cooperation to be provided for their Puja committee.

2. Sri Meghanath Das, Representative of Sarpanch of Brahmapur Gram Panchayat:

He welcomed the dignitaries and public present in the meeting. He said that the public hearing is done for the benefits of public. So the public opinions are taken before the operation of the Brahmapur sand bed mine. He mentioned that if the sand quarry will operate than poor people will get sand easily for construction of house under Pradhanmantri Abas yojana, Mo Kudia, Mo Pakka Ghar etc. and this is the main objective of Government. Further government will get revenue from the sand quarry and it will be used for the benefits of the public. He also intimate that road is narrow and cattle are sleeping on both sides of road so the issues need to be solved and accidents not to be happened. He informed that if the raised issues are solved than they have no objection if the sand quarry will operate.

At the outset total two nos, of people had registered their names to express their views, comments etc. and deliberated their views accordingly.

After all the speakers completed their respective opinion and suggestion, the Regional Officer. Cuttack asked the project proponent to give relevant reply, if any to the issues raised. The Additional Tahasildar, Cuttack Sadar on behalf of the Tahasildar, Cuttack Sadar (project proponent), explained the public about the rules regulation related to land conversion. Further he said that they will instruct the lessee to manage the traffic movement to avoid accident. He committed that necessary pollution control measures will be taken and the stipulations made in the Environmental Management Plan will be complied. Finally the Regional Officer requested the Additional District Magistrate, Cuttack to give his views on the public hearing meeting.

Then the President of Public Hearing meeting, Sri Purna Chanda Mishra, Additional District Magistrate, Cuttack welcomed all the government officers and public presented in the meeting. He said that as observed people gave their views in support of the Brahmapur sand quarry. He stated that by the operation of the sand quarry sand will be available easily and illegal mining will be stopped and Government will get revenue. Further he mentioned that the lessee will do CSR activity as proposed in the Environmental Management Plan and the lessee will take care of the vehicular movement due to the sand mining activity so that local people will not suffer.

Finally, the Regional Officer, Cuttack ended the meeting with thanks to the Chair.
