

PROCEEDINGS OF THE PUBLIC HEARING MEETING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT OF UTTAMAPUR SAND BED MINES PROPOSED BY TAHASILDAR, CUTTACK SADAR ON RIVER KUAKHAI OVER AN AREA OF 5.67 HECTARE OR 14.00 ACRES AT VILLAGE UTTAMAPUR UNDER CUTTACK SADAR TAHASIL OF CUTTACK DISTRICT

The Public Hearing meeting in respect of Environmental Impact Assessment of Uttamapur Sand Bed Mines proposed by Tahasildar, Cuttack Sadar on River Kuakhai over an area of 5.67 hectare or 14.00 acres at village Uttamapur under Cuttack Sadar Tahasil of Cuttack district was held on 03.11.2021 at Acharya Harihar Government High School, Uttamapur, Cuttack Sadar Tahasil in Cuttack district, Odisha at 11.30 am with reference to:

1. EIA Notification S. O. 1533(E) dated 14.09.2006.
2. Interim Operational Guidelines.

The Panel consists of the following members:

1. Sri Bijay Kumar Khandayatray, OAS (SAG), Additional District Magistrate, Cuttack
2. Er. Rashmita Priyadarshini, Regional Officer, State Pollution Control Board, Odisha, Cuttack

At the outset, welcoming the members participated in the meeting presided over by the Additional District Magistrate, Cuttack, the representatives of State Pollution Control Board, Odisha, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by the Tahasildar, Cuttack Sadar.

Welcoming the public, Er. Rashmita Priyadarshini, Regional Officer, State Pollution Control Board, Odisha, Cuttack, explained the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. Then Sri Bijay Kumar Khandayatray, Additional District Magistrate, Cuttack welcomed all and asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public.

Sri Sambit Kumar Garnayak, Tahasildar, Cuttack Sadar, project proponent, addressed the committee members and the assembled public and informed that they have engaged Environment Consultant i.e. M/s. Kalyani Laboratories Pvt. Ltd., Bhubaneswar for

Environment Impact Assessment of this project and requested them to make a presentation about the project. Sri Sudhir Kumar Barik, representative of M/s. Kalyani Laboratories Pvt. Ltd addressed the panel members and the assembled public. He made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, afforestation programme and various other CSR activities envisaged in the proposed project.

Then Sri Bijay Kumar Khandayatray, Additional District Magistrate, Cuttack requested the public to give their views, comments, objections and opinions on the proposed project.

The following speakers gave their views on the above said project, which are given as follows:

1. Sri Debabrata Barik, Uttamapur, Cuttack :

He welcomed the dignitaries and public present in the meeting. He said that the Uttamapur sand Bed Mine should operate so that people will get benefit and their livelihood will be better.

2. Sri Raj Kishore Samal, Uttamapur Tota Sahi, Cuttack :

He welcomed the dignitaries and public present in the meeting. He said that they are facing problem as the sand quarry is not in operation and sand is coming from outside. So if the sand quarry will operate it will be benefited for all. He stated that it will be better if plantation will be done on river embankment.

3. Sri Partha Sarathi Mahanty, Uttamapur, Cuttack :

He welcomed the dignitaries and public present in the meeting. He said that it is a welcome decision of district administration to give the project of the sand quarry and he thanks them on behalf of his villagers. Further he stated that the villagers of Uttamapur are very poor and it is difficult for them to purchase sand for construction of house as sand is coming from distance place. He said that the commitment made by the project proponent like doing plantation and development activity of school are also welcoming decision. He mentioned that the unemployed youth of the village will also get employment. He said that he will be obliged if such project will be given for their village.

4. Sri Sanjay Samal, Uttamapur Tota Sahi Cuttack :

He welcomed the dais and the people and spoke that, it is a good decision that the Uttamapur Sand Bed Mine will operate. He said that he is a poor person and he is

unable to construct house due to higher price of sand so if the village sand quarry will operate he will able to construct his house.

At the outset total four nos. of people had registered their names to express their views, comments etc. and deliberated their views accordingly.

After all the speakers completed their respective opinion and suggestion, the Additional District Magistrate, Cuttack asked the project proponent to give relevant reply, if any to the issues raised. Sri Sambit Kumar Garnayak, Tahasildar, Cuttack Sadar as well the project proponent said that the public present here wants that the sand quarry to be operated so that construction activity will be done and people will get employment. He mentioned that he will take necessary pollution control measures and comply with the conditions given in the Environmental Management Plan.

Then the President of Public Hearing meeting, Sri Bijay Kumar Khandayatray, Additional District Magistrate, Cuttack said that the Tahasildar the project proponent said detail about the project. He realised that there is requirement of sand for construction activity. So people will get benefit if sand will available nearby their area. He stated that as stated by the project proponent they will take measures to protect environment as committed by him. Pollution Control Board and district administration are watchful on the activity and how the environment will get protected.

Finally, the Regional Officer, Cuttack ended the meeting with thanks to the Chair.


