

PROCEEDINGS OF THE PUBLIC HEARING OF M/s. UPPER LANTH IRRIGATION PROJECT FOR CONSTRUCTION OF HOMOGENOUS EARTH FILL DAM ACROSS RIVER LANTH AT CHIKILI VILLAGE, BELPADA TAHSIL OF BALANGIR DISTRICT BY THE EXECUTIVE ENGINEER, PADAMPUR INVESTIGATION DIVISION, PADAMPUR HELD ON 10.12.2021 AT: 11.00 A.M. FOR PANDAKIMAL VILLAGE AND AT: 2.30 P.M FOR JAMJURI VILLAGE AT: COMPANY GROUND, JAMJURI VILLAGE, DISTRICT BALANGIR.

Sri Ananta Narayan Singh Laguri, OAS(S), Additional District Magistrate (General), Balangir presided over the meeting along with Er. Ramesh Kumar Ekka, Regional Officer (In-Charge), State Pollution Control Board, Odisha, Balangir.

At the outset, Regional Officer, State Pollution Control Board, Balangir welcomed all the public present in the meeting. He briefly described the objective of the public hearing conducted as per the provisions of EIA Notification No. S.O. 1533(E) of Dt. 14<sup>th</sup> September 2006 of the Ministry of Environment and Forests & Climate Change (MOEF & CC), Government of India. He also informed that the date, time and venue for conducting the public hearing meeting for Upper Lanth Irrigation Project for construction of Homogenous earth fill dam across river Lanth at Chikili village, Belpada Tahasil of Balangir District by the Executive Engineer, Padampur Investigation division, Padampur was duly advertised in Odia daily "**Dharitri**" dtd. **09.11.2021** and English daily "**The New Indian Express**" dtd. **09.11.2021**. (Paper clipping are enclosed as **Annexure-I**).

The Addl. District Magistrate has also briefed about the proposed project and requested the public who were present during the public hearing meeting to express their opinions and views on the proposed project. He also requested the representative of the proposed project to highlight about their proposed project before the public.

On behalf of the project proponent, Er. Kulamani Sethi, Superintending Engineer, Padampur Investigation Division addressed the public during the public hearing meeting. He briefly explained about the proposed irrigation project. There will be constructed a 2400 meter long homogeneous rolled earth fill dam, besides a spillway of 100 meter long at the central portion of the dam. The proposed project will provide irrigation facilities to 4700 hector land and will produce 210 KW of Hydro-electricity power at the left canal. The gross storage capacity of the reservoir will be 295.05 HaM. There will be constructed canal on both side of the dam. The project is proposed to be benefited to Belparablock of Balangir district.

The Addl. District Magistrate invited the public to offer their views on environmental related issues of the proposed project.

**Pandakimal Village:**

About 70-80 participants from the Pandakimal Village have attended the public hearing meeting and out of them 33 participants have put their signature in the attendance sheet whose list is annexed as **Annexure-II**. 12 persons have registered their name to deliver their views during public hearing and list is annexed as **Annexure-III**.

## NOTICE

It is brought to the notice of all concerned that The Executive Engineer, Padampur Investigation Division Padampur has proposed to have Environmental Assessment for Upper Lanth Irrigation Project for construction of homogenous earth fill dam across river Lanth at Chikil village, Belpada tahsil of Bolangir district to obtain Environmental Clearance from State Environment Impact Assessment Authority (SEIAA), Odisha. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.

Besides this, persons interested to submit their views relevant to the proposed mining project in writing or orally may also do so during the public hearing to be conducted on 10-12-2021 at 11.00 A.M. for Pandakimal Village and at 2.30 P.M for Jamjuri village at Company Ground, Jamjuri Village, Block/Tahsil - Belpada in Balangir district. Public hearing shall be conducted strictly observing guidelines contained in COVID — 19 pandemic restrictions issued by the MoEF&CC, Govt. of India vide OM No.22-25-IA.III, dated 09.06.2021 as well as Govt. of Odisha.
