PROCEEDINGS OF THE PUBLIC HEARING MEETING FOR ENVIRONMENTAL CLEARANCE OF M/S. KANTAPADA MAHANADI RIVER SAND QUARRY PROPOSED BY SRI CHINTAMANI SAMAL ON RIVER MAHANADI OVER MINING LEASE AREA OF 6.470 HECTARE AT VILLAGE KANTAPADA UNDER BADAMBA TAHASIL OF CUTTACK DISTRICT

The Public Hearing meeting of M/s. Kantapada Mahanadi River Sand Quarry proposed by Sri Chintamani Samal on River Mahanadi over mining lease area of 6.470 hectare at Village Kantapada under Badamba Tahasil of Cuttack District was held on dtd. 29.12.2021 at Mandap, Laxmi Mandir near Kantapada Sand source under Sankhameri Gram Panchayat, Badamba Tahasil in Cuttack District, Odisha at 11.30 A.M. with reference to:

- 1. EIA Notification S. O. 1533(E) dated 14.09.2006.
- 2. Interim Operational Guidelines.

The Panel consists of the following members:

- 1. Sri Purna Chandra Mishra, OAS (SAG), Additional District Magistrate, Cuttack
- 2. Er. Rashmita Priyadarshini, Regional Officer, State Pollution Control Board, Odisha, Cuttack

At the outset, welcoming the members participated in the meeting presided over by the Additional District Magistrate, Cuttack, the representative of State Pollution Control Board, Odisha, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by Sri Chintamani Samal.

Welcoming the public, Er. Rashmita Priyadarshini, Regional Officer, State Pollution Control Board, Odisha, Cuttack, explained the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. She asked the project proponent to make a brief presentation before the public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public.

Sri Chintamani Samal, the project proponent addressed the committee members and the assembled public and made a brief presentation about the salient features of the proposed project, environmental management and other aspect of the proposed project.

Then Er. Rashmita Priyadarshini, Regional Officer, State Pollution Control Board, Cuttack requested the public to give their views, comments, objections and opinions on the proposed project.

The following speakers gave their views on the above said project, which is given as follows:

1. Sri Gobardhan Samantaray, Kantapada:

He welcomed the dignitaries and public presented in the meeting. He said, they have not been informed about the meeting. He said when the sand ghat was not auctioned earlier they were getting sand easily and have done many developments works in the village. He requested to conduct meeting on another day.

2. Sri Pratap Chandra Palei, Kantapada:

He welcomed the dignitaries and public presented in the meeting. He raised the issue of spreading of nala and river water on their cultivated land and requested to the administration to look into the matter and to take required measures to prevent it. He said the road connected from Sapneswar temple to their village is not in good condition, stone packing is not done properly and the embankment is not strong to prevent entering of river water into their house and land. He requested to strengthen the embankment and for doing more plantation to control soil erosion.

3. Sri Madhaba Nanda Nayak, Kantapada:

He stated that no development activity is done in the village due to non-operation of the sand mine so the mine should be operated for the development of their village.

4. Sri Prabodha Kumar Mohanty, Sankhameri:

He welcomed the dignitaries and public presented in the meeting. He said they are buying sand at higher price from distance location due to non-operation of the sand mine of their village. He said if the project proponent will operate the sand mine and give sand to the villagers at reasonable rate then villagers will be benefited.

5. Sri Sushanta Mallick, Kantapada:

He welcomed the dignitaries and public presented in the meeting. He said the road on which the sand loaded vehicles will be moved are required to be strengthen.

6. Sri Bhabagrahi Sahoo, President, Kantapada:

He said the road used for sand vehicles movement is not widened enough for movement of sand vehicles, the embankment is getting weak and environment is polluted and he seek clarification what benefits villagers will get. He stated not to operate the sand mine.

7. Sri Krupasindhu Mallick, Kantapada:

He raised the issues of movement of sand loaded vehicles during late night hour which create disturbance, movement of sand loaded vehicles without tarpaulin cover creating dust pollution, road is getting damaged which needs repairing. He requested to provide sand to the villagers at reasonable rate and contribution for their village temple.

8. Sri Golakha Bihari Mohanty, Kantapada:

He welcomed the dignitaries and public presented in the meeting and stated that he supports the statement of Sri Bhabagrahi, President.

9. Sri Batakrushna Mohanty:

He said that operation of the sand mine will provide royalty to the government, lessee will get benefit but villagers are not getting any benefit. He requested to provide contribution for their village temple, road should be repaired, villagers should get sand at reasonable rate. He stated movement of sand vehicles during late night hour creates disturbance also possibility of accident is there due to these vehicles and requested to administration to look into the matter.

10. Sri Bipin Barik, Kantapada:

He said that school exists near the sand mine and transportation of sand from this mine is polluting the environment due to dust pollution, accident possibility is there so proper measures should be taken during school hour, Further people are also getting sick due to dust pollution. He said the government should made expenditure for the development of their villages with the royalty fund. He raised the issues of dust pollution due to movement of sand loaded vehicles without any water sprinkling provision.

11. Sri Madan Mohan Mahapatra, Kantapada:

He welcomed the dignitaries and public presented in the meeting. He said that plantation should be done to control pollution, care should be taken during sand transportation as the

school is located near the sand mine and sand loaded vehicles should be covered with tarpaulin cover.

12. Sri Fakir Sethi, Sankhameri G.P., Sarapanch:

He welcomed the dignitaries and public presented in the meeting. He requested to provide sand to the villagers at reasonable rate.

At the outset total 12 Nos. of people had registered their names to express their views, comments etc. and deliberated their views accordingly. Total 23 numbers of public present in the meeting have signed the attendance sheet. The video of the last speaker is not recorded due to some technical problem.

Sri Hemanta Kumar Swain, OAS(S), Sub-collector, Athagarh was present in the meeting. He clarified the public that paper publication was made in Odia daily newspaper "Pramaya" on dtd. 25.11.2021 and in English daily newspaper "The Times of India" on dtd. 25.11.2021 regarding intimation to the public about this public hearing meeting. He intimated the public about the environment management plan proposed by the lessee and stated the movement of sand loaded vehicles during school children movement time and during late night hour to be regulated by the lessee.

After all the speakers completed their respective opinion and suggestion, the Regional Officer, Cuttack asked the project proponent to give relevant reply, to the issues raised by the public. Sri Chintamani Samal, the project proponent committed to provide water sprinkling arrangement, plantation, regulate the movement of sand loaded vehicles during school children movement time and he will take necessary steps to protect the environment and comply with the stipulations made in the Environmental Management Plan.

Sri Purna Chanda Mishra, OAS (SAG), Additional District Magistrate, Cuttack Additional District Magistrate, Cuttack welcomed all the government officers and public presented in the meeting. He said royalty collected by the government is utilised for different development activities and stated that the views of the public have been recorded which will be sent to SEIAA.
