

PROCEEDINGS OF THE PUBLIC HEARING MEETING FOR ENVIRONMENTAL CLEARANCE OF BIRUPA RIVER SAND QUARRY, BHAIRPUR PROPOSED BY M/S. SAHU METALIKS PVT. LTD. ON RIVER BIRUPA OVER MINING LEASE AREA OF 5.058 HECTARE AT BHAIRPUR MOUZA UNDER SALIPUR TAHASIL OF CUTTACK DISTRICT

The Public Hearing meeting of M/s. Birupa River Sand Quarry, Bhairpur proposed by M/s. Sahu Metaliks Pvt. Ltd. on River Birupa over mining lease area of 5.058 hectare at Bhairpur mouza under Salipur Tahasil of Cuttack District was held on dtd. 09.03.2022 at the play ground of Bhairpur Mouza situated near Tarini Mandir by the side of Cuttack- Chandbali under Salipur Tahasil in Cuttack District, Odisha at 11.30 A.M. with reference to:

1. EIA Notification S. O. 1533(E) dated 14.09.2006.
2. Interim Operational Guidelines.

At the outset, welcoming the members participated in the meeting presided over by the Project Director, D.R.D.A., Cuttack, the representative of State Pollution Control Board, Odisha, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of project proposed by M/s. Sahu Metaliks Pvt. Ltd..

Welcoming the public, Er. Rashmita Priyadarshini, Regional Officer, State Pollution Control Board, Odisha, Cuttack, explained the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. She informed that the date, time and venue for conducting this public hearing was duly advertised in Odia daily newspaper "Dharitri" on dtd. 05.02.2022 and in English daily newspaper "The Times of India" on dtd. 05.02.2022 for intimation to the public about this public hearing meeting.

Sri Ambar Kumar Kar, OAS (SAG), Project Director, D.R.D.A., Cuttack welcomed all the government officers and public presented in the meeting. He informed the public that the issues and concern raised by them related to the project will be recorded in a proceedings

On behalf of M/s. Sahu Metaliks Pvt. Ltd. (Project proponent), Sri Pabitra Kumar Swain addressed the panel members and the assembled public. He made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management, afforestation programme and various other CSR activities envisaged in the proposed project.

Then Er. Rashmita Priyadarshini, Regional Officer, State Pollution Control Board, Cuttack requested the public to give their views, comments, objections and opinions on the proposed project.

The following speaker gave his views on the above said project, which is given as follows:

1. Sri Chittaranjan Baisakh, Bhairpur:

He welcomed the dignitaries and public present in the meeting. He said that limited numbers of people have attended the public hearing meeting and many villagers, public representatives, Sarpanch, people of nearby panchayat are not present in the meeting. He requested not to continue the meeting.

NOTICE

It is brought to the notice of all concerned that M/s Sahu Metaliks Pvt. Ltd. has proposed to have Environmental Assessment for Birupa River Sand Quarry, Bhairpur over an area of 5.058 ha. at Bhairpur Mouza under Salipur Tehsil of Cuttack district to obtain Environmental Clearance from the State Environment Impact Assessment Authority (SEIAA), Odisha. The proponent has applied to the State Pollution Control Board, Odisha, Bhubaneswar for a Public Hearing.

By virtue of Ministry of Environment, Forests & Climate Change, Government of India Notification No. S.O. 1533 (E) Dtd. 14.09.2006, the Board has been authorized to conduct environmental public hearing and as such invites suggestions, views, comments and objections on matters relating to environmental aspects of the proposed project from all the persons including bonafide residents, environmental groups and others located at the proposed site/sites of displacement/sites likely to be affected.

For the above purpose, a person will only mean:

- Any person who is likely to be affected by the grant of Environmental Clearance.
- Any person who owns his control over the project with respect to which an application has been submitted for environmental clearance.
- Any association of persons whether incorporated or likely to be affected by the project and / or functioning in the field of environment.
- Any local authority within any part of whose local limits is within the neighborhood, wherein the project is proposed to be located.

Persons as above who desire to submit their views, comments, objections etc. relevant to the project, may do so in writing within 30 days from the date of publication of this notice addressing the same to the Member Secretary, State Pollution Control Board, Odisha through Registered Post. Besides this, persons interested to submit their views relevant to the proposed mining project in writing or orally may also do so during the public hearing to be conducted on 09.03.2022 at 11.30 A.M at the Playground of Mouza-Bhairpur situated near Tarini Mandir by the side of Cuttack-Chandbali under Salipur tehsil of Cuttack district. Public hearing shall be conducted strictly observing guidelines contained in COVID - 19 pandemic restrictions issued by the MOEF&CC, Govt. of India vide OM No.22-25-IA.III, dated 09.06.2021 as well as Govt. of Odisha.
