

PROCEEDINGS OF THE PUBLIC HEARING OF M/S. TALAB STONE QUARRY NO.1, 1(A), 2, 2(A) & 6 OF SRI NEERAJ KUMAR AGRAWAL OVER AN AREA OF 12.61 HA AT VILLAGE TALAB UNDER SADAR SAMBALPUR TAHSIL OF SAMBALPUR DISTRICT HELD ON DT. 22.03.2022 AT 11.00 A.M AT: IN FRONT OF PRIMARY AGRICULTURE CREDIT SOCIETY (PACS) OFFICE, TALAB, DIST: SAMBALPUR

Sri Umakanta Raj, OAS(SAG), Additional District Magistrate, Sambalpur presided over the meeting along with Er. Ramesh Kumar Ekka, Regional Officer, State Pollution Control Board, Sambalpur, Odisha.

At the outset, Regional Officer welcomed the public present in the meeting. He briefly described the objective of the public hearing conducted as per the provisions of EIA Notification No. S.O. 1533(E) of Dt. 14th September 2006 of the Ministry of Environment and Forests & Climate Change (MOEF & CC), Government of India. He also informed that the date, time and venue for conducting the public hearing meeting for Talab Stone Quarry no. 1, 1(A), 2, 2(A) and 6 of Sri Neeraj Kumar Agrawal over an area of 12.61 Ha at Village Talab under Sadar Sambalpur Tahasil of Sambalpur District held on dt.22.03.2022 at 11.00 A.M at in front of Primary Agriculture Credit Society (PACS) Office, Talab, in the district of Sambalpur was duly advertised in Odia daily "*The Samaj*", dtd. 18.02.2022 and English daily "*The Times of India*" dtd. 18.02.2022(Paper clipping are enclosed as Annexure-I).

The Addl. District Magistrate, Sambalpur has also briefed about the proposed stone quarry project and requested the public who were present during the public hearing meeting to express their opinion and views on the proposed project. He also requested the representative of the project to highlight about their proposed project before the public.

On behalf of the project proponent, Sri Neeraj Kumar Agrawal, representative of the Quarry addressed the public during the public hearing meeting. He briefly explained about the project and assured the public that the company will adopt latest technology to prevent any pollution and implement good CSR practices for the welfare of the local area. He informed that the geological reserve in the project area is 50,000 M³ of Ordinary Stone. Automated methods will be adopted and drilling and blasting will be carried out in the proposed project. About 100 families are employed in the quarry/crusher. Controlled blasting method will be adopted in accordance with government regulations. Blasting will be done once in every 10-15 days interval.

The Addl. District Magistrate, Sambalpur invited the public to keep their views on environmental related issues for the proposed project.

About 150-200 participants have attended the public hearing meeting and out of them 91 participants have put their signature in the attendance sheet whose list is annexed as Annexure-II. During meeting, 21 persons have registered their names and delivered their views. List is annexed as Annexure-III.

1.	<u>Sri Nibas Chandra Satpathy, Jamadarpali.</u> He welcomed the proposed project.
2.	<u>Sri JayadebaSahu, Jamadarpali.</u> He expressed his support and welcomed the proposed project.
3.	<u>Sri Prasanna Bisi, Jatupada:</u> He welcomed the proposed mining project.
4.	<u>Sri LambodharSahu, Jogipali.</u> He welcomed the proposed mining project.
5.	<u>Sri Arobinda Pradhan, Jogipali:</u> He expressed his support to the proposed mining project.
6.	<u>Sri Ranjit Thakur, Talab:</u> He welcomed the proposed mining project
7.	<u>Sri Jatin Kumar Sahu, Talab:</u> He conditionally supported the proposed mine. He expressed that the company has not developed the road, plantation etc. So the mine authority should take care to develop road and planting more trees in the area.

9.	<u>Sri Mahendra Kumar Bhoi, Talab:</u> He expressed his support to the proposed quarry. The authority should focus on periphery development of the area.
10.	<u>Sri M. U. Maheswar, Madhupur:</u> He expressed his support to the proposed quarry. He also asked the mine authority to plant more trees in the vacant area.
11.	<u>Sri KedarnathBhoi, Talab:</u> He expressed his support to the proposed quarry.

12.	<u>Sri Nigamananda Pujari, Talab.</u> He opposed the quarry. He expressed that the company has not developed any road, plantation etc. in Talab Panchayat.
13.	<u>Sri Prakash Seth, Talab:</u> He opposed the proposed project. He expressed his dissatisfaction and stated that no local people have been employed by the nearby crusher. If the mining authority will employ the local people then he has no objection for the proposed quarry.
14.	<u>Sri Saroj Kar, Talab:</u> He expressed his support to the proposed quarry. He said that the local peoples are getting financial help for which the company is unable to make periphery development. So first the donation to be stopped to the individuals. He also stressed on local employment, periphery development and plantation.
15.	<u>Sri Udit Kumar Bhoi, Talab:</u> He supports the proposed quarry. He also asked the quarry authority to stop donation to the individuals and focused on periphery development.
16.	<u>Sri DinabandhuChaini, Talab:</u> He supports the quarry and told to develop roads in Talab Panchayat
17.	<u>Sri Gopal Pati, Talab:</u> He expressed his supports for the proposed mining project and demanded to develop roads in Talab Panchayat. He placed a proposal to formulate a committee for carry out developmental work I the local area as per the recommendation of the committee.
18.	<u>Sri Sudhir Kumar Sahu, Talab:</u> He supported the proposed mining project and urged before the mining authority for controlled blasting in the mines.
19.	<u>Sri Byomakesh Thakur, Talab:</u> He supported the proposed mining project and demanded before the quarry authority for periphery development, roads and plantation. He stated that all the development work should be done as per recommendation of the committee and individual donations system should be stopped by the mining authority.
20.	<u>Sri Manas Pati, Talab:</u> He supported the proposed quarry project and demanded before the mining authority to provide local employment opportunity.
21.	<u>Sri Chandramani Bag, Madhupur:</u> He expressed his support and welcomed the proposed mining project.




The public raised the following issues and apprehensions for readdressed by the project proponent.
