PROCEEDING OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT FOR SUNDARPUR STONE QUARRY OVER THE MINING LEASE AREA OF 5.058 HA FOR PRODUCTION OF BUILDING STONE (2), 10,000 CUM/ANNUM AT SUNDARPUR VILLAGE, CHATRAPUR TAHASIL OF DISTRICT GANJAM, HELD ON 09.03.2022 AT 11.00 AM OVER PLOT NO. 10520, KHATA NO. 400, ADJACENT TO SUNDARESWAR TEMPLE OF SUNDARPUR VILLAGE UNDER CHATRAPUR TAHASIL OF GANJAM DISTRICT

At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that the Tahasildar Chatrapur has proposed to have Environmental Impact Assessment for Sundarpur Stone Quarry over mining lease area of 5.058 ha. for production of Building Stone @ 10,000 cum/Annum at Sundarpur village, Chatrapur Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Odia Daily "Sambada" dated 04.02.2022 and an English Daily "The Times of India" dated 04.02.2022 regarding the venue, date and time of the public hearing along with the places of availability of Executive Summaries (Odia & English) of Environmental Impact Assessment (EIA) report in the office of the Collector & Dist. Magistrate. Ganjam. District Industries Centre(DIC), Ganjam. Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment (Environment) Govt of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospeboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Sundarpur Gram Panchayat and the Block Development Office, Chatrapur, in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Addl. District Magistrate (Rev) Ganjam, Sri Priya Ranjan Prusty, O.A.S to kindly preside and supervise in the public hearing.

The Addl. District Magistrate, Ganjam, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance. Then he asked the Project Proponent of M/s. Sundarpur Stone Quarry to brief about the project.

The Addl. Tahasildar, Chatrapur, Project Proponent of M/s. Sundarpur Stone Quarry presented the salient features of the proposed project, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the project proponent to reduce the impact while executing the project in Odia language. The representative of successful bidder of this stone quarry has also highlighted the remedial measures they will take to mitigate environmental pollution.

The Addl. District Magistrate, Ganjam, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 100 persons were present in the public hearing meeting, only 70 nos. of persons signed in the attendance sheet, out of which 06 persons participated in the oral deliberation and signed in the oral deliberator's sheet. No written representations were received in the hearing. The attendance sheets and the Deliberator sheets are enclosed as **Annexure-I** and **Annexure-II** respectively.

The statements recorded are as follows:

1. Sri Manoranjan Behera, At/PO- Sundarpur, Chatrapur

He stated that cost of the construction stone in the locality has increased due to non-operation of the quarry since last two years. The local public has no objection for operation of this quarry and they welcome this project for local employment. He requested to undertake plantation, water sprinkling etc. to control pollution. He further added that transportation of minerals shall be carried out during less traffic hours for convenience of local public.

2. Sri Basanta Kumar Bisoyi, At/PO- Sundarpur, Ganjam

He expressed that local people will have employment opportunity by operation of this mine.

3. Sri Arjun Behera, At/PO- Sundarpur, Ganjam

He emphasized that, this quarry should operate for local employment and especially inhabitants of Sundarpur G.P. shall get materials from this quarry at a cheaper rate. He also demanded that the project proponent should clarify in detailed regarding environmental protection measures to be adopted during operation of this quarry. He has also highlighted the issue of soil erosion, noise pollution, traffic congestion, dust pollution etc. due to mining. He also added that due to blasting about 80 nos. of houses were damaged in Ward No. 2 which are located towards the mine. He demanded that the workers to be engaged shall be provided with Personal Protective Equipment (P.P.E.) for safety, time of blasting shall be intimated to the local public in advance and all safety precaution shall be adopted during blasting.

4. Sri Subash Chandra Naik, Youth President of Chatrapur Block

He thanked the Government for conducting the public hearing for operation of the mine as this will lead to local development and create employment opportunity. He requested to the successful bidder to abide by the guidelines of the Government and

undertake the developmental works after consultation with the villagers. He also added that the lessee shall undertake plantation to prevent soil erosion.

5. Sri Babu Pradhan, At/PO- Sundarpur, Ganjam

The local villagers are suffering with the problem of unemployment as the mine was non-operational since last two years. He requested to the public to support this mine for its operation.

6. Sri Ranjan Mahankuda, At/PO-Sundarpur, Chatrapur

He seeks clarification from the authority regarding insurance facilities to the workers in case of accident.

Further the Addl. District Magistrate, Ganjam and Regional Officer, State Pollution Control Board, Berhampur also discussed on issues raised by the public and requested to the Project Proponent of Sundarpur Stone Quarry to address the issues raised by the local public. The Addl. Tahasildar, Chatrapur and Sri S. Sanjeev Reddy, representative of successful bidder addressed the apprehensions raised by the public.

Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns, expressed by the oral deliberators. The minutes of the public hearing were prepared which has been ratified by Sri Priya Ranjan Prusty, O.A.S, Addl. District Magistrate, Ganjam with the views and concerns of the deliberators. The video recording of the entire public hearing is enclosed herewith for ready reference.

The statement of issues and concerns of public with the comments of the project proponent, prepared in Odia and English Language are annexed as **Annexure-III** and **Annexure-IV** separately.

The public hearing was ended with vote of thanks by the chair.
