PROCEEDINGS OF THE PUBLIC HEARING HELD ON 10.05.2022 (AT 11.00 AM) AT VILLAGE CHAMPADIHI (KHATA NO. 49, PLOT NO.22) WITH RESPECT TO ENVIRONMENTAL ASSESSMENT OF M/S KASHVI INTERNATIONAL PRIVATE LIMITED FOR ESTABLISHMENT OF 0.6 MILLION TPA IRON ORE PELLET PLANT AND 5 NOS. (4W+1S) PRODUCER GAS PLANT OF CAPACITY 5000 NM³/HR EACH AT CHAMPADIHI VILLAGE UNDER JHUMPURA TAHASIL OF KEONJHAR DISTRICT FOR ENVIRONMENTAL CLEARANCE.

The public hearing in respect of the project proposed by M/s Kashvi International Pvt. Ltd. for establishment of 0.6 MTPA Iron Ore Pellet Plant and 5 nos. (4W+1S) producer Gas Plant of capacity 5000 NM³/Hr each at village Champadihi under Jhumpura Tahasil of Keonjhar district was held on scheduled date & time with reference to:

I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and Amendments thereafter.

The Panel consisted of the following members:

- Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar, Odisha

Shri Jadumani Mahala, Additional District Magistrate, Keonjhar, supervised & presided over the public hearing process and was assisted by Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting, the Regional Officer, State Pollution Control Board, Keonjhar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of the project proposed by M/s Kashvi International Private Limited.

Shri Behera explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public, gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Sri Biswaranjan Puhan of Visiontek Consultancy Services Pvt. Ltd. addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management and various other CSR activities envisaged in the proposed project.

Then Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

1) Smt. Khirodini Mahakud, Zilla Parisad, Zone-16, Jhumupa GP:

Welcoming the panel and gathering she supported the project proposed by M/s Kashvi International Pvt. Ltd. She expressed his happiness by stating that people of around 10 (ten) villages will be able to manage their livelihood with the set up of the Plant. At the end, she told that SHG will also be benefited.

2) Smt. Laxmi Champia, Sarapanch, Khutunga GP:

While supporting the Public Hearing, she stated that there will be overall development of the Panchayat with the operation of the Plant in this area and people will not go to other states for employment as migrated labour and they will get all benefit in their village itself.

3) Sri Mahusudan Maharana Champadihi:

While welcoming and supporting the Public Hearing, he informed all the villagers are very happy with the setting up of a Plant by M/s. Kashvi International Pvt. Ltd. and stated that there should not be the involvement of mischievous and disruptive people. Any grievance should be discussed with the Company Management and the villagers.

4) Sri Shyam Sundar Purty Brahmanijhari:

While supporting the proposed project, he welcomed the Industrialist for operating Plant and Mines in this locality. He informed that due to closing the plants of M/s. Sri Ganesh and M/s. Kushum and due to covid-19 pandemic situation for last 2 years, the people of this locality are in desperate condition. Now it is an opportunity for us that M/s. Kashvi International Pvt. Ltd. is going to set up plants in our area. He demanded the Company Management to take appropriate action for Water and Air pollution control measures and keep the pollution level within the limit as per standard. He further informed that as per the commitment of M/s. Kashvi Management, there will be around 93 direct employments. He demanded the following:

- That priority should be given for employment to the land owner/land losers and people of surrounding 8 nos. of villages.
- Extend help to the students of these area for various competitive examination like JEE/
 NEET at par with English medium school students through CSR activities.
- Arrangement for regular health check up by a Specialist doctor with medicine and for emergency case, Ambulance should be provided for shifting the patients to Keonjhar and other well equipped hospital.
- Company management should take proper care of wild life to ensure movement of elephants to the public area.
- Suggested for adoption of nearby villages by the company for overall development of the villagers with regard to education, health etc.
- Whatever demands raised by the villagers should be fulfilled through DMF fund.

5) Sri Hemanta Aruk Sanjoda:

While supporting the Public Hearing, he stated that company management should also support us for fulfilling our demands. He demanded the following:

- One school bus should be provided by the company.
- One Ambulance should be provided in the locality.
- One committee should be formed considering 8 nos. of surrounding villages for discussing with the Company Management for various issued raised by us and the villagers will not approach to any higher authority.
- Request the Company Management for pollution control measures.
- In addition to surrounding villages, employment should also be considered for Jamunapasi, Belda and Kamalpur villagers.
- Employment should be provided to the youths of this locality as per their qualification.

6) Sri Prashant Mahakud Sanjoda:

While supporting the project, he suggested for constituting a development committee along with senior citizen and youths considering 8 nos of villages. He further stated that there will be overall development if Plants operate in our area.

7) Sri Prashant Ghana Kamalpur:

In his speech, he expressed that his village is Kamalpur which is 3 KM distance from the Plant area and will suffer due to operation of plant. There is only one river named Baitarani which is a life line of Keonjhar, Mayurbhanj, Bhadrak and Balesore district. Presently M/s. ESSAR Steel, M/s. BRPL and M/s. Pro Minerals are taking water from the Baitarani river for use at their Plants. If this continues, the flow of river water will reduced as well as Kanpur Dam will also be affected. Therefore, he suggested for using underground water by M/s. Kashvi International. This area is coming under Chamakpur Reserve Forest and area of elephant corridor. He further stated that National High way is around 10 KM distance from the project site and so many villages exist in the area and the roads from NH to these villages are very narrow which will result difficulties for movement of villagers due to transportation of raw materials. While he is in favour of the project, but told that environment should not be destroyed and that to be maintained accordingly.

8) Sri Prahallad Mahakud, Sanjoda:

While supporting the proposed project and public hearing, he stated that today is an auspicious day for us. We were waiting for a Plant in this area. Earlier 2 Nos. of Plants were running in the locality, but after closure of these plant, numbers of youths lost their jobs and they suffered. The industry will run by the workers and the management and the workers should obey the rules and regulations of the Management. He further stated that as per the qualification and locality, employment should be provided and involvement of mischievous and disruptive people should not be there. Further, he suggested that company management to visit the villages and after proper inspection, the issues raised by the villagers to be looked after without any partiality.

9) Sri Sunil Kumar Mahakud, Belda, Bamebari:

While supporting the proposed project, he demanded the following:

- Employment to youths of Palsa GP and Kutunga GP.
- Medical facility with Ambulance
- Construction of Road
- Drinking Water facility
- Water Sprinkling on roads
- CSR activity to be done.

10) Smt. Madhusmita Behera, P.S member, Kutgaon GP:

While supporting the Public Hearing, she demanded for Ambulance, Medical facilities, school bus up ,to Jhumpura, supply of drinking water and pollution control measures. Further, she demanded for employment as per qualification.

11) Sri Gokul Chandra Mahanta, Bamebari:

While supporting the proposed project, he expressed his happiness that this area is full of water, land and minerals etc. Ore produced here are sent to other states like Jharkhand, Bihar and West Bengal for beneficiation. He welcomed the content of the executive summary read out by M/s. Kashvi International Pvt. Ltd. He stated that if the Company implements whatever mentioned in their Executive summery scientifically, then we have nothing to raise any objections. During the running of the mining activities, there is affect on water, land and forest. For transportation of the raw materials Company will engage Dumpers, Hywa and other vehicles, for which route map is required and requested the Co. Management for improvement of the roads. The company i.e, M/s. Sri Ganesh and M/s. Kushum Power were not complying the Govt. guidelines and protocols, hence no proper pollution control measures were in place. M/s. Kashvi International should be aware this. He further told that there will be appointment of 93 persons by the Company, but Company will also engage engineers from IITs/NITs for operating their plant. So it is not possible to engage all 93 persons from local areas. He also demanded for a mega Steel Plant in this locality.

12) Sri Sankhadi Behera, Kutgaon GP:

While supporting the proposed project he demanded the following:-

- Employment to local unemployed youths of this locality and to all ITI/Diploma and Degree holders.
- Construction of roads.
- Providing street light to save from elephant movement.
- Providing drinking water facility and bathing water.
- School bus to be provided for the students for reading in English medium school.

13) Smt. Purnima Mahakud, Sanjoda, Kutgaon GP:

While supporting the Public Hearing, she demanded the following:

- Providing Ambulance
- Providing trained teachers in the Primary School

- Employment as per qualification
- Proper pollution control measures
- Take care of landed property from Pollution
- Company should follow the guidelines mentioned in their executive summary.

14. Sri Saroj Kumar mahanta, Jamunaposhi:

He fully supported the proposed project and Public Hearing. He requested the Company Management for Water, Air and Sound pollution control.

15. Sri Deepak Ku Mahanta, Jamunaposhi:

While supporting the proposed project, he stated that it is true that there will be water crisis in Baitarani River and after construction of Kanpur dam near Kandra, the water level of Baitarani river will increase. Definitely there will be dust generation in view of Plant operation. So, Company to take proper care to control air pollution. At the end he told that afforestation should be done in the waste land in the locality.

16. Sri Benudhar Tanti, Champadihi:

While supporting the Public Hearing, he stated that everybody will be benefited after the operation of the Plant and demanded the following:-

- Construction of road
- Water supply
- Street light
- Health care

17. Sri Niladri Bihari Mishra, President Paribesh Surakhya Samiti, Joda:

While supporting the Public Hearing, he stated that due to habitant problem, elephants are entering into the villages and from time to time population increased near Baitarani River. He suggested that plantation should be done in the catchment areas of Baitarani River.

18. Sri Arjun Patra, Chipinda, Kutgaon GP:

He fully supported the proposed project and requested for fulfillment of all the demands raised by the villagers.

19. Sri Ram Das Nag, Brahmanijhari:

He supported the project proposed by M/s Kashvi International Pvt. Ltd.

20. Sri Shyam Singh, Brahmanijhari:

He supported the project and Public Hearing.

The Panel received **02 nos.** of written representations of the local people demanding different facilities in the locality during the hearing which are enclosed herewith in original.

Observation:

The overall opinion of the public about the proposed project was favorable. However, the local people have some aspirations as laid down in their deliberations.

Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns expressed by the speakers with the inclusion of comments of the applicants, read over to the audience at the end of the proceedings explaining the contents in Odia language and the agreed minutes of public hearing meeting is prepared. The statement of issues and concerns of public with the comments of applicants, prepared in Odia and English language is annexed as per Annexure- I & II. List of participants is annexed as per Annexure- III.

The President of Public Hearing, Shri Jadumani Mahala, Additional District Magistrate, Revenue, Keonjhar ratified the minutes of meetings with the views and demands of public. He extended his vote of thanks to the public for rendering their co-operation for smooth operation of the public hearing.

The meeting ended with a vote of thanks to the chair and the participants.


