

PROCEEDINGS OF THE PUBLIC HEARING HELD ON 18.05.2022 (AT 11.00 AM) AT BALIPAL (NEAR BALIPAL HATA, KHATA NO.337 (RAKHITA), PLOT NO.901, KISSAM-BAGAYAT-II) WITH RESPECT TO ENVIRONMENTAL ASSESSMENT FOR REMAL SAND BED, DARADIPAL OVER AN AREA OF 5.06 HA. OF SRI HRUSIKESHA JENA OF M/S JENA MINERALS PVT. LTD. IN MOUZA KATHAPAL & DARADIPAL UNDER GHASIPURA TAHASIL OF KEONJHAR DISTRICT FOR ENVIRONMENTAL CLEARANCE.

The public hearing in respect of the project proposed by Sri Hrusikesha Jena of M/s Jena minerals Pvt. Ltd. for Remal sand bed over an area of 5.06 Ha. in Mouza Kathapal & Daradipal under Ghasipura Tahasil of Keonjhar district was held on scheduled date & time with reference to:

- I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and Amendments thereafter.

The Panel consisted of the following members:

2. Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar, Odisha

Shri Bijan Kumar Thamba, Project Administrator (ITDA), Keonjhar, supervised & presided over the public hearing process and was assisted by Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting, the Regional Officer, State Pollution Control Board, Keonjhar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of the project proposed by Sri Hrusikesha Jena of M/s Jena Minerals Pvt. Ltd.

Shri Behera explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public, gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Sri Suman Kumar Sahoo (Consultant) addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management and various other CSR activities envisaged in the proposed project.

Then Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

- 1) **Sri Pradeep Kumar Naik, Daradipal GP:**
While supporting the sand bed he stated that though 2 Nos. of rivers viz. Kushai and Remal rivers are flowing through their area but they are facing difficulties to get sand in reasonable price. Due to no sand mining in their locality as a result they are compelled to purchase at high cost from elsewhere, particularly those beneficiaries who are going to construct their house under Indira Awas Yoyona and Mo Kudia Ghara Yoyona. If permission for this sand bed mining is permitted then the local people will be benefited.
- 2) **Sri Smrutiranjana Bihari, Daradipal GP:**
While supporting the Public Hearing he stated that residents of their locality are managing purchase of sand in half price than the actual price. Once sand mining starts at their locality people need not to procure in illegal way they can buy at their own place in reasonable price. At the same time requested to ensure that there should not be any damage to the environment.
- 3) **Miss Subhashree Subhalaxmi Sahoo, Balipal, Daradipal GP:**
While supporting the Public Hearing she has no objection if the sand mining start at their village and nearby villages will be benefited.
- 4) **Sri Gadhadar Nayak, Daradipal:**
While supporting the proposed sand bed project he stated that due to no sand mining lease in their locality they are facing difficulties for procuring sand. At the same time he demanded that damaged roads need to be repaired by the lessee which will cause as a result of transportation of sand from their local road. He requested to ensure that the road condition should not be bad in view of the transportation. He also requested to take appropriate measure to control the flood at their locality.
- 5) **Sri Dhurba Charan Dehu, Balipal:**
While supporting the Public Hearing he suggested lessee to ensure that in view of extraction and transportation their village should not be affected. He advised to start the sand mining after the cleaning the river ghat.
- 6) **Sri Kailash Chandra Jena, Kathapal, Daradipal:**
He expressed that due to massive extraction of sand in the nearby sand lease area the depth of the river increased and look like pond. At the same time he told that their roads are getting damaged due movement of heavy vehicles. Now their people are procuring the sand in Rs.500/- to Rs.600/- Per ton of sand but once the sand mining starts in their area it will increase to Rs.3000/- per ton.
- 7) **Sri Gobordhan Sha, Daradipal GP, Balipal:**
He supported the Auction. He suggested to do sand mining as per the Govt. guidelines. He also suggested to ensure that no environment impact in their area. He expressed his concern that due to massive extraction of sand at their Balipal area water is getting depleted and hand pumps and borings become dry. Due to over mining in long stretch of river bed there is no sand only stone is noticed and advised not to disturb the stones. Due to depth the elderly persons are facing difficulties for utilizing this ghat at Balipal.

The Panel received **14 nos.** of written representations of the local people demanding different facilities in the locality during the hearing which are enclosed herewith in original.

Observation:

The overall opinion of the public about the proposed project was favorable. However, the local people have some aspirations as laid down in their deliberations.





There will be no overloading of the vehicles. Materials in trucks will be covered with tarpaulin. Regular water sprinkling will be done on transportation road to mitigate the dust pollution. There will be no drilling and blasting during the mining activities and underground water will not be affected through these mining activities.</p> <p>He said that overloading of vehicles will not be permitted. Road repair will be done on regular basis.</p> <p>At the end he ensured that agricultural land will not damage. There will be no bad impact in biodiversity and no threat of aquatic animal as this operation will be manually done.</p>
