PROCEEDINGS OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT FOR DWARAGAM STONE QUARRY OF SMT. LAXMI SETHI OVER THE MINING LEASE AREA OF 12.8721 HA FOR PRODUCTION OF CONSTRUCTION STONE 5,000 CUM/ANNUM AT DWARAGAM VILLAGE.

DIGAPAHANDI TAHASIL OF DISTRICT GANJAM, HELD ON 26.04.2022 AT 11.00 AM OVER PLOT NO. 382, KHATA NO. 317 OF DWARAGAM VILLAGE UNDER DIGAPAHANDI TAHASIL OF GANJAM DISTRICT

At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that Smt. Laxmi Sethi has proposed to have Environmental Impact Assessment for mining lease area of 12.8721 ha. for production of Construction Stone 5,000 cum/Annum at Dwaragam village, Digapahandi Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner –

- Advertisements through an Odia Daily "The Prameya" dated 23.03.2022 and an English Daily "The New Indian Express" dated 23.03.2022 regarding the venue, date and time of the public hearing along with the places of availability of Executive Summaries (Odia & English) of Environmental Impact Assessment (EIA) report in the office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre (DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment (Environment) Govt of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Padmanabhapur Gram Panchayat, Kaithagada Gram Panchayat, Kaithakhandi Gram Panchayat and the Block Development Office, Chatrapur, in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Addl. District Magistrate, Ganjam, Sri Priyaranjan Prusty, O.A.S. to kindly preside and supervise in the public hearing.

The Addl. District Magistrate, Ganjam, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance. Then he asked the Project Proponent of M/s. Dwaragam Stone Quarry to brief about the project.

Sri Biswanath Sethi, representative of Smt. Laxmi Sethi of M/s. Dwaraga. Stone Quarry presented the salient features of the proposed project, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the project proponent to reduce the impact while executing the project in Odia language.

The Addl. District Magistrate, Ganjam, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 40 persons were present in the public hearing meeting, only 32 nos. of persons signed in the attendance sheet. 12 persons signed for oral deliberation sheet and 11 persons among them participated and expressed their views. No written representations were received in the hearing. The attendance sheets and the Deliberator sheets are enclosed as **Annexure-I** and **Annexure-II** respectively.

The statements recorded are as follows:

1. Sri Krushna Chandra Pradhan, At- Dwaragam, Digapahandi

He stated that in the past this stone quarry was closed by the villagers due to issues of blasting. Domestic animals as well as villagers were injured due to blasting and environmental degradation will be there due to mining. Therefore he requested the administration to provide different facilities to the villagers in lieu of environmental degradation.

2. Sri Sankar Behera, At- Dwaragam, Digapahandi

He stated that they have no objection for this project. He also added that the lessee is known to them therefore they will get benefits and feels safe.

3. Sri Debaraj Nayak, At- Dwaragam, Digapahandi

He mentioned that the nearby villages are located only about 150 to 200 meters away from this stone quarry. Therefore village will get affected due to blasting and villagers will face difficulties.

4. Sri Chandan Kumar Patro, At-Podamari, Digapahandi

He stated that due to operation of this quarry local villagers will be benefited as about 20-30 families will get employment opportunities, problem of migration labour will be solved and construction material will be available at the locality with cheaper price. They have no objection for this project.

5. Sri Sudam Sahu, At- Dwaragam, Digapahandi

He stated that local villages will get employment opportunities by operation of this stone quarry.

6. Sri Santosh Dora, At- Moulabhanja, Digapahandi

He stated that most of the local villagers are migrating outside states for employment but due to operation of this mine they will get employment opportunities in their locality.

7. Sri Santosh Gouda, At-Batagada, Podamari, Digapahandi.

He stated that local vehicles will be engaged in this mine and local labours will also get employment opportunities by operation of this mine. Therefore they have no objection for this project.

8. Sri Raja Sahu, At-Moulabhanja, Digapahandi.

He stated that most of the local villagers are migrating outside states for employment but due to operation of this mine they will get employment opportunities in their locality.

9. Sri Dillip Kumar Pradhan, At- Dwaragam, Digapahandi

He stated that villagers have closed the operation of this quarry due to issues of blasting. Domestic animals and local villagers were injured due to blasting. Therefore he requested the administration to take preventive measures for safety of the local public during operation of this quarry.

10. Sri Ashok Gouda, At-Dwaragam, Digapahandi

He has highlighted the issues of blasting and expressed the difficulties faced by the villagers and their domestic animals.

11. Sri Sarathi Nayak, At-Dwaragam, Digapahandi

He highlighted the issues of farmers and stated that their paddy is not procured regularly.

Further the Addl. District Magistrate, Ganjam and Regional Officer, State Pollution Control Board, Berhampur also discussed on issues raised by the public and requested to the Project Proponent of Dwaragam Stone Quarry to address the issues raised by the local public. Sri Biswanath Sethi, representative of Smt. Laxmi Sethi addressed the apprehensions raised by the public.

Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns, expressed by the oral deliberators. The minutes of the public hearing were prepared which has been ratified by Sri Priyaranjan Prusty, O.A.S. Addl. District Magistrate, Ganjam with the views and concerns of the deliberators. The video recording of the entire public hearing is enclosed herewith for ready reference.

The statement of issues and concerns of public with the comments of the project proponent, prepared in Odia and English Language are annexed as **Annexure-III** and **Annexure-IV** separately.

The public hearing was ended with vote of thanks by the chair.


