PROCEEDINGS OF THE PUBLIC HEARING HELD ON 12.05.2022 (AT 11.00 AM) AT VILLAGE TAMPO ((NEAR TAMPO BRIDGE, KHATA NO.218, PLOT NO.556, KISSAM-GOCHAR) WITH RESPECT TO ENVIRONMENTAL ASSESSMENT OF BAITARANI SAND BED MINES OF M/S JENA MINERALS PVT. LTD. ON RIVER BAITARANI OVER AN AREA OF 5.058 HA. IN VILLAGE TAMPO UNDER GHASIPURA TAHASIL OF KEONJHAR DISTRICT FOR ENVIRONMENTAL CLEARANCE.

The public hearing in respect of the project proposed by M/s Jena minerals Pvt. Ltd. for Baitarani sand bed Mines on river Baitarani over an area of 5.058 Ha. in village Tampo under Ghasipura Tahasil of Keonjhar district was held on scheduled date & time with reference to:

I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and Amendments thereafter.

- 2. Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar, Odisha

Shri Jadumani Mahala, Additional District Magistrate, Keonjhar, supervised & presided over the public hearing process and was assisted by Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting, the Regional Officer, State Pollution Control Board, Keonjhar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of the project proposed by M/s Jena Minerals Private Limited.

Shri Behera explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public, gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Sri Mrutunjay Das of M/s Kalyani Laboratory Pvt. Ltd. Bhubaneswar, addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management and various other CSR activities envisaged in the proposed project.

Then Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

#### 1) Sri Golak Bihari Jena, Tampo:

While supporting the sand mining project and Public Hearing he was quite happy that their long standing dream is going to comply due to which they can easily purchase sand in reasonable rate for construction of their houses which till now they were procuring from distant place with very high price. At the same time he requested Government authority to look after the proper implementation of Indira Awas Yoyona as many persons of their village could not get this facility till now. He also requested to look after the betterment of bad road condition, construction of bridge for better connectivity to Kolkata and other places and plantation of trees.

#### 2) Sri Chintamani Naik, retired teacher, Batto:

He supported the Public Hearing and welcomed the sand bed mining. He expressed that even though the River Baitarani is flowing through 5 villages they are compelled to buy sand from Salondi village which is too costly. Now they can get it in reasonable price after opening the mines.

#### 3) Sri Jadunath Mallick, Tampo village:

While supporting the project he requested for tree plantation. At the same time, he stated that all the residents of their village are farmers and among them, some have paid their crop insurance premium some not. So he requested for waive off 25% crop insurance premium to Odisha Gramya Bank. He requested to look after completion of the incomplete bridge, which will connect Bhadrak, Jajpur. He also requested for construction of bridge so that connectivity Anandapur will improve. He requested to give attention for completion of lift irrigation project which is partly incomplete as of now.

#### 4) Miss Rojalin Rout, College Student Tampo:

She supported auction of sand bed. By this river bed sand mining everybody will be benefitted. She requested for immediate completion of bridge.

#### 5) Sri Sridhar Mahanta, Tampo:

While supporting the Public Hearing he stated that he never seen this kind of Public Hearing during last 53 years and all the residents are assembled to welcome this project with great enthusiasm. He requested to create jungle by tree plantation. He also requested to award land rights to the landless persons. He demanded for immediate completion of half-completed bridge, which will connect Bhadrak, Balasore and Keonjhar, A small park for elderly persons with all facilities like chairs, lights, toilets etc. He demanded of latrine facility as they have no latrine in their village.

#### 6) Sri Anath Bej, Atta, Madhukeashri:

While supporting the proposed project he expressed his happiness that with extraction of the sand at their village they can get sand in affordable price which now they are purchasing with high price from other locality. At the same time he requested for repairing of damaged river embankment.

#### 7) Sri Santosh Behera, Tampo village:

While supporting the Public Hearing he requested to pay proper attention to stop the illegal sand extraction and transportation and requested for auction of their sand bed also.

8) Smt. Jharana Jena, Sarpanch, Batto GP:

While supporting the Public Hearing, she expressed that by opening of river bed sand mining everybody will be benefitted.

The Panel received **07 nos.** of written representations of the local people demanding different facilities in the locality during the hearing which are enclosed herewith in original.

#### Observation:

The overall opinion of the public about the proposed project was favorable. However, the local people have some aspirations as laid down in their deliberations.

Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Keonjhar & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns expressed by the speakers with the inclusion of comments of the applicants, read over to the audience at the end of the proceedings explaining the contents in Odia language and the agreed minutes of public hearing meeting is prepared. The statement of issues and concerns of public with the comments of applicants, prepared in Odia and English language is annexed as per Annexure-I & II. List of participants is annexed as per Annexure-III.

The President of Public Hearing, Shri Jadumani Mahala, Additional District Magistrate, Revenue, Keonjhar ratified the minutes of meetings with the views and demands of public. He extended his vote of thanks to the public for rendering their co-operation for smooth operation of the public hearing.

The meeting ended with a vote of thanks to the chair and the participants.




