PROCEEDING OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT FOR DHANARASI SAND QUARRY OF SMT LAXMI SETHI OVER THE MINING LEASE AREA OF 5.152 HA FOR PRODUCTION OF ORDINARY SAND: 5,000 CUM/ANNUM AT DHANARASI VILLAGE, DIGAPAHANDI TAHASIL OF DISTRICT GANJAM, HELD ON 22.04.2022 AT 11.00 AM AT BATYA ASHRAYASTHALI OF VILLAGE DHANARASI (PLOT NOS. 370 & 371, KHATA NO. 192/79, MOUZA DHANARASI) UNDER DIGAPAHANDI TAHASIL OF GANJAM DISTRICT

At the outset, Er. Deepak Kumar Sahoo, Regional Officer. State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that Smt. Laxmi Sethi has proposed to have Environmental Impact Assessment for Dhanarasi Sand Quarry over mining lease area of 5.152 ha. for production of Ordinary Sand: 5,000 cum/Annum in Dhanarasi village, Digapahandi Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner -

- Advertisements through an Odia Daily "The Sambad" dated 18.03.2022 and an English Daily "The New Indian Express" dated 18.03.2022 regarding the venue, date and time of the public hearing along with the places of availability of Environmental Impact Assessment (EIA) report and Executive Summaries (Odia & English) in the office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre(DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment (Environment) Govt of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Gadagovindapur Gram Panchayat, Jakara Gram Panchayat, Chandapur Gram Panchayat, Nuapada Gram Panchayat and the Block Development Office, Digapahandi in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Addl. District Magistrate, Ganjam, Sri Priyaranjan Prusty, O.A.S to kindly preside and supervise in the public hearing.

The Addl. District Magistrate, Ganjam, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance. Then he asked the Project Proponent of Dhanarasi Sand Quarry of Smt. Laxmi Sethi to brief about the project.





Sri Biswanath Sethi, representative of Smt. Laxmi Sethi, presented the salient features of the proposed Dhanarasi Sand Quarry, the present status of the environmental, conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the lessee to reduce the impact while executing the project in Odia language.

The Addl. District Magistrate, Ganjam, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 40 persons were present in the public hearing meeting, only 26 nos. of persons signed in the attendance sheet, out of which 05 persons participated in the oral deliberation and signed in the oral deliberator's sheet. No written representations were received in the hearing. The attendance sheets and the Deliberator sheets are enclosed as **Annexure-I** and **Annexure-II** respectively.

The statements recorded are as follows:

1. Sri Kalu Charan Pradhan, At- Dhanarasi, Digapahandi

He questioned to the authority how leased was settled in favour of Smt. Laxmi Sethi without consent of Gram Panchayat. He also highlighted the issues of dust pollution due to open transportation of minerals, damage of roads due to deployment of heavy vehicles for transportation and affect of flood due to sand excavation. He demanded that the lessee shall sign an Agreement to abide all rules and regulations of the Government and they will not use heavy vehicle for transportation.

2. Sri Murali Pradhan, At- Dhanarasi, Digapahandi

He demanded for wide circulation of notice for public hearing. Further he added that villagers of Dhanarasi will not be affected by this project rather adjacent villagers will have impacts and Government will generate revenue by this project. He also alleged that damage of houses and crop loss due to blasting in a stone quarry adjacent to their village. He has requested to the lessee for mutual discussion with the villagers for smooth operation of this minor mineral source.

3. Sri Kamal Lochan Pradhan, At- Dhanarasi, Digapahandi

He stated that, adequate measures shall be taken for protection of environment and proper maintenance of the transport roads should be carried out during operational period. Proper care shall be taken to avoid loss of crop productivity due to blasting.

4. Sri Ranjan Kumar Sahu, Sarapanch, Gadagovindapur G.P.

He requested to the administration to enhance the load bearing capacity of the rural roads as these are getting damaged due to plying of heavy loaded transporting vehicles.

5. Sri Pradeep Pradhan, At- Dhanarasi, Digapahandi

He stated that they have no objection for this proposal as local people will be benefited.

Berhampur also discussed on issues raised by the public and requested to the Project Proponent of Dhanrarasi Sand Quarry of Smt. Laxmi Sethi to address the issues raised by the local public. Sri Amaresh Rath, representative of Smt. Laxmi Sethi addressed the apprehensions raised by the public.

Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns, expressed by the oral deliberators. The minutes of the public hearing were prepared which has been ratified by Sri Priyaranjan Prusty, O.A.S, Addl. District Magistrate (Rev), Ganjam with the views and concerns of the deliberators. The video recording of the entire public hearing is enclosed herewith for ready reference.

The statement of issues and concerns of public with the comments of the project proponent, prepared in Odia and English Language are annexed as **Annexure-III** and **Annexure-IV** separately.

The public hearing was ended with vote of thanks by the chair.


