PROCEEDINGS OF THE PUBLIC HEARING HELD ON 03.06.2022 (AT 10.30 AM) AT GROUND NEAR SAINTO VILLAGE PRIMARY SCHOOL OF SAINTO VILLAGE WITH RESPECT TO ENVIRONMENTAL ASSESSMENT FOR BADARO DEVI NADI SAND QUARRY OVER AN AREA OF 5.10 HA. UNDER JAGATSINGHPUR TAHASIL OF JAGATSINGHPUR DISTRICT FOR ENVIRONMENTAL CLEARANCE.

The public hearing in respect of the project proposed by the Tahasildar Jagatsinghpur for Badaro Devi Nadi Sand Quarry over an area of 5.10 Ha. under Jagatsinghpur Tahasil of Jagatsinghpur district was held on scheduled date & time with reference to:

I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and Amendments thereafter.

The Panel consisted of the following members:

Smt. Chinmayee Biswal, Addl. District Magistrate, Jagatsinghpur, supervised & presided over the public hearing process which was assisted by Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting, the Regional Officer, State Pollution Control Board, Paradeep, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of the project proposed by the Tahasildar Jagatsinghpur.

Shri Behera explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public, gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Shri Mrutunjaya Das (Consultant) addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management and various other CSR activities envisaged in the proposed project.

Then Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep requested the public to give their views, comments, objections and opinions on the proposed project.

The views expressed by various speakers on the proposed project are as follows:

1. Shri Rabindranath Acharya, Mahira:

He opposed the project and questioned about public intimation regarding schedule of the public hearing of the project.

2. Shri Bijayananda Mishra, Sainto:

While opposing the proposed project, he questioned about public intimation regarding schedule of the public hearing of the project and mentioned about the problem of narrow village road, plying of tractors whole night causing road dust and noise. He also alleged that children playing on village road will get affected due to the transportation activities of sand mining. He requested ADM to get plantation done in 66 acres of Gochar land adjacent to Sainto village.

3. Shri Bichtrananda Mishra, Ex. Sarpanch, Sainto:

He placed his mixed views about the project. He highlighted the problem of narrow road, damage of boundary of village houses due to transportation vehicles. He demanded that a fund may be created by collecting money from the transporter of the sand mining activity and the same be used for developmental activity of the village. He also demanded repairing of village road shall be done by the operating agency of the sand mine.

4. Shri Ashol Kumar Behera, Sainto:

Opposing the project he mentioned that children roaming and playing on the narrow village road will get affected due to transportation vehicles.

5. Smt. Pratima Mohanty, Chadheigaon:

She wanted to identify the lease holder to fix accountability for repercussion of the project. She demanded for repair of road and funding to private school near village and welfare activities of village.

6. Shri Batakrushna Routray, Kortal:

He demanded that accountability of the mine operator/lessee shall be fixed with respect to developmental or repair activity of the village in consultation with local Sarpanch.

7. Shri Mihir Bhoi, Sainto:

He did not tell anything relevant to the project.

8. Shri Jay Narayan Mohanty, Chadheigaon:

He placed his mixed views about the project and questioned about the purpose of public hearing with respect to loss and profit to villagers, school and village road. He wanted to be assured regarding repair of village road and developmental activity of the village before supporting the project.

9. Shri Bijaya Mania, Sainto:

He opposed the project and stated that mining and transportation activity will cause air pollution and road accident. He questioned about the compensation by mine operator on the case of casualty due to sand mining and transportation activity.

10. Shri Dhuleswara Sethy, Sainto:

He offered his gratitude to the officials of District administration and SPCB for conducting such meeting at the village.

11. Shri Dhuleswara Sethy, Sainto:

He offered his gratitude to the officials of District administration and SPCB for conducting such meeting at the village.

The Panel received **04 nos.** of written representations of the local people demanding different facilities in the locality during the hearing which are enclosed herewith in original.

Observation:

The overall opinion of the public about the proposed project was mixed type. However, the local people have some aspirations as laid down in their deliberations.

Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns expressed by the speakers with the inclusion of comments of the applicants, read over to the audience at the end of the proceedings explaining the contents in Odia language and the agreed minutes of public hearing meeting is prepared. The statement of issues and concerns of public with the comments of applicants, prepared in Odia and English language is annexed as per Annexure- I & II. List of participants is annexed as per Annexure- III.

The President of Public Hearing, Smt. Chinmayee Biswal, Addl. District Magistrate, Jagatsinghpur ratified the minutes of meetings with the views and demands of public. She extended her vote of thanks to the public for rendering their co-operation for smooth operation of the public hearing.

The meeting ended with a vote of thanks to the chair and the participants.


