

**PROCEEDINGS OF THE PUBLIC HEARING HELD ON 22.06.2022 (AT 10.30 AM) AT GROUND NEAR MARKET COMPLEX OF ALIPINGAL VILLAGE WITH RESPECT TO ENVIRONMENTAL ASSESSMENT FOR ALIPINGAL-ADHANGA DEVI NADI SAND QUARRY OVER AN AREA OF 8.93 HA. UNDER JAGATSINGHPUR TAHASIL OF JAGATSINGHPUR DISTRICT FOR ENVIRONMENTAL CLEARANCE.**

The public hearing in respect of the project proposed by the Tahasildar Jagatsinghpur for Alipingal-Adhanga Devi Nadi Sand Quarry over an area of 8.93 Ha. under Jagatsinghpur Tahasil of Jagatsinghpur district was held on scheduled date & time with reference to:

I. EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and Amendments thereafter.

Smt. Chinmayee Biswal, Addl. District Magistrate, Jagatsinghpur, supervised & presided over the public hearing process which was assisted by Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting, the Regional Officer, State Pollution Control Board, Paradeep, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of the project proposed by the Tahasildar Jagatsinghpur.

Shri Behera explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He asked the project proponent to make a brief presentation before the public, gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public. On behalf of the Project Proponent, Shri Mrutunjaya Das (Consultant) addressed the committee members and assembled public, and made a brief presentation about the salient features of the proposed project, environmental management, pollution control measures, waste management and various other CSR activities envisaged in the proposed project.

Then Shri Puskar Chandra Behera, Regional Officer, State Pollution Control Board, Paradeep requested the public to give their views, comments, objections and opinions on the proposed project.

**The views expressed by various speakers on the proposed project are as follows:**

**1. Shri Manoranjan Pal, Alipingal:**

He supported the public hearing of Alipingal-Adhanga Devi Nadi sand quarry proposed by Tahasidar Jagatsingpur.

**2. Shri Suchitra Kumar Jena, Alipingal:**

He spoke in favour of the project and operation of sand quarry.

**3. Shri Pramod Jena, Alipingal:**

While supporting the proposed sand quarry project, he expressed that they are poor people and earn for their livelihood due to operation of sand quarry.

**4. Shri Keshab Pradhan, Odapada, Alipingal GP:**

He spoke in favour of the sand quarry project.

**5. Shri Sangram Jena, Alipingal:**

He supported the proposed Alipingal Sand quarry project.

**6. Mrs Jhunilata Mallick, Alipingal:**

While supporting the public hearing, she told that people will be benefitted due to operation of sand mine.

**7. Shri Saroj Nayak, Alipingal :**

Supporting the project, he stated that accountability shall be fixed regarding suppression of sand dust due to transportation and sprinkling shall be done on transportation road to minimize air pollution.

**8. Subhalaxmi Mallick, Alipingal:**

She told we faced major problem while non-operation of sand mines. My father also engaged in the sand mines. We all villagers will be benefitted while operation of this mine. She supported points raised by the previous speaker Sri Nayak regarding minimization of air pollution.

**9. Shri Surya Narayan Palaur, Alipingal Sarpanch:**

He supported the project and said that it is the livelihood of villagers. He doesn't have any issue regarding operation of the sand mine. He demanded for

minimization of air pollution due to transportation activities and requested highest bidder to take care of water sprinkling activities for dust suppression.

**10. Shri Prasanna Kumar Bhoi, Patasara:**

He supported the project and stated that we villagers have not any issues in operation of this sand mine as it is the livelihood of villagers and they get sand at cheaper price.

The Panel received **02 nos.** of written representations of the local people demanding different facilities in the locality during the hearing which are enclosed herewith in original.

**Observation:**

The overall opinion of the public about the proposed project was mixed type. However, the local people have some aspirations as laid down in their deliberations.




