

PROCEEDINGS OF THE PUBLIC HEARING MEETING HELD ON 24.06.2022 (AT 11.00 AM) AT SAHANIDIHA GRAM PANCHAYAT OFFICE PREMISES UNDER DHARMASALA TEHSIL OF JAJPUR DISTRICT FOR ENVIRONMENTAL CLEARANCE IN RESPECT OF M/S NILACHAL CARBO METALICKS PRIVATE LIMITED, FOR EXPANSION IN PRODUCTION OF LOW ASH METALLURGICAL COKE OF 60,000 TPA TO 1,08,000 TPA BY INSTALLATION OF 2 NOS. OF COKE OVEN BATTERY (2X24,000 TPA) WITHIN EXISTING PREMISES AT BARAMANA, PURUNABOULAMALA, PS: JENAPUR IN JAJPUR DISTRICT.

The public hearing in respect of the Nilachal Carbo Metalicks Private Limited for proposed enhancement in production capacity from 60,000 TPA to 1,08,000 TPA by installation of 2 nos. of Coke oven battery (2X24000 TPA) within the existing plant premises, at Village Baramana, Purunaboulamala, Tehsil Dharmasala in Jajpur District was held on scheduled date & time at Sahanidiha gram panchayat office premises, Dharmasala in the District of Jajpur with reference to EIA Notification S.O 1533 (E) Dtd. 14.09.2006 and amendments thereof.


The Panel consisted of the following members:

Sri Santosh Kumar Mishra, Additional District Magistrate, Kalinganagar, Jajpur, supervised & presided over the public hearing process and assisted by Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, the representative of State Pollution Control Board, Odisha, Bhubaneswar.

At the outset, welcoming the members participated in the meeting Sri Pramod Kumar Behera, Regional Officer, State Pollution Control Board, Kalinganagar, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, in respect of Nilachal Carbo Metalicks Private Limited, at Baramana, Purunaboulamala, Tehsil Dharmasala in Jajpur District.

Welcoming the public, Sri Mishra, Additional District Magistrate, Kalinganagar, Jajpur welcomed the public and explained that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. He reminded public that the Public Hearing meeting is being conducted following the Social distancing and COVID-19 guideline. He requested the public to follow the Social distancing and COVID guidelines during the public hearing process. He asked the project proponent to make a brief presentation before the



public gathered in the meeting about the various aspects of the proposed project to be undertaken for better awareness of the public.

On behalf of the project proponent, Sri Jugal Kishore Mishra, Executive Director of Nilachal Carbo Metalicks Private Limited briefed the expansion proposal and Environmental impact of the expansion project. He addressed the dais and assembled public and made a brief presentation about the salient features of the proposed expansion project, environmental management, pollution control measures, afforestation programme and various other peripheral development activities envisaged in the proposed expansion project.

Then Sri Mishra, ADM, Kalinganagar, Jajpur requested the public to give their views, comments, objections and opinions on the proposed project.

7. **Sri Anam Charan Mallick**


Sri Mallick welcomed the dais & gathering and requested the Company for employment of local public of Sahanidiha GP as per their qualification and Company requirement.
