**PROCEEDINGS OF THE PUBLIC HEARING MEETING HELD IN RESPECT OF
ENVIRONMENT IMPACT ASSESSMENT OF JARIPUT AND JAYMANGALPUR
CLUSTER BLACK STONE QUARRY OVER AN AREA OF 8.484 HECTARE IN VILLAGE
JARIPUT & JAYMANGALPUR UNDER TANGI TAHASIL IN THE DISTRICT OF
KHORDHA, ODISHA**

The Public Hearing meeting in respect of environmental impact assessment of Jariput and Jaymangalpur cluster black stone quarry over an area of 8.484 hectare in village Jariput & Jaymangalpur under Tangi tahasil in the district of Khordha, Odisha was held on Dt. 17.12.2021 at 10.30 AM at Village Community Centre, Jariput in Khurda District, Odisha with reference to:

1. EIA Notification S. O. 1533(E) dated 14.09.2006.
2. Interim Operational Guidelines.
3. Covid-19 Guidelines issued by MoEF&CC, Govt. of India vide OM No.22-25-IA.III, Dated.09/06/2021

The Panel consists of the following members:

At the outset, Dr. Sohan Giri, Regional Officer, State Pollution Control Board, Bhubaneswar Regional Office on behalf of State Pollution Control Board, Odisha welcomed all the guests, dignitaries, public and other members present in the meeting. The meeting was presided over by the Additional District Magistrate, Bhubaneswar, on behalf the local District Administration.

Dr. Sohan Giri, being the Representative of State Pollution Control Board, Odisha, gave a brief introduction about the guidelines to be followed for the public hearing in the light of EIA Notification, 2006 and interim operational guidelines till date, along with Covid-19 Guidelines issued by MoEF&CC, Govt. of India vide OM No.22-25-IA.III Dated.09/06/2021 and the modalities to be followed for the conduct of public hearing meeting in respect of project proposed by Tahasildar, Tangi.

Welcoming the public, the Regional Officer, State Pollution Control Board, Odisha, Bhubaneswar, necessitates the importance of public hearing programmes and explained

that the views, comments, objections and opinions of the public are necessary while considering the environmental clearance of the project. The Learned Officer requested Sri Anuj Kumar Das Pattanaik, Additional District Magistrate, Bhubaneswar to preside the Public Hearing meeting and formally to start the proceedings.

Sri Anuj Kumar Das Pattanaik, Additional District Magistrate, Bhubaneswar presided over meeting and highlights about the purpose, requirement and procedure of the meeting and conveyed the same to the gatherings.

Then, Dr. Sohan Giri asked the project proponent to intimate the details of the proposed project before the public. The Tahasildar, Tangi being the project proponent addressed the public and requested Sri Saidatta Das, Consultant to make a brief environmental presentation before the public gathered in the meeting. Sri Das explained about the various aspects of the proposed project i.e. benefits, implementation in lieu of the possible environmental aspects, etc. and the basic purpose of the project. He welcomes the perceptiveness of the public as their suggestion, opinion and objection has to be considered for the smooth implementation of the project.

After the presentation completed, Dr. Sohan Giri requested the public to give their views, comments, objections and opinions independently the proposed project.

The following speakers gave their views on the above said project, which is given as follows :

1. Sri Kedar Mohapatra :

Welcoming the public Sri Mohapatra highlighted about the bad road condition of Jariput, Protection of Tangia hill and the Goddess Temple on that hill, repairing of NH to Jariput Road, protection of local Kaju Jungle, ration card to all the public group people of the area. He informed that there is no Ambulance provision for delivery patient for which few years back a woman had died due want of proper Doctor's treatment. Also he emphasized that due to the Pahad blasting cracks are being created in the nearby houses.

2. Mr. Dinabandhu Mohapatra, Jariput :

Welcoming the public, Sri Mohapatra emphasized that there should be complete stoppage of Black Stone Quarry and its excavation because the local inhabitants are not enjoying any sorts of benefit and due to blasting activity cracks will be there to the nearby houses in their area.



3. **Smt. Godabari Pradhan, Jayamangalpur :**

Smt. Pradhan had highlighted that due to loud noise during blasting, the plaster of roof will collapsed and cracks will also occur to the wall of houses.

4. **Mrs. Urmilla Mohapatra:**

She had opined to stop the excavation activity by the Government.

5. **Mrs. Dharitri Paikray:**

Mrs. Paikray had put-forth that ration card has not been issued to her as a land less person. Also due to excavation activity the school going children will face a lot of problems.

6. **Sri Ashis Kumar Jena, Kaithapalla :**

Sri Jena highlighted in favour of Pahad excavation because it will develop the economy of the poor class people of nearby areas.

7. **Mrs. Nirupama Dei, Jariput:**

Mrs. Dei informed that she is a widow and has no ration card and requested to issue ration card in her name.

8. **Mrs. Shanti Paikray, Jariput :**

Mrs. Paikray had expressed against the excavation of Black Stone Quarry Pahad and informed that she has not received ration card facility.

9. **Sri Narayan Harichandan, Jariput :**

Sri Harichandan asked the District Administration for issue of ration card to the people.

10. **Mrs. Reeta Das, Jariput :**

Mrs. Das requested the District Administration for issue of ration card to the people.

11. **Sri Balaram Muduli, Jariput :**

Sri Muduli expressed that there is no better road facility to the village and till date he could not be able to get ration card facility.

12. **Mrs. Pramila Muduli, Jariput :**

Mrs. Muduli expressed to stop the excavation work of the Pahad.



13. Sri Subash Chandra Sahoo, Kaithapalla :

Sri Sahoo proposed in favour of the excavation of sariat sources so that poor people will be benefited, village condition will develop and asked that the noise level should be controlled during blasting and the village road cannot be made due to forest land area.

14. Mrs. Kumari Paikrai, Jariput :

Mrs. Paikrai expressed her opinion to stop the excavation issue of the Black Stone Quarry hill.

15. Sri Ramesh Mohapatra, Jariput :

Sri Mohapatra expressed his opinion against the excavation of Black Stone Quarry hill in their area because heavy noise will occur during blasting, road condition will be damaged and the local people will be suffered a lot.

16. Sri Rabi Narayan Champatirai, Kaithapalla :

Sri Champatrai told that Mining should not be stopped and excavation of stone should be carried out as per Rule and guideline. Road condition should be developed within the area.

17. Mrs. Hira Dei, Jariput :

Smt. Dei has expressed her opinion to stop the excavation of Sariat source and road should be developed in their area.

18. Mrs. Bilasini Mohapatra, Jariput :

Mrs. Mohapatra informed regarding the blasting of Pahad and the road should be developed from village to school as the children are facing a lot of troubles during going and coming from school.

19. Sri Sarbeswar Routray, Jaymagalpur :

Sri Routray told that Mining should not be stopped and excavation of stone should be carried out as per Rule and guideline. Road condition should be developed within the area.



20. Sri Narayan Sen, Kaithapalla :

Sri Jena viewed in favour of Black Stone Quarry mining. A Gramya Committee may be constituted so that they will look after the overall development of the surrounding and the environment related activity during the process of mining. He informed that the road condition to be improved, illegal blasting during night time to be stopped, Noise Rules to be followed, Gramya Kaju, jungle should be protected or else the mining should be stopped.

21. Sri Raghunath Paikrai, Biribadi :

Sri Paikray highlighted about the illegal mining and requested the same should be stopped as the government is losing revenue. The entire area is being polluted w.r.t. water and Air due to mining activity.

22. Sri Gopinath Paikrai, Biribadi :

Sri Paikray highlighted about illegal Mining to be stopped, Government is losing Revenue Entire area is being polluted w.r.t. water and Air due to Mining activity.

23. Sri Aintai Mohapatra, Jariput:


He informed that the mining activities may be carried out with all guideline of the government and the revenue should not be lost. The development of the local people should be looked into and the local area condition should not be badly affected.

24. Sk. Saha Jahan, Dikhipada Village of Kunjuripada Panchayat :

He gave the proposal in favour of mining with controlled blasting and low noise level and the mining to be continued. He informed that the local Public should get employment, blasting activity to be carried out within guideline and Rules.

25. Sri Sarat Kumar Mohapatra, Jariput :

Sri Mohapatra raised various issues like road development in the village and periphery areas, dust on nearby agricultural land due to blasting, the wall the houses getting crack due to blasting, bad condition of road the ambulance of AIIMS, Bhubaneswar is unable to enter into their village area. He informed that the rampant illegal mining should be checked.



26. Sri Dhamanda Sena, Sarpanch of Biribadi Panchayat:

Sri Sena highlighted in favour of the Black Stone Quarry mining activity and informed that transportation should be given to the local people and the village road should be developed.

Five (05) numbers of representations were received from the people with respect to objection against the operation of the quarry. After all the speakers completed their respective opinion and suggestion, the Regional Officer, SPCB, Odisha, Bhubaneswar asked the representative of the environment consultant on behalf of the Project Proponent to give relevant reply, with regards to the opinion and view of the speakers.


Sri Saidatta Das, Environment Consultant addressed the panel members, Guests, and Honorary members as well as all the persons present in the meeting and deliberated a brief presentation about the salient features of the proposed project, environmental management, pollution control measures to be adopted during operation of the quarry, waste management, afforestation programme, local employment and various other CSR activities envisaged in the proposed project situated in cluster.

The Regional Officer, SPCB, requested the Presiding authority to put final comments and remarks before concluding the programme. Sri Anuj Kumar Das Pattanaik, Additional District Magistrate, Khordha finally passed his concluding remarks and put forwards vote of thanks to everybody for smooth continuance of the programme.

The Public Hearing programme was concluded accordingly and the whole proceedings have been video recorded completely without pause. At last the Public Hearing was ended with vote of thanks to the Chair.




