PROCEEDINGS OF THE PUBLIC HEARING IN RESPECT OF ENVIRONMENTAL IMPACT ASSESSMENT FOR SUNATHAR STONE QUARRY CLUSTER (A, B, C) OF SRI GOPAL CHANDRA SAHU & SRI KAPILA CHANDRA SAHU OVER THE MINING LEASE AREA OF 11.331 HA FOR PRODUCTION OF CONSTRUCTION STONE 4,554 CUM/ANNUM AT SUNATHAR VILLAGE, PURUSHOTTAMPUR TAHASIL, HELD ON 20.07.2022 AT 11.00 AM AT QUARRY SITE OF VILLAGE SUNATHAR (OVER PLOT NO. 6344 & 6326 IN KHATA NO. 2091/781) UNDER PURUSHOTTAMPUR TAHASIL OF GANJAM DISTRICT

At the outset, Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur welcomed all the persons assembled in the hearing. He briefed about the EIA Notification, 2006 and the objectives of the public hearing. He stated that Sri Gopal Chandra Sahu & Sri Kapila Chandra Sahu have proposed to have Environmental Impact Assessment for Sunathar Stone Quarry Cluster (A, B, C) having mining lease area of 11.331 ha. for production of Construction Stone 4,554 cum/Annum at Sunathar village, Purushottampur Tahasil of District Ganjam and has applied to obtain Environmental Clearance and carried out Environmental Impact Assessment (EIA) Study.

Publicity regarding public hearing was made in the following manner

- Advertisements through an Odia Daily "The Sambad" dated 19.06.2022 and an English Daily "The Time of India" dated 19.06.2022 regarding the venue, date and time of the public hearing along with the places of availability of Executive Summaries (Odia & English) of Environmental Impact Assessment (EIA) report in the office of the Collector & Dist. Magistrate, Ganjam, District Industries Centre (DIC), Ganjam, Chief Executive Officer, Zilla Parishad, Ganjam, Head Office of the State Pollution Control Board, Bhubaneswar, Regional Office of the State Pollution Control Board, Berhampur & Department of Forest & Environment (Environment) Govt of Odisha and also in the website of State Pollution Control Board, Bhubaneswar (www.ospcboard.org).
- Executive summaries along with paper clippings regarding date, time, and venue of public hearing were made available to the Sunathar Gram Panchayat, Bhatakumarada Gram Panchayat, Sundarpur Gram Panchayat and the Block Development Office, Purushottampur, in the Dist. of Ganjam.

The Regional Officer, State Pollution Control Board, Berhampur requested the audience to give their opinions orally, written or in both, based on the Environmental aspects. Then he requested the Addl. District Magistrate, Ganjam, Sri Priyaranjan Prusty, O.A.S. to kindly preside and supervise in the public hearing.

The Addl. District Magistrate, Ganjam, welcomed the people for attending the hearing with a message to the audience that they should give their comments based on the Environment related aspects. He briefed about the project and elaborated the objective of conducting public hearing in respect of any project seeking Environmental Clearance. Then he asked the Project Proponents of M/s. Sunathar Stone Quarry Cluster (A, B, C) to brief about the project.

Sri Ramakrushna Sahu, representative on behalf of project proponents of M/s. Sunathar Stone Quarry Cluster (A. B. C) presented the salient features of the proposed project, the present status of the environmental conditions, possible impact on the environment due to such activities and the remedial measures to be undertaken by the project proponent to reduce the impact while executing the project in Odia language.

The Addl. District Magistrate, Ganjam, invited the public to offer their views, objections, opinions, comments and suggestions regarding the proposed project, specifically relating to environmental issues. About 60 persons were present in the public hearing meeting, only 49 nos. of persons signed in the attendance sheet. 05 persons participated in oral deliberation and expressed their views. No written representations were received in the hearing. The attendance sheets and the Deliberator sheets are enclosed as **Annexure-I** and **Annexure-II** respectively.

The statements recorded are as follows:

1. Sri Krushna Chandra Sahu, At/PO- Gurunthi, Berhampur

He stated that this quarry is non-operational since last 3 years and its operation will generate local employment which will stop problem of migration of labours, raw material will be easily available for local development works and local people will be benefitted.

2. Sri Gagan Kumar Behera, Sarapanch, Sundarpur G.P.

He stated that earlier nearby villagers were dependent on this quarry for their livelihood generation. However, as this quarry was non-operational since long, public were facing difficulties. He thanked the Government for taking steps to operationalize this source, which will create local employment and livelihood generation.

3. Sri Gouri Sankar Mohanty, At- Bhatakumarada, Purushottampur

He stated that local public were facing difficulties and forced to move outside as migration labour as this quarry was non- operational since last 3 years. Further added that operation of this quarry will create employment opportunities, construction materials will be easily available in the local market and there will be facilities for processing of stones for value addition. He requested to provide ID card, ID proof and insurance for workers to be engaged during operation.

4. Sri Anil Kumar Nahak, Sarapanch, Sunathar G.P.

He stated that there will be blasting during quarry operation which will lead to dust pollution in the locality and strongly demanded for plantation for protection of environment. Further he added that the lessee shall supply construction stones to local public at cheaper rate and engage them during operation.

5. Sri Rushi Mandal, At/PO, Sundarpur

He stated those local public were facing difficulties for livelihood generation as most of the stone quarries in the locality were non-operational. He thanked the Government for taking steps to operationalize this source. He further requested the Administration to regulate the price hike of minor minerals as common public are facing difficulties for construction of houses. Operation of this quarry will create employment opportunities and there will not be any problem of pollution.

District Magistrate, Ganjam and Regional Officer, State Pollution Control Board, Berhampur also discussed on issues raised by the public and requested to the Project Proponents of Sunathar Stone Quarry Cluster (A,B,C) to address the issues raised by the local public. Sri Ramakrushana Sahu, representative of project proponents addressed the apprehensions raised by the public.

Er. Deepak Kumar Sahoo, Regional Officer, State Pollution Control Board, Berhampur & representative of State Pollution Control Board, Odisha prepared the summary of the public hearing proceedings accurately reflecting the views and concerns, expressed by the oral deliberators. The minutes of the public hearing were prepared which has been ratified by Sri Priyaranjan Prusty, O.A.S. Addl. District Magistrate. Ganjam with the views and concerns of the deliberators. The video recording of the entire public hearing is enclosed herewith for ready reference.

The statement of issues and concerns of public with the comments of the project proponents, prepared in Odia and English Language are annexed as **Annexure-III** and **Annexure-IV** separately.

The public hearing was ended with vote of thanks by the chair.
